March 25, 2016	A. Brendan emails Denise confirming that the lease will Expire in October 1, 2016, not June 1, 2016 as stated in the Original Lease, Ivy Tsai, City Attorney, confirms this.
September 2015-June 16, 2016	Repeated attempts to have me removed as Trustee by Lawrence Blackstone, Diana Blackstone & Joshua Blackstone, Brendan O'Reilly is being informed of all (All failed)
May 11, 2016	Airport Office meeting with Brendanbegged him to renew our lease and explain what was happening at ACUSA with the ownership.
