- Note: (i) Candidates shall apply online only by One Time Registration to [www.keralapsc.gov.in](http://www.keralapsc.gov.in). Applications submitted in any other manner will be summarily rejected.
- (ii) In the absence of suitable candidates, the vacancies set apart for By Transfer recruitment shall be filled up by the candidates from the Ranked List prepared for Direct recruitment.
- (iii) The applicant should be an approved probationer/Full member of the Kerala General Education subordinate service as on the date of application.
- (iv) A Ranked List will be prepared for Idukki district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies reported during the currency of the list.
- (v) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (vi) Candidates should submit the application for this post to Idukki district and should note the name of the district against the relevant column of the online application.
- (vii) The rules regarding the reservation of appointment contemplated in Rule 14 to 17 in Part II of the KS & SSR are not applicable to recruitment by transfer.

**5. Method of appointment** : Recruitment by transfer from among the employees who have completed the prescribed service and who are working as Clerk/Typist/Attender/Office Attendant/Binder in the General Education Department.

**6. Age Limit** : Not applicable.

## 7. Qualifications:-

- 1) A Degree in the concerned subject and B.Ed/BT in the concerned subject both conferred or recognized by the Universities in Kerala. (Concerned subject are specified in Note (iii) below.
- 2) Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala.

**Note :** The Degree/Diploma awarded by UGC approved Universities or Institutions established through an act passed by Parliament/State Legislative Assembly in accordance with the conditions laid down in G.O(MS) No.526/PD dated 17.07.1965 are acceptable for appointment in Government Services.

### Exemption:

1. Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D in the respective subjects / M.Ed. in any subject are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.16, G.O. (P)No.206/16/G.Edn. Dated 08.12.2016 and G.O (P)No.15/2020/G.Edn dated 9.10.20).
2. As per the conditions laid down in Government Circular No. 1866829/J3/2017/G. Edn. Dated 09.03.2018 those who passes CTET primary stage and CTET Elementary stage were excluded from KTET Cat. I & KTET Cat. II respectively. Also CTET qualification can't be considered as an alternative qualification for KTET Cat. III and Cat. IV.

- 3) (i) Must have passed SSLC/Plus Two/Pre-Degree with Tamil as I or II Language.

OR

- (ii) A pass in Degree or post Graduation in Tamil Language .

In the absence of the qualifications referred in (i) & (ii) above its equivalent shall also be considered. (G.O(P)No.166/16/G.Edn.Dated 30.09.2016).

- (i) M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.
  - (ii) The Employees of the General Education Department who entered service before 31.03.2012 and have completed the prescribed period of service as Clerk/Typist/Attender/Office Attendant/Binder are exempted from acquiring K-TET qualification.
  - (iii) The applicant should have taken History or Economics or Geography or Politics or Philosophy or Sociology as main subject for Graduation. The candidates who possess B.Ed Degree in Social Science after obtaining a degree in Commerce or Music before 21.09.2022 are also eligible to apply for the post (G.O(MS)No. 234/2022/G Edn dated 19.12.2022)
  - (iv) Diploma in Rural Service awarded by the National Council for Rural Higher Education will also be treated as equivalent to Degree for the above purpose.
  - (v) The candidates who have acquired BA.Ed Integrated Course (Social Studies, English) conducted by the Regional Institute Of Education in Mysore are also eligible to apply for the post.(GO(Rt)No :2135/2019/GEdn dtd 4/6/2019)
  - (vi) Post Graduates in concerned subject with B.Ed/BT in the concerned subject are also eligible to apply for the post.
  - (vii) The following qualifications are also acceptable for appointment to the post of High School Assistant (Social Science)
    - a) BA Degree in Islamic History and Urdu Double main and B.Ed in Social Studies.  
OR
    - b) BA Degree in Islamic History (Main) General Economics and Indian History (Subsidiaries) and B.Ed in History.  
OR
    - c) BA Degree in Islamic History and Arabic main and B.Ed in History  
(a, b & c above as per GO(MS)No.254/90/G.Edn dated 05.12.1990)  
OR

- d) BA Degree in Islamic History (Main) General Economics and Political Science (Subsidiaries) and B.Ed in History (GO(MS)No.21/94/G.Edn dated 21.02.1994)  
OR
- e) BA (Islamic History and Arabic Main) and B.Ed (Social Studies)  
OR
- f) BA Islamic History (Main), Indian History and Political Science (Subsidiaries) and B.Ed (History) or B.Ed (Social Studies)  
OR
- g) BA Islamic History(Main), Political Science and General Economics (Subsidiaries) and B.Ed (Social Studies)  
OR
- h) BA Islamic History (Main), outlines of Indian Culture and Freedom Movement and Political Science (Subsidiaries) and B.Ed (Social Studies).

viii) Candidates applying to the post should have sufficient knowledge in Tamil which will be tested at the time of interview. If there is a written(Descriptive/OMR) Test Question papers for the written test if any will be in Tamil. The candidates should answer the question in Tamil. In case of OMR answer script, answers are to be marked as instructed

ix) The disciplines in which graduation and post graduation were obtained and the subject of B.Ed/BT should be mentioned in the application.

**NB:** Rule 10(a) ii of Part II of KS&SSR is applicable for this post.

In addition to the qualifications prescribed in this notification, qualifications declared by the Government as equivalent qualifications through Executive/Standing Orders and higher qualifications with prescribed qualification as basic qualification will be accepted. Government Orders regarding equivalent/higher qualification shall be produced as and when called for by the Commission.

4) Candidates should have service not less than 5 years as clerk/ Typist/ Attender/ Office Attendant/ Binder in the General Education Department as on the date of application.

## 8 Mode of Sending applications :-

Candidates must register as per “ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2013. **Candidates who are creating profile newly, should upload the photograph taken within 6 months.** Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The Application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, community, age etc. have to be produced as and when called for. **Candidates who have AADHAAR card should add AADHAAR card as I.D Proof in their profile.**
