Applications are invited online only from qualified male candidates belonging to the following communities of Kerala State for Selection to the under mentioned post in Kerala Government Service. Applications must be submitted online only through the official website of the Kerala Public Service Commission (www.keralapsc.gov.in) after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. **Department** : **Excise**
2. **Name of Post** : **Civil Excise Officer (Trainee)**

Note: Differently abled candidates & Female candidates are not eligible to apply for the post

Note :

- (i) The above vacancies are now in existence. The Ranked List published as per this notification shall remain in force, until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Mother Ranked Lists published as per Cat.No.538/2019, in Thrissur District (R/L NO.463/2023/DOR dated 22/06/2023) and Idukki District (R/L No. 531/2023/DOJ dated 06/07/2023) respectively.
- (ii) Applications submitted by candidates belonging to the communities other than that notified will be summarily rejected. No rejection memo will be issued.
- (iii) The name, educational qualification and age for this post is notified as per G.O. (P)No.264/10/TD dated 10/11/2010 (SRO No.1025/10), G.O(P)No.178/2015/TD dated 03/10/2015 (SRO No.669/15) and G.O(Rt) No.766/2018/TD dated 21/10/2018.
- (iv) The selection in pursuance of the notification will be made on a Revenue District basis subject to the special conditions laid down in G.O(Ms)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another District unless he completes five years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after five years, it will be subject to the rules in G.O (Ms)No.4/61/PD, dated 02.01.1961. Candidates already in Government service holding this post in anyone Districts are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (v) Preference shall be given to Ex-serviceman.
- (vi) NCC certificate holders having 'A' 'B' & 'C' categories will be given weightage marks at the rate of 2% , 3% and 5% respectively.
- (vii) Civil Excise Officer (Trainee) shall not be appointed in the substantive posts till the successful completion of basic training for a period of not less than six months, subject to the minimum of 180 working days as may be decided by the Commissioner of Excise. Persons undergoing basic training shall be paid stipend as may be fixed by the Government from time to time. All the persons who did not undergo basic training will be placed under orders of training within a period of two years and those who did not successfully complete

the basic training shall not be considered for future promotion.

6. **Age Limit:** (a) Dheevara community : 19-34 , Candidates born between 02.01.1989 and 01.01.2004 (both dates included) and
(b) Scheduled caste/ Scheduled Tribe Communities : 19-36

For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years , please see para (2) of the General Conditions except para2(i) under Part II of this Notification.

7. **Qualifications :**

1. **Educational Qualification** : Must have passed Plus Two Examination or its equivalent.

Note:

i) Rule 10 (a) ii of Part II of KS & SSR is applicable.

ii) In addition to the qualification prescribed in the notification the qualifications recognized by Executive orders or standing orders of Government as equivalent to a qualification specified for a post and such of those qualifications which pre suppose the acquisition of the lower qualifications prescribed for the post shall also be sufficient for the post. The Government orders declaring equivalent/ higher qualification shall be produced as and when called for by the commission.

2. **Physical Qualification** : (a) Must not be less than 165 cms in height and 81 cms round the chest with a minimum expansion of 5 cms for candidates belonging to Dheevara community and
(b) Must not be less than 160 cms in height and 76 cms round the chest with a minimum expansion of 5 cms will be sufficient for candidates belong to SC/ST communities.

3. **Physique & Eye sight**

- (i) Must be certified by a Medical Officer not below the rank of an Assistant Surgeon/Junior Consultant in Government service as to his physique fitness and capacity for active outdoor work. The Medical Certificate has to be produced as and when called for.
- (ii) Must be certified to possess the visual standards specified below without glasses.

(c) Each eye must have full field of vision, Colour blindness, squint or any other morbid condition of the eyes or lids of either eye will be deemed to be a disqualification.

- (iii) Must be free from apparent physical defects like knock knee, flat foot, varicose vein , bow legs, deformed hands and limbs, irregular and protruding teeth , defective speech and hearing.
- (iv) Medical Certificate from a Medical Officer in government service not below the rank of an Assistant Surgeon/Junior Consultant should be produced at the time of Physical Efficiency Test/Endurance Test and should be uploaded in their profile at the time of Certificate Verification. A format of Medical Certificate is given below.

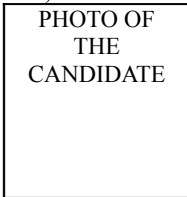

Note: Details regarding standards of vision should be clearly stated in the Certificate, as given above. Vague statements such as vision normal, Good, Average etc. will not be accepted. Specification for each eye should be stated separately against each item. If the specifications are not as indicated above, the officer issuing the certificate should notify whether the candidate has got better standards of vision or worse standards of vision, as the case may be, otherwise the Certificate will not be accepted.

- 4. Must qualify in the Endurance Test of completing 2.5 kilometers race within 13 minutes.

Note: The Physical measurement of candidates will be taken at the time of physical efficiency test or endurance test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test or endurance test. **If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test or Endurance Test, he will not be given further chance to participate in the test.**

8. **Mode of submitting Applications:**

(a) Candidates shall register as per ONE TIME REGISTRATION system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.' for applying for the post. Candidates who have registered shall apply by logging on to their profile using their User-ID and Password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification Link for applying for a post. The Photograph uploaded in the profile of the candidate who have already registered should be taken after 31.12.2013. Candidates who are creating new profile from 01.01.2023 onwards must upload photograph which is taken within six months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** Applications submitted not in accordance with the conditions of the notification will be summarily rejected if non compliance with the notification is found in due course of processing. Original documents to prove qualification , experience , community, age etc., have to be produced as and when called for.

(b) If Written Test/OMR Test/Online Test is conducted as a part of this selection, candidates possessing requisite qualification as per Para 7 above alone shall submit a Confirmation for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.

(c) The Examination Schedule and the Syllabus will be notified separately.

(d) Candidates who have AADHAAR card should add AADHAAR card as ID Proof in their profile.

11. **Special Instruction to candidate :-**

(A) In the case of difference in caste/community claimed in the application and that entered in SSLC Book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.

(B) Candidates are required to acquaint themselves with the instruction given in the notification as Part-II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.

(C) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc., and are liable to be qualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or

the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
