“I believe that this problem is rooted in the domestic developments in the United States.

We are not enjoying the current developments, but we did not start it. It is stretching the truth to say that this is the punishment for Ukraine and Crimea. It all began back under President Barack Obama, long before Washington launched its “colour revolution” project in Ukraine. It began with Edward Snowden, who was stuck in Russia because he could not fly anywhere – his passport was cancelled. The US President, the Secretary of State and the FBI and CIA directors put pressure on us to surrender him without delay. We said we could not do so because all the accompanying information indicated that he was facing the death penalty. This is why Obama banned bilateral contacts and cancelled his visit ahead of the G20 summit in St Petersburg. By the way, we were preparing for that meeting an agreement on the further reduction of strategic offensive arms, which should have followed on the 2010 Prague Treaty, as well as a declaration that set out an agenda on strategic stability for many years to come. Obama’s inability to forgo personal resentment buried a very important document, which could have been put to very good use now.

Next, sanctions were imposed over the Magnitsky case. A closer look at the problem revealed that Bill Browder, who raised the ballyhoo, had problems with the law, and not only Russian law. The Prosecutor General’s Office of Russia brought charges against Browder in the United States. American courts had to accept numerous facts supporting our suspicions. However, the court’s operations were clearly interfered with by those who did not want to ease pressure on Russia, that is, by Browder himself and his supporters. In other words, Ukraine was just another pretext.

The US elite disliked the changes that took place in Russia after Vladimir Putin became our president, when we gradually got back on our feet and regained our independence. Most importantly, we started thinking independently and stopped listening to the advisers who were entrenched in our key ministries in the 1990s.

The election defeat of the Democratic Party provided the pretext for preventing the normalisation of relations with Russia. Three weeks before leaving the White House, Barack Obama seized Russia's diplomatic property. It happened in a country where this cannot be done for any reason, where private property is a sacred right and others' property must never be taken. It was a time bomb, and its clock is still ticking. The Democrats have done their best to use the Russian card so as to do maximum damage to the current administration. When a great nation spends three years speculating about foreign interference that allegedly predetermined the outcome of its presidential elections, we see this as disrespect for the great American people.

Speaking about the election turbulence, I would like to refer to the Democratic Party. Contrary to what the investigation led by Special Counsel Robert Mueller is trying to prove, there are solid facts showing that the Democratic Party violated the law when illegal methods were used to force Bernie Sanders to quit the race. Everyone has forgotten about this, talking about Russia all the time rather than about what is happening in the United States.

We are open for dialogue as long as the United States is. President Vladimir Putin has said this more than once at his meeting with US President Donald Trump in Hamburg in 2017, in Helsinki last year, as well as during their contacts at the G20 summit in Buenos Aires. We do not want to interfere, and we do not want to give any reason for accusing us of interference in the internal

fighting and conflicts in the United States. What we have is a constructive agenda. We have outlined a number of cooperation areas, including the establishment, upon our presidents' approval, of a business council comprising five, six or seven top officials each from the largest Russian and US corporations. I am sure that such a high-level council could become a major stabilisation factor, at least for our business communities.

We have also proposed establishing, if our presidents approve this, a council of leading Russian and US political scientists who can be charged with preparing a positive agenda. We have offered an extended programme for a dialogue on strategic stability, including on the INF Treaty and a future agreement on strategic offensive arms, as well as on cooperation in space and on ways to prevent its militarisation with unpredictable consequences. They have put all this on back burner. We have not received a clear response to these proposals. When the United States initiated the procedure to withdraw from the INF Treaty, President Putin said at a meeting with Defence Minister Sergey Shoigu and me that we had more than once told our American partners about all our initiatives, and that our partners surely know about them. If they opted for disregarding these initiatives, we will no longer knock on a locked door and will stop reminding our partners about our initiatives. Our American colleagues can tell us when they are ready. We will be willing to start the talks”.

## **TIMELINE OF MAIN EVENTS SURROUNDING U.S. ELECTIONS AND CLAIMS OF «RUSSIAN INTERFERENCE»**

1. **May 18, 2016** - Director of the U.S. National Intelligence James Clapper reported that the American Intel community had found evidence of foreign spy services attempting to hack networks of the Democratic National Committee (the DNC).
  
2. **June 14, 2016** – “The Washington Post” for first time claimed that Russian hackers had penetrated the DNC databases and gained access to internal information, but, as it would become a “tradition”, offering no proof and relying solely on “anonymous sources”.
  
3. **June 15, 2016** - “Crowdstrike”, a computer security firm hired by the DNC to investigate the hacking, declared that “Russia was behind the cyberattack into the DNC servers”. The company representative said that it had identified two sophisticated adversaries - hacking groups “Cozy Bear” and “Fancy Bear”, “linked to the Russian intelligence services”. There have been no facts proving anti-Russian allegations yet.
  
4. **July 22, 2016** - “Wikileaks” released nearly 20 000 DNC internal emails. Eventually, it would published more than 44 000 e-letters and 17 000 attachments, showing the DNC bias in favor of Hillary Clinton and against her contender Bernie Sanders during the 2016 presidential campaign. Despite the absence of evidence and numerous public rebuttals from Wikileaks the U.S.

mass media and politicians can't stop speculating that Russia was the source of the stolen DNC emails.

5. **July 25, 2016** - the FBI confirmed it had opened an investigation into the hacking of the DNC servers (it later became known that the target of the probe had been Russian government's efforts to interfere in the election and Trump campaign associates who had been allegedly involved in the conspiracy with the Kremlin).

6. **July 25, 2016** - Republican candidate Donald Trump said: "Russia, if you are listening, I hope you are able to find 30 000 emails (- from the DNC) that are missing". Despite sarcastic manner of this joke the phrase along with his other public promises "to get along with Russia" have been later used by the U.S. mainstream media as "a proof of his conspiracy with the Kremlin".

7. **July 29, 2016** - the Democratic Congressional Campaign Committee joined colleagues from the DNC and announced that its computer network had also been hacked.

8. **October 7, 2016** - the Department of Homeland Security and Office of the Director of National Intelligence issued a joint statement saying the U.S. Intelligence community "is confident" that hacks into the email systems of the Democratic Party "were directed by the Russian government". As usual: there was no evidence.



9. **October 31, 2016** - the magazine “Mother Jones” published article summarizing the so-called “Trump dossier” (a set of unverified allegations of conspiracy between Trump’s campaign and the Russian Government), authored by Christopher Steele, a British former MI-6 officer (his name wasn’t disclosed at the time). The dossier was released in full by the news agency “Buzzfeed” on January 10, 2017. It was later revealed that Senator John McCain, who had been given Steele’s memos by former U.S. State Department official David Kramer, delivered them to FBI Director James Comey. Besides, it was reported said that an associate of the Senator passed this “dossier” to the “Buzzfeed”. There remains possibility that the launch of U.S. Intel community probes into Russian interference were based mostly on Steele’s document.

10. **November 8, 2016** - Donald Trump is elected President of the United States. Shortly after Democrats and liberal media initiated an anti-Trump campaign with focus on peddling the “Russian interference” narrative spiked with the “Trump-Kremlin collusion” theme.

11. **December 9, 2016** - President Obama announced his executive order to review “Russian hacks” during the 2016 presidential campaign.

12. **December 29, 2016** - President Obama authorized “a number of actions in response to the Russian government’s aggressive harassment of U.S. officials and cyber operations aimed at the American elections in 2016” (anti-Russian measures included sanctions against Russian intelligence services, expulsion of 35 diplomats of the Russian Embassy in Washington and closure of two diplomatic compounds in Maryland and New York).

13. **January 6, 2017** - Office of the Director of National Intelligence released a declassified intelligence report with “assessments” that stated U.S. Intel services “are high confident” that “Russian President Vladimir Putin ordered an influence campaign in 2016 aimed at the U.S. election”. The report said that Russian intelligence services had gained access to the DNC computer network for nearly a year from July 2015 to June 2016 and had released hacked material to Wikileaks “to help President-elect Trump”. Although this report contained no evidence of “Russian meddling” and “Collusion between Russia and Trump campaign” American media has continued to speculate about the alleged “Trump-Kremlin conspiracy” as well as the false narrative of “Russian interference in the U.S. political processes”.

14. **January 20, 2017** - Donald Trump sworn in as the 45<sup>th</sup> President of the United States of America.

15. **January, 2017** - several Senate and House Committees announced congressional investigations of the “Russian activity during the 2016 campaign” with focus on “Russian meddling” and “Trump-Moscow collusion”.

16. **February 13, 2017** - Presidential National Security Advisor Michael Flynn resigned, following reports that he had misled the Vice-President about contacts with the Russian ambassador in December of 2017.

17. **March 20, 2017** - FBI Director James Comey confirmed the Bureau’s investigation into links between Russia and members of the Trump campaign.

18. **April 3, 2017** - The Russian side delivered an official proposal to the U.S. to hold a bilateral high-level group meeting on international information security. The American side ignored this document.
  
19. **May 9, 2017** - Trump fired FBI Director James Comey. The White house statement said that the President acted “based on the clear recommendations of the Department of Justice” for Comey’s poor conducting of the FBI’s investigation into Hillary Clinton’s violations of classified information use. White House critics used this President’s decision to blame him for obstruction of the so-called “Russian probe”.
  
20. **May 17, 2017** - Department of Justice appointed Robert Mueller as Special counsel to look into “Russian election interference and related matters”. The investigation’s scope included allegations about links or coordination between Trump’s presidential campaign and the Russian government.
  
21. **July 7, 2017** - first meeting between Presidents Vladimir Putin and Donald Trump on the sidelines of the G20 summit in Hamburg. Mainstream media and American political establishment attacked the U.S. leader for “shameful and disgraced” contact with the Russian President and “his unusual friendliness towards Moscow”.
  
22. **July 8-11, 2017** - On the next day after Russia-US presidential talks the “New York Times” published a series of “sensations” detailing the meeting between Donald Trump’s associates with Russian lawyer Natalia Veselnitskaya

at the “Trump Tower” hotel in New York in June 2016. The U.S. mainstream media used this story to promote conspiracy theory about “Trump-Russia collusion”. Congressional Democrats declared that the “Trump Tower” meeting is “clear evidence of senior level members of the Trump campaign meeting with Russians to try to obtain information that might hurt Hillary Clinton”.

23. **July 17, 2017** - The Russian side delivered a draft memorandum on creation of the bilateral high-level working group on cybersecurity issues, following the discussion of this subject between Presidents Vladimir Putin and Donald Trump in Hamburg on July 7. There was no reply.

24. **July 27, 2017** - the U.S Congress approved the bill “Countering America’s Adversaries through Sanctions Act” that imposed broad restrictions mainly against Russia.

25. **August 2, 2017** - President Trump signed the bill into law.

26. **August 31, 2017** - the U.S. Administration announces unprecedented restrictive measures against Russian diplomatic and consular missions in the U.S. requiring to close the Russian Consulate in San Francisco, Consul General’s residence there as well as properties of the Trade Representation in Washington, DC and New York. This move was yet another violation of international law.

27. **September 22, 2017** – the Department of Homeland Security notified U.S. election officials in 21 states that hackers targeted their systems in 2016.

Mass media accused Russia in those “cyberattacks”. There have been no facts presented yet.

28. **October, 2019** - U.S. Ambassador to the U.N. Nikki Haley said that “Russian interference is warfare”.

29. **October 26, 2017** - Twitter said it would no longer accept ads from accounts owned by Russian news outlets “RT” and “Sputnik”.

30. **October 30, 2017** - social media companies delivered to the U.S. Congress “alarming” reports claiming that Russian agents placed 1 000 videos on YouTube, 131 000 messages on Twitter, 120 000 posts on Instagram and 80 000 posts on Facebook which were viewed by up to 126 million people.

31. **November 13, 2017** - under pressure from the U.S. Russian media outlet “RT” was forced to register as a foreign agent. The other Russian news agency “Sputnik” was filed under the Foreign Agents Registration Law a few days later - on November 17.

32. **January 23, 2018** - Congressional Democrats called on “Facebook” and “Twitter” to urgently investigate and “combat Russian trolls and bots”.

33. **February 7, 2018** - Secretary of State Rex Tillerson suggested in an interview with “Fox News” that “Russia is already attempting to interfere in the 2018 midterm elections”.

34. **February 13, 2018** – The heads of National Intelligence, CIA, FBI and NSA said during testimony to the Senate that “Russia is intent on disrupting foreign elections, including the 2018 midterms”. Director of National Intelligence Dan Coats said that “the U.S. is under attack from Russian efforts”.

35. **February 16, 2018** - Special counsel R.Mueller indicted 13 Russian citizens, Internet-Research Agency and two other Russian entities for alleged “interference in the 2016 elections”. According to investigators, the defendants conducted “information warfare” to “sow discord” in the U.S. political system to help Donald Trump win.

36. **March 12, 2018** - Republicans from the House Intelligence Committee announced the end of their investigation over the objections of the Democrats. Their findings are that Russia interfered to create discord, but “there was no evidence of collusion” between the Trump campaign and the Russian government and that Russia did not have a preference for Donald Trump as a candidate.

37. **March 12, 2018** - State Secretary Rex Tillerson publicly blamed Russia of the supposed use of a nerve agent in the poisoning of Skripals in the U.K.

38. **March 15, 2018** - President Trump imposed financial sanctions under CAATSA on 13 Russian government hackers and organizations indicted by Special counsel R.Mueller.

39. **March 15, 2018** - the U.S. Administration accused the Russian government of a series of cyberattacks targeting United States and European nuclear power plants and electric grids.

40. **March 20, 2018** - “the Washington Post” reported that President Trump failed to follow warnings from his advisers “not to congratulate the President-elect of Russia”.

41. **March 26, 2018** - the U.S. Administration joined other Western countries and declared expulsion of 60 Russian diplomats in response to the poisoning of Skripals.

42. **April 6, 2018** - the U.S. Treasury implemented economic sanctions on 7 Russian businessmen and 12 companies along with 17 top Russian officials.

43. **April 20, 2018** - the Democratic National Committee sued the Trump Campaign, the Russian government and Wikileaks for “election interference” in 2016.

44. **July 13, 2018** - Special Counsel R. Mueller indicted 12 “Russian military intelligence officers for the hacking the DNC, the DCCC and the Clinton campaign for the purpose of stealing internal documents and distributing them in public as well as influencing the 2016 presidential election”.

45. **July 15, 2018** - Russian citizen Maria Butina was arrested in Washington, DC on charges of being an unregistered foreign agent of the Russian Federation

working to infiltrate politically influential organizations in the U.S. and influence U.S. officials.

46. **July 15, 2018** - magazine “the Business Insider” reported that “a new Russian intelligence-linked news-site USAREally attempted to test the waters ahead of the November midterms”.

47. **July 16, 2018** - President Putin and President Trump met in Helsinki. Republicans and Democrats criticized the results of the meeting, calling the talks “disgraceful and detrimental to American democratic principles”. U.S. media reaction was almost universally negative. Under pressure upon arrival to Washington President Trump declared that he held Russia responsible for attempts at “meddling” in the U.S. elections in 2016.

48. **July 20, 2018** – “Microsoft” claimed that Russian hackers had targeted three Congressional candidates running the 2018 elections.

49. **July 26, 2018** - Democratic Senator Claire McCaskill declared that Russian hackers attempted to break into her Senate email account.

50. **August 2, 2018** - Director of National Intelligence Dan Coats and FBI Director Christopher Wray announced that Russia “is actively interfering in the 2018 elections”.



51. **August 2-8, 2018** - Democratic candidates Jeanne Shaheen, Bill Nelson and Tabitha Isner reported the attempts of Russian hackers to penetrate state election systems and compromise their campaigns.

52. **August 6, 2018** – U.S. State Department summoned the charge d'affaires of the Russian Embassy to answer for Russia's alleged interference in the American internal affairs. However, the claims were, as usual, unverified.

53. **August 31, 2018** - the first major documentary to address the allegations of collusion between the Trump campaign and agents of the Russian state "Active measures" was distributed in theaters and digitally. The film was endorsed by Democrats and promoted by liberal activists before the 2018 midterms.

54. **September 12, 2018** - President Trump issued executive order authorizing sanctions against individuals and governments for interference in the U.S. elections.

55. **September 27, 2018** – Russian MFA delivers a diplomatic note to the U.S. side, regarding the case opened in the U.S. "Democratic National Committee v. the Russian Federation", explaining that the exercise of jurisdiction over the case by U.S. courts with respect to the Russian Federation is a violation of the international law, notably violation of jurisdictional immunities of the Russian Federation.

56. **October 4, 2018** - the U.S. Department of Justice announced the indictment of 7 Russian military intelligence officers for cybercrimes including hacking into the World Anti-Doping Agency and leaking the test results of athletes. Four defendants had been previously accused by Special counsel R.Mueller for “interference in the U.S. election”.

57. **October 19, 2018** - the U.S. Department of Justice charged Russian citizen Elena Khusyaynova with conspiracy to defraud the U.S. by managing the finances of the Russian social media troll operation that attempted to interfere with the 2016 and 2018 U.S. elections.

58. **November 6, 2018** - the United States midterm elections were held.

59. **November 11, 2018** – U.S. authorities in a show of harassment of media detained and interrogated Russian journalist A.Malkevich in a Washington DC airport

60. **December 21, 2018** – Director of National Intelligence Dan Coats issued a statement on the Intelligence Community's Response to Executive Order 13848 on Imposing Certain Sanctions in the Event of Foreign Interference in a United States Election, declaring that the Intelligence Community does not have intelligence reporting that indicates any compromise of election infrastructure.

61. **December 28, 2018** - Republicans from the House Judiciary Committee released final report on Russian probe, condemning the FBI for “unfair and politicized” investigation of “Trump collusion”.

62. **January 3, 2019** - the new Congress convened with the House under Democratic control. Liberal Congressman Brad Sherman filed articles of impeachment against President Trump for the reason of his obstruction of justice by firing FBI Director James Comey in May, 2017.

63. **January 10, 2019** – the “New York Times” reported that the FBI had opened counterintelligence probe against President Trump a few days after he fired Bureau’s Director James Comey. The FBI leadership allegedly had been alarmed by the President’s actions and concerned that he may had been working for Russia against American interests. The investigations had been taken over by Special counsel R.Mueller.

64. **January 29, 2019** - U.S. Intelligence services assessed that Russia along with other “adversaries” would seek to interfere in the 2020 presidential election “to advance its interests” during the testimony on the congressional hearings “Worldwide threats”.

65. **February 5, 2019** – Acting Attorney General and Secretary of Homeland security submit joint report on impact of foreign interference on elections and political/campaign infrastructure in 2018, stating that there was no material impact of the abovementioned.

66. **February 26, 2019** – American media claims that the U.S. military disrupted Internet access of the Russian Internet Research Agency on the day of U.S. elections of November 6, 2018. If true, then this is essentially an attack on a non-governmental entity based in another country.

67. **March 22, 2019** - Special counsel R.Mueller concluded his investigation and submitted final report to the Department of Justice.

68. **March 24, 2019** - Attorney General William Barr released a four-page letter to Congress highlighting the key findings of the Special counsel's report. Barr stated that Mueller's report outlined the Russian effort to influence the U.S. election but there was not sufficient evidence that President Trump colluded with Russia or obstructed justice. In total the Special Counsel's office indicted 34 people - 26 Russian citizens, 7 U.S. and 1 Dutch nationals. None of the Americans were accused of conspiracy with Russia.

- **January 11, 2017**

First of the many request authorizations to visit Russian diplomatic properties confiscated by U.S. government. Every single one of them was denied.

**- September 27, 2017**

The Embassy diplomatic note #80 to protest against an illegal invasion to the territory of the real estate facilities of the Russian Consular Post in San-Francisco.

**- October 11, 2017**

The Embassy diplomatic note #87 to protest against removal of the state flags of the Russian Federation from the buildings of the Consulate General of the Russian Federation in San Francisco, the residence of the Consul General of the Russian Federation in San Francisco and the Trade Representation of the Russian Federation in Washington D.C.

**- November 9, 2017**

The Embassy's statement on the US' demand for RT to register as a foreign agent.

*“The Russian side has repeatedly warned that any measures limiting activity of the Russian mass media in the United States will inevitably trigger an immediate symmetrical response, as provided for in the Russian legislation. Our signals have been ignored. RT's affiliates in the United States were presented with The United States Department of Justice's ultimatum demanding them to register as a foreign agent until November 13 or face arrests of the employees and bank accounts for non-compliance. Normal journalistic work of the RT team in the US has thus already been disrupted.”*

**- November 17, 2017**

The Embassy's comment on the US measures to force the owner of the 105,5 signal "Reston Translator", an American partner of the "Sputnik" radio station, to register as a foreign agent.

*"These steps signal continuation of the policy of pressure on the Russian mass media. It is obvious that now attempts are made to intimidate the commercial companies cooperating with our media".*

**- December 5, 2017**

The Embassy diplomatic note #112 on "Buzzfeed" publications regarding the information on money transfers of the Ministry of Foreign Affairs to Russian embassies around the globe.

*"According to the website Citibank which provides services to the Embassy passed 650 suspicious financial documents of the Russian diplomatic mission to the Congress and the FBI to fuel the «investigations». This leak of the relevant documents to the Buzzfeed is a gross violation of banking secrecy and inviolability of the Embassy's bank accounts."*

**- January 10, 2018**

The Embassy's statement on the US requirement for 'RIA Global' to register as a foreign agent.

*"We deem such actions unacceptable. We consider this to be another blow to Russia-U.S. relations. We are strongly convinced that these steps do not serve*

*U.S. interests, but undermine its' image and credibility. Russia has consistently been against limiting freedom of press. Including limiting the activity of foreign media and journalists. The same cannot be said of the USA and a number of its' allies, who continue to exert pressure on Russian media instead of promoting mutually beneficial cooperation”.*

**- February 27, 2018**

The Embassy diplomatic note #39 on disruption by the U.S. side of the Russian-American expert-level consultations on international information security, which were to take place in Geneva on February 27-28, 2018.

It was ignored by the U.S side.

**- March 30, 2018**

The Embassy diplomatic note #61 in connection to the unfounded accusation of alleged involvement of Russia in the Salisbury incident on March 4 (the so-called “Skripal case”) with request to provide national investigation records on this issue. 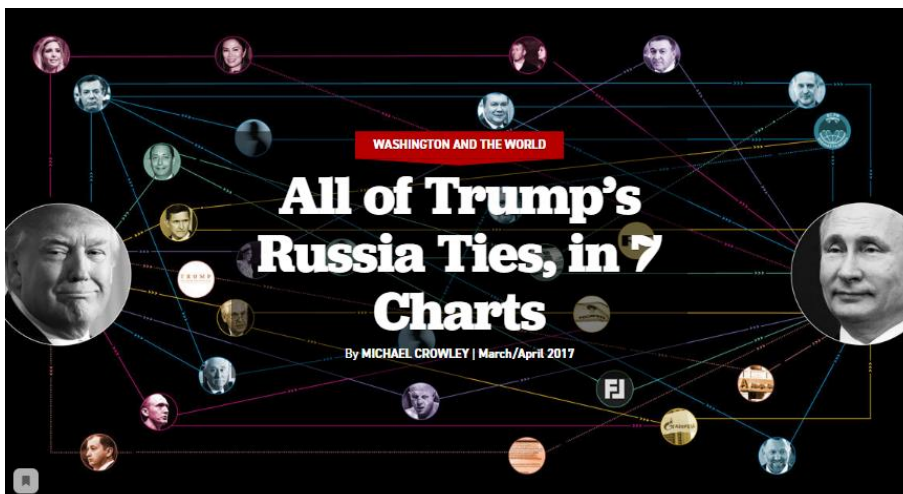

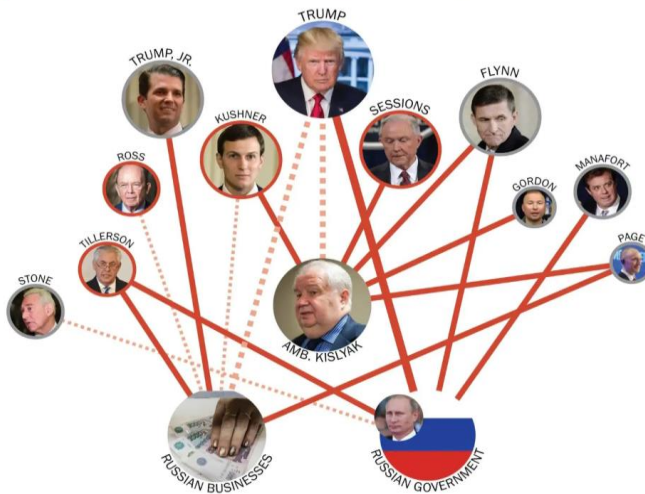

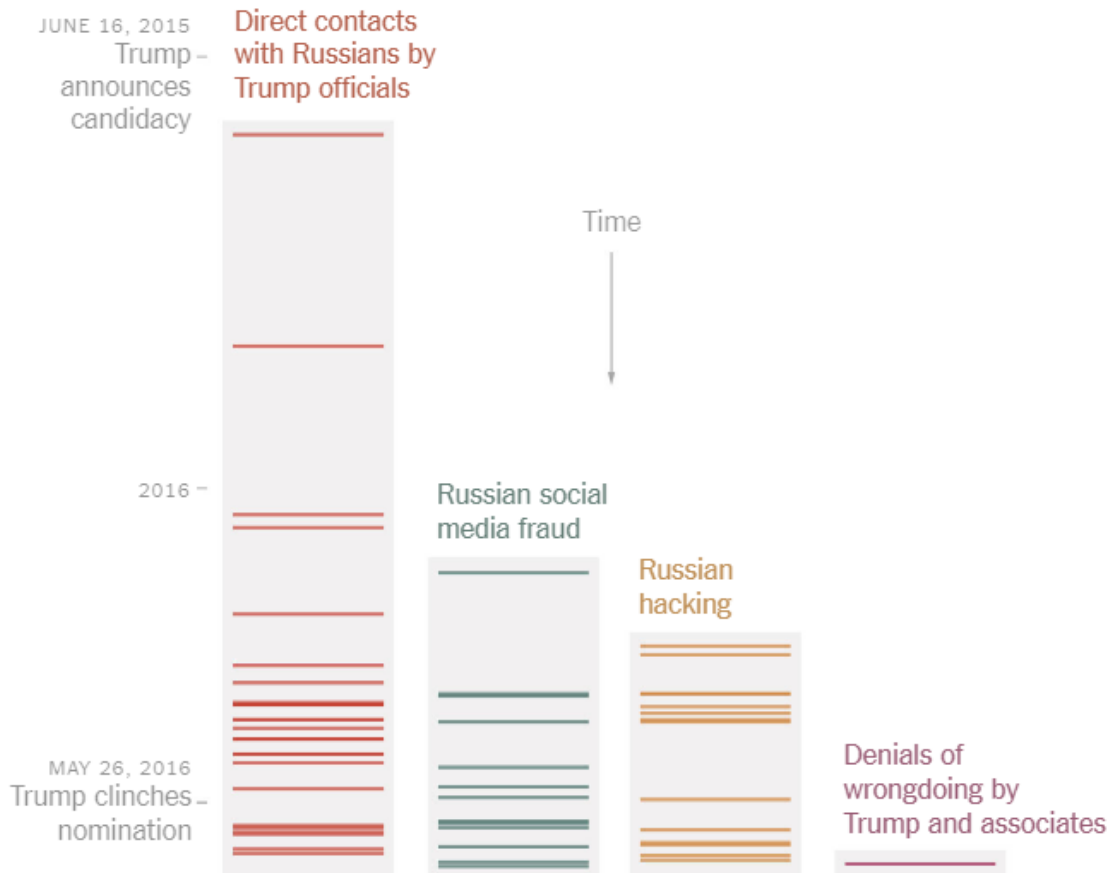

#### **Topic 4. DEMONIZATION OF THE EMBASSY**

There is another example of the absurdity of what is happening. Prosecutor Robert Mueller has been working for almost two years now. He interviewed dozens, if not hundreds of people, but found no leaks that would confirm alleged collusion between US President Donald Trump and the Russian Federation. No facts and no leaks were presented, which is very strange for the American political system. Leaks usually happen instantly there. There have been some; several facts have been mentioned regarding Ukraine's involvement in the US election campaign, but not Russia.

Here is one example. Michael Flynn served as President Trump's national security adviser for several days. I read with interest what he was specifically accused of. Prosecutor Mueller accused him of two things: first, Flynn called Russian Ambassador Sergey Kislyak before President Trump's inauguration and asked him not to reciprocate in response to the sanctions that Barack Obama imposed on Russia in the last days of his presidency, urged us not to take the path of escalation and confrontation. Was that so bad? Was it against the interests of the American people or the American government that a potential



member of the administration urged us not to harm the American diplomatic mission in the Russian Federation, not to take away property or expel diplomats? This was one accusation against Flynn. The second charge against him was that he also asked Ambassador Kislyak to influence Moscow's position on the resolution discussed in the UN Security Council, which required Israel to stop building new settlements in the occupied territories. Since the Obama administration decided not to block adoption of this resolution and, unlike in the previous cases, to abstain rather than vote it down, Flynn, according to Mueller, asked the Russian side to veto this anti-Israeli resolution.

I am not talking about whether it was necessary to adopt that resolution or not. But he essentially called on the Russian side to defend the position that the United States had been promoting in the UN for decades. Here are two accusations against this person. I do not know what sentence he will get. But the absurdity of the situation is obvious to me. This is just one example of the bacchanalia going on around the so-called Russian dossier.

<...> There are solid facts showing that the Democratic Party violated the law when illegal methods were used to force Bernie Sanders to quit the race. Everyone has forgotten about this, talking about Russia all the time rather than about what is happening in the United States.

I know American society, where no secrets are safe but are leaked to the public. If there was a single solid fact of Russia's interference in US affairs, it would have been leaked during the more than two years of hearings and meetings held by Mueller's office. But the only one to get in trouble was Paul Manafort. Moreover, it turned out that he worked for Ukraine, not Russia. But this fact is being forgotten as well.

The focus is now on Maria Butina, whose only sin is that she has joined the National Rifle Association of America. This has been presented as nearly an assault on the US Constitution.

We are open for dialogue as long as the United States is. President Vladimir Putin has said this more than once at his meeting with US President Donald Trump in Hamburg in 2017, in Helsinki last year, as well as during their contacts at the G20 summit in Buenos Aires. We do not want to interfere, and we do not want to give any reason for accusing us of interference in the internal fighting and conflicts in the United States. What we have is a constructive agenda. We have outlined a number of cooperation areas, including the establishment, upon our presidents' approval, of a business council comprising five, six or seven top officials each from the largest Russian and US corporations. I am sure that such a high-level council could become a major stabilisation factor, at least for our business communities.

We have also proposed establishing, if our presidents approve this, a small council of leading Russian and US political scientists who can be charged with preparing a positive agenda. We have offered an extended programme for a dialogue on strategic stability...

## DEBUNKING KEY CLAIMS OF “RUSSIAGATE”

### **1. FALSE CLAIM: Russia “meddled” in the U.S. elections by conducting influence operations, including through social media.**

#### **FACT**

All of the claims of Russian trolls that surfaced over the last few years (such as Russians using Pokémon Go mobile game and sex toys ads to meddle in the elections - [https://news.vice.com/en\\_us/article/j5zkn3/russian-trolls-tried-to-use-pokemon-go-and-lgbt-positive-sex-toys-to-tip-the-2016-election](https://news.vice.com/en_us/article/j5zkn3/russian-trolls-tried-to-use-pokemon-go-and-lgbt-positive-sex-toys-to-tip-the-2016-election)) are so preposterous and contradictory that they virtually disprove themselves.

Not to mention the absurdity of the whole notion of 13 persons and 3 organizations (whichever country they might represent) charged on February 16, 2018, by Robert Mueller with criminally interfering with the elections, affecting in any way electoral processes in a country of more than 300 million people.

It is telling that when pressed about the scope of the alleged influence campaign, representatives of U.S. social media companies give such numbers, that even if they were true (and there’s no evidence of a connection to Russian government), are basically non-existent. For example, Facebook has identified 3,000 Russia-linked ads that cost about \$100,000. That’s a miniscule number of ads and a fraction of Facebook’s revenues, which totaled \$28 billion (<http://fortune.com/2017/11/01/facebook-google-twitter-russian-ads-congress/>). Facebook estimates that 126 million people might – the emphasis is on the word might - have seen this content. But this number represents just 0,004% of the content those people saw on the platform.

Google CEO Sundar Pichai testified to the U.S. House Judiciary Committee hearing on December 11<sup>th</sup>, 2018 that “ad accounts linked to Russia”

spent “about \$4,700 in advertising” to politically influence Americans during the 2016 presidential election season (<https://www.breitbart.com/tech/2018/12/11/google-ceo-russia-linked-ad-accounts-spent-4700-on-2016-political-advertising/>).

To further cast doubt on the allegations, an American watchdog group “Campaign for Accountability” (“CFA”) admitted on September 4<sup>th</sup>, 2018, that it deliberately posted propaganda materials on Google disguised as “Russian hackers from the Internet Research Agency” to check how they would be filtered for “foreign interference”. Google officials then accused the CFA for its ties to a rival tech company “Oracle”. In other words, corporate intrigues disguised as “Russian interference”. (<https://www.businessinsider.com/google-failed-to-stop-watchdog-posing-as-russians-from-buying-divisive-ads-2018-9>).

As American media has admitted, out of several dozens of pre-election rallies Special Counsel Mueller mentions in his indictment against the Russians, only a few actually appear to have successfully attracted anyone, and those that did were sparsely attended and, almost without exception, in deep-red enclaves that would have voted for Trump anyway. (<https://www.nationalreview.com/2018/03/mueller-investigation-indictments-russian-organized-rallies-not-influential/>)

Amidst all the hysteria about the alleged Russian meddling it is worth reading about U.S. researchers’ studies showing that, quoting “The Washington Post”, it is the Americans that peddle disinformation and hate speech. ([https://www.washingtonpost.com/technology/2018/11/06/forget-russians-this-election-day-its-americans-peddling-disinformation-hate-speech/?utm\\_term=.b6a8b85c2268](https://www.washingtonpost.com/technology/2018/11/06/forget-russians-this-election-day-its-americans-peddling-disinformation-hate-speech/?utm_term=.b6a8b85c2268))

According to Graham Brookie, director of the Atlantic Council's Digital Forensic Research Lab., the scale and scope of domestic disinformation is much larger than any foreign influence operation. And academics from the Harvard's Shorenstein Center on Media, Politics and Public Policy show in their study that they had seen major spikes in outright fabrication and misleading information proliferating online before the 2018 U.S. election, with people using warlike rhetoric in social media posts to spread anti-immigrant sentiment. A "significant portion" of the disinformation appeared to come from Americans, not foreigners, the Harvard researchers said.

## **2. FALSE CLAIM: Russian hackers accessed computer servers of the Democratic National Committee (DNC) and leaked materials through Wikileaks and other intermediaries**

### **FACT**

As President of the Russian Federation Vladimir Putin noted in his interview with U.S. TV channel NBC on June 5, 2017 when flatly denying any allegations of Russia interfering in internal affairs of the U.S., today's technology is such that the final internet address can be masked and camouflaged to an extent that no one will be able to understand the origin of that address. It is possible to set up any entity or individual that everyone will think that they are the exact source of attack. (<http://en.kremlin.ru/events/president/news/54688>)

No evidence has been presented linking Russia to leaked emails. In fact, there are credible studies arguing that DNC servers are much more likely to have been breached by someone with physical access. For example, a group of former officers of the U.S. intel community from the "Veteran Intelligence

Professionals for Sanity” (VIPS), members of which met with then-CIA Director Mike Pompeo in 2017 to present their findings (<https://consortiumnews.com/2019/03/13/vips-muellers-forensics-free-findings/>), demonstrated using forensic analysis that the DNC data was copied at a speed that far exceeds an Internet capability for a remote hack (<https://consortiumnews.com/2016/12/12/us-intel-vets-dispute-russia-hacking-claims/>, <https://consortiumnews.com/2017/01/17/a-demand-for-russian-hacking-proof/>, <https://consortiumnews.com/2017/07/24/intel-vets-challenge-russia-hack-evidence/>), thus suggesting it was more likely a removable storage device was used. Another counterargument to the “Russian hackers” claim is that the DNC files published by Wikileaks were initially stored under the FAT (File Allocation System) method which is not related to internet transfers and can only be forwarded to an external device such as a thumb drive.

It is also suspicious that the DNC prohibited the FBI from examining the servers. Instead, a third-party tech firm was hired, “Crowd Strike”, known for peddling the “Russian interference” claims. And soon enough it indeed announced that “Russian malware” has been found, but again, no solid evidence was produced.

According to the respected former UN weapons inspector Scott Ritter, the indictment by the Mueller team on July 13, 2018 of the 12 supposed Russian operatives (<http://time.com/5338451/rod-rosenstein-russian-indictment-transcript/>) was a politically motivated fraud (<https://www.truthdig.com/articles/indictment-of-12-russians-under-the-shiny-wrapping-a-political-act/>). As Ritter explains, Mueller seems to have borrowed his list from an organizational chart of a supposed Russian military intelligence unit, contained in a classified document from the NSA titled “Spear-Phishing



Campaign TTPs Used Against U.S. And Foreign Government Political Entities”, which was published by The Intercept online resource (<https://theintercept.com/2017/06/05/top-secret-nsa-report-details-russian-hacking-effort-days-before-2016-election/>). As stated in that document, this is just a subjective judgement, not a known fact. Ritter concludes, that this is a far cry from the kind of incontrovertible proof that Mueller’s team suggests exists to support its indictment.

Moreover, it is telling that the indictment was released (<http://time.com/5338451/rod-rosenstein-russian-indictment-transcript/>) just before the meeting between President Putin and Trump in Helsinki on July 16, 2018, seemingly as if the aim was to intentionally derail the bilateral summit.

### **3. FALSE CLAIM: Donald Trump colluded with Russia in the 2016 U.S. Presidential elections.**

#### **FACT**

As concluded in the summary of the Special Counsel Robert Mueller’s report, the investigation did not find that the Trump campaign or anyone associated with it conspired or coordinated with Russia (<https://www.nytimes.com/interactive/2019/03/24/us/politics/barr-letter-mueller-report.html>)

If the Mueller team, having all the resources of the U.S. government, after 22 months of work, many millions of dollars spent (<https://www.politifact.com/truth-o-meter/article/2019/mar/26/mueller-investigation-cost/>), more than 2800 subpoenas issued, nearly 500 search warrants and 500 witness interviews, didn’t find any evidence of “collusion”, it is simply because there was never any.

As the above listed timeline of events and analysis of sources show, the whole claim of collusion was launched and peddled by the same group of Democrats, liberal-leaning media and the so-called “Never Trump Republicans”, as it became clear that Donald Trump had real chances of winning the election. And later it morphed into a campaign to derail the newly-elected President agenda, including his efforts to mitigate the damage done to U.S.-Russian relations.

**4. FALSE CLAIM: Hacking of American political institutions was personally ordered by the Russian President Vladimir Putin.**

**FACT**

This claim is based on nothing else but the infamous fraudulent “Steele Dossier”([https://archive.org/stream/TheSteelDossierTrumpIntelligenceAllegations/The%20Steele%20Dossier%20-%20Trump-Intelligence-Allegations\\_djvu.txt](https://archive.org/stream/TheSteelDossierTrumpIntelligenceAllegations/The%20Steele%20Dossier%20-%20Trump-Intelligence-Allegations_djvu.txt)), paid for by political opponents of Donald Trump, and wild conjectures that “nothing in Russia happens without Putin’s approval” <https://www.politico.com/story/2016/12/obama-press-conference-today-live-speech-on-russia-hacking-232737>.

Needless to say, zero proof is presented. By the same logic, nothing in the U.S. happens without the President’s approval. For example, is he also responsible for Edward Snowden? After all, Mr. Snowden was doing work for the U.S. intelligence services. Or the deaths of all the civilians killed abroad by U.S. drone strikes? Sounds true?

**5. FALSE CLAIM: Russia did not cooperate with the U.S. in tracing the source of the alleged hacking.**

## **FACT**

Russia has repeatedly offered to set up a professional and de-politicized dialogue on international information security only to have been rebuffed by the U.S. side. For instance, following the discussion between Presidents Vladimir Putin and Donald Trump in Hamburg on July 7, 2017, Russia forwarded to the U.S. a proposal to reestablish a bilateral working group on cyberthreats which would have been a perfect medium to discuss American concerns. Moreover, during his meeting with Donald Trump in Helsinki on July 17, 2018, Vladimir Putin offered to allow U.S. representatives to be present at an interrogation of the Russian citizens who were previously accused by the office of Special Counsel Robert Mueller of being guilty of electoral interference (<http://en.kremlin.ru/events/president/transcripts/58017>). Furthermore, in February 2019 we suggested publishing bilateral correspondence on the subject of unsanctioned access to U.S. electronic networks , which was conducted between Washington and Moscow through the Nuclear Threat Reduction Centers in the period from October 2016 to the end of January 2017.

Needless to say, all Russian offers were rejected. A conclusion is naturally reached that the U.S. side does not want the truth to come out.

## **6. FALSE CLAIM: Russia is interfering in elections all over the world**

### **FACT**

Russia strictly adheres to the principle of non-interference in domestic affairs of other countries, which it considers to be cornerstone to international law. No credible evidence was produced not only of Russia's mythical meddling in the U.S. political processes, but to support similar allegations made by the U.S. in respect to other countries. For example, former National Security

Advisor H.R. McMaster insinuated that Russia was interfering in the Mexican presidential elections of 2018 (<https://thehill.com/homenews/administration/367844-mcmaster-points-to-russian-interference-in-mexican-election>). However, Mexican officials, including the president of the Mexican Senate Ernesto Cordero Arroyo (<https://sputniknews.com/europe/201805181064587418-mexico-election-russian-meddling-groundless/>), and Ambassador to Russia Norma Pensado during a press conference in Moscow in February, 2018 (<https://rossaprimavera.ru/news/93592ca6>), debunked this baseless claim.

Another example of fake news – reports saying that U.S. was increasingly convinced that Russia hacked French election on May 9, 2017 (<https://www.reuters.com/article/us-france-election-russia/u-s-increasingly-convinced-that-russia-hacked-french-election-sources-idUSKBN1852KO>).

However, on June 1, 2017, the head of the French government's cyber security agency said no trace was found of the claimed Russian hacking group behind the attack. (<https://apnews.com/fc570e4b400f4c7db3b0d739e9dc5d4d>)

On the other hand, the history of U.S. interfering in other countries' elections is well documented – by American sources as well (see: <https://www.theatlantic.com/ideas/archive/2018/07/the-us-has-a-long-history-of-election-meddling/565538/>).

For example, a Carnegie Mellon scholar, Dov H. Levin, has scoured the historical record and found 81 examples of U.S. election influence operations from 1946- to 2000 (<https://www.nytimes.com/2018/02/17/sunday-review/russia-isnt-the-only-one-meddling-in-elections-we-do-it-too.html>). Often cited examples include Chile in 1964, Guyana in 1968, Nicaragua in 1990, Yugoslavia in 2000, Afghanistan in 2009, Ukraine in 2014 not to mention

Russia in 1996! And how else could the current situation in Ukraine and Venezuela be described, with U.S. representative for Ukraine Kurt Volker openly pressuring Ukrainian voters to support the incumbent (<https://www.pbs.org/newshour/show/as-nato-turns-70-alliance-increases-aid-to-ukraine-to-confront-russia>), and Washington plotting a coup in Caracas? (<https://news.yahoo.com/russia-accuses-us-plotting-coup-venezuela-182217466.html>)

**7. FALSE CLAIM: The lawsuit of the Democratic National Committee against the Russian Federation related to “interference in the election” has a legal standing.**

**FACT**

The DNC filed a civil lawsuit on April 20, 2018 against the Russian Federation and other entities and individuals. Named as defendants in the lawsuit are the Russian Federation; the General Staff of the Armed Forces of the Russian Federation (GRU); the GRU operative using the pseudonym "Guccifer 2.0"; Aras Iskenerovich Agalarov; Emin Araz Agalarov; Joseph Mifsud; WikiLeaks; Julian Assange; the Trump campaign (formally "Donald J. Trump for President, Inc."); Donald Trump, Jr.; Paul Manafort; Roger Stone; Jared Kushner; George Papadopoulos; Richard W. Gates; and unnamed defendants sued as John Does 1–10. The DNC's complaint accuses the Trump campaign of engaging in a racketeering enterprise in conjunction with Russia and WikiLeaks.

Even irrespective of the fact that there was no “interference” in the first place, the case has no legal standing. Exercise of U.S. jurisdiction over the pending case with respect to the Russian Federation is a violation of the

international law, specifically, violation of jurisdictional immunities of the Russian Federation arising from the principle of the sovereign equality of states.

**8. FALSE CLAIM: Russian Ambassador to the U.S. Sergey Kislyak was a spy.**

**FACT**

In March of 2017 U.S. media began libeling Sergey Kislyak a “top spy and spy-recruiter” (<https://edition.cnn.com/2017/03/02/politics/russia-kislyak-spy-claim-sessions/index.htm>) This preposterous claim was based on nothing but his contacts with Trump confidant Senator Jeff Sessions – carrying out work any Ambassador would do. Per the Vienna Convention on Diplomatic Relations of 1961, among core diplomatic functions is ascertaining by all lawful means conditions and developments in the receiving State ([http://legal.un.org/ilc/texts/instruments/english/conventions/9\\_1\\_1961.pdf](http://legal.un.org/ilc/texts/instruments/english/conventions/9_1_1961.pdf)), and that certainly includes openly meeting leaders of Congress on Capitol Hill. Even former CIA Director John McLaughlin noted that Mr. Kislyak is an experienced diplomat, not a spy. (<http://www.msnbc.com/andrea-mitchell-reports/watch/russian-ambassador-experienced-at-collecting-information-888728131913>).

**9. FALSE CLAIM: Russian Embassy retreat in Maryland was an intelligence base**

**FACT.**

Among the unlawful acts that U.S. administrations undertook was the expropriation of a legal Russian property in Maryland, a summer retreat near the Chesapeake Bay under the pretext it was used for intelligence gathering

But where is the trove of the alleged spy equipment that U.S. authorities reportedly found there? Why not show it publicly to back up the claim?

The retreat, “dacha” as Russians would call it, was bought by the former Soviet Union in 1972. Since then, it was used for recreation, including hosting a children’s summer camp and regularly entertaining American visitors. One of the more popular events was the stop-over during the annual Chesapeake Regatta, completed with an expansive tour of the property. Presumably U.S. intelligence services could have used this for years to inspect the property. Why nothing was mentioned before the Obama Administration action?

**10. FALSE CLAIM: The meeting in Trump Tower in New York on June 9, 2016 between Trump campaign officials and Russian lawyer Natalia Veselnitskaya was to discuss compromising materials that Russian had on Hillary Clinton.**

**FACT**

According to testimony provided to the U.S. Senate Judiciary Committee (<http://www.documentcloud.org/documents/4366365-Natalia-Veselnitskaya-Testimony-to-Senate.html>), Ms. Veselnitskaya focused on explaining the illicit activities of U.S.-British investor Bill Browder, wanted in Russia for crimes, and brought attention to the adverse effects of the so-called “Magnitskiy Act”, adopted by U.S. Congress in 2012 and lobbied for by Browder.

**11. FALSE CLAIM: Donald Trump’s former lawyer, Michael Cohen, met with Russians in Prague to “collude”.**

**FACT**

It was reported in American media that the Justice Department special counsel had evidence that Donald Trump’s personal lawyer, Michael Cohen, secretly made a trip to Prague during the 2016 presidential campaign to meet with Russian representatives, a fact also mentioned in the discredited “Steele Dossier” (<https://www.mcclatchydc.com/news/politics-government/white-house/article208870264.html>). This was given as further evidence of “collusion”. But Cohen vehemently denied this – under oath (<https://www.cnn.com/2019/02/27/politics/michael-cohen-prague-testimony-russia/index.html>). Given that he publicly turned on his former boss and still denied the fact of ever going to Prague disproves this claim further.

**12. FALSE CLAIM: Former member of the Trump campaign team Carter Page was a Russian intelligence asset.**

**FACT**

According to members of Congress and journalistic investigations, the redacted declassified documents of the U.S. Foreign Intelligence Surveillance Court (FISC, also called the FISA Court) show that the main source used by U.S. counterintelligence to justify spying on Mr. Page was the fraudulent so-called “Steele Dossier”.

Mr. Page for obvious reasons was not accused by the team of Robert Mueller of being involved in a “Russian conspiracy”.



**13. FALSE CLAIM: On August 22, 2018, The National Democratic Committee filed a claim to the FBI, accusing the “Russian hackers” of infiltrating its electoral database.**

**FACT**

Several days later members of the Democratic Party admitted that it was a “false alarm”, as it was simply a security check-up performed at the initiative of the Democratic Party’s affiliate in Michigan.

**14. FALSE CLAIM: On August 8, 2018 U.S. Senator Bill Nelson accused Russia of breaching the infrastructure of the voter registration systems in several local election offices of Florida.**

**FACT**

Florida’s Department of State spokesperson, Sarah Revell, stated on August 9, 2018, that Florida’s government had not received any evidence from competent authorities that Florida’s voting systems or election records had been compromised. The U.S. Department of Homeland Security and the FBI also could not confirm the accusations.

**15. FALSE CLAIM: In September, 2017 the U.S. media, referring to the Department of Homeland Security, accused Russia of “cyberattacks”**

**on electoral infrastructure in 21 states during the 2016 U.S. Presidential elections.**

**FACT**

On September 27, 2017, Wisconsin and California authorities stated that their electoral systems were not targeted by cyberattacks. On November 12, 2017, the U.S. Secretary of the Treasury Steven Mnuchin said in a CBS interview that the “hackers’ activity” had no significant consequences and did not influence the outcome of the elections.

**16. FALSE CLAIM: Russia meddled in the Alabama 2017 Senate elections to help the Republican candidate.**

**FACT**

Despite the initial claims (<https://www.motherjones.com/politics/2017/12/russian-propagandists-are-pushing-for-roy-moore-to-win/>), it turned out, a group of Democratic tech experts decided to imitate so-called “Russian tactics” in the fiercely contested Alabama Senate race. Even more jarring is the fact that one participant in the “Alabama project”, Jonathon Morgan, is chief executive of “New Knowledge”, a cyber security firm that wrote a scathing account of Russia’s social media operations in the 2016 election that was released in 2018 by the Senate Intelligence Committee. (<https://www.nytimes.com/2018/12/19/us/alabama-senate-roy-jones-russia.html>). Once again, we have one of the main private sector players in hyping the Russian threat caught red-handed.

**17. FALSE CLAIM: Paul Manafort, Donald Trump’s presidential campaign chairman, was a secret link to Russian intelligence.**

**FACT**

Trump’s former campaign chair was hit with two indictments from Mueller’s office. However, even as American media notes, both cases have nothing to do with Russia and stemmed from his years as a political consultant for the Ukrainian government and his failure to pay taxes on the millions he earned, report the foreign bank accounts he used to stash that money, and report his work to the US government. In his second case in Virginia, he was also charged with committing bank fraud to boost his assets when the Ukraine work dried up (<https://www.buzzfeednews.com/article/zoetillman/robert-mueller-everyone-charged-russia-investigation>).

In fact, concerns are raised in the U.S. that it was the Ukrainian officials who tried to influence the 2016 elections by leaking compromising materials on Mr. Manafort (<https://www.politico.com/story/2017/01/ukraine-sabotage-trump-backfire-233446>).

The Ukrainian connection is also prevalent in the case of money transferred to accounts of U.S. politicians. For instance, according to a “New York Times” article, Ukrainian billionaire Viktor Pinchuk donated over 10 million dollars to the “Clinton Foundation and just 150 thousand dollars to the “Trump Foundation” (<https://www.nytimes.com/2018/04/09/us/politics/trump-mueller-ukraine-victor-pinchuk.html>).

**18. FALSE CLAIM: Russia compromised the Vermont power grid.**

**FACT**

On December 31, 2016, “The Washington Post”, referring to U.S. authorities, accused “Russian hackers” of compromising the Vermont power grid. The local company, “Burlington Electric”, allegedly traced a malware code in a laptop of its employee. It was stated that the same “code” was used to hack the Democratic Party servers in 2016. However, the “Wordfence” cybersecurity firm checked “Burlington Electric” for hacking, and said that the malware code was openly available, for instance, on a web-site of Ukrainian hackers. The attackers were using IP-addresses from across the world. “The Washington Post” later admitted that conclusions on Russia’s involvement were false. **19. FALSE CLAIM: Russian Alfa Bank was used as a secret communication link with the Trump campaign.**

**FACT**

In October 2016 a new “sensation” appeared, alleging that a message exchange between Alfa Bank server and Trump organizations indicated a «secret» Trump – Russia communication channel.

**20. FALSE CLAIM: Russia cracked voter registration systems during the 2016 U.S. elections.**

**FACT**

In July, 2016 the U.S. Department of Homeland Security accused Russia of gaining unauthorized access to electronic voter registration systems in Arizona. But on April 8, 2018, “Reuters”, referring to a high-ranking U.S. Administration official, wrote there was no proof Russia had anything to do with the mentioned cyberattack. (<https://www.reuters.com/article/us-usa-cyber-election/arizona-election-database-targeted-in-2016-by-criminals-not-russia-source-idUSKBN1HF11F>)

**21. FALSE CLAIM: Russian Embassy bank transactions were linked to “election interference”.**

**FACT**

American publication “Buzzfeed” repeatedly claimed that U.S. authorities flagged Russian Embassy financial transfers as suspicious, many of them dated around the 2016 election (<https://www.buzzfeednews.com/article/jasonleopold/newly-uncovered-russian-payments-are-a-focus-of-election>). In reality, the media outlet, by twisting the facts and placing them out of context, made routine banking transactions – salary transfers, payments to contractors – look nefarious. It is not uncommon for Embassy personnel to receive larger payouts, transfer or withdraw larger sums of money at the end of their work, for example ([http://www.mid.ru/ru/foreign\\_policy/news/-/asset\\_publisher/cKNonkJE02Bw/content/id/3024493](http://www.mid.ru/ru/foreign_policy/news/-/asset_publisher/cKNonkJE02Bw/content/id/3024493)). Furthermore, leaking of

confidential banking information of persons and organizations protected by diplomatic immunity raised concerns about the likely involvement of security services.

The arrest in October 2018 of a U.S. Treasury Department's Financial Crimes Enforcement Network official (<https://www.rferl.org/a/us-treasury-official-edwards-charged-with-leaking-confidential-bank-reports-suspects-in-russia-investigation-buzzfeed/29549944.html>), charged with leaking information both about the Russian Embassy accounts and former Trump campaign chairman Paul Manafort, provides further proof to the theory of a political vendetta.

## CONCLUSION

Almost three years have passed from the first fake news that appeared in American media on the subject of “Russian meddling” and “collusion”, which were first launched to discredit Donald Trump candidacy and then to sabotage his agenda, including efforts to stabilize Russian-U.S. relations.

After three years, more than 8000 publications in just four main outlets (“Washington Post”, “New York Times”, CNN and MSNBC), endless Congressional inquiries, 22 months of the work of Robert Mueller that cost taxpayers an estimated more than 32 million dollars, more than 2800 subpoenas, 500 witnesses interrogated and as much search warrants, an obvious conclusion is reached – there was no collusion.

The investigation also didn’t show any real evidence to back up claims of Moscow’s cyberattacks and attempts to “subvert democracy”. The act of repeating in the summary of the Mueller report the indictments against 25 Russian citizens, made last year just to justify the useless work of the investigative team, doesn’t make them any less hollow and laughable.

All this time Russia pointed to the obvious made-up nature of these insinuations. Fruitlessly we asked first the Obama Administration and then the current authorities in Washington for conclusive proof. In order to alleviate the suspicions we proposed exchanging mutual written commitments not to interfere in the domestic affairs of each other. Suggested reestablishing the bilateral expert group on information security that the Obama Administration derailed, which could have served as an optimal platform for the de-politicized dialogue on these matters. The American side was also invited to attend the proposed questioning of Russian citizens accused by Mueller, and to publicize

the exchange between the two countries following the U.S. accusations of cyberattacks which was conducted through existing channels in the “hot period” between October 2016 to January 2017.

The U.S. refused every single time.

We understand that certain political circles in Washington have invested too much in the spreading of conspiracy theories about Russia and Donald Trump to admit they are groundless. Nevertheless, we hope that the end of the Mueller saga would contribute to further dispelling the smoke and mirrors on this topic. The first step – the disavowal of the “collusion theory” – was taken. But if all of the categorical allegations heard all this time turned out to be patently false, why not make the next logical move and fact-check the “Russian meddling” narrative? As demonstrated in this report, an objective analysis of the claims and the timeline of events invariably leads to the conclusion - it was just fake news.

Our hope is that this realization would not only contribute to the normalization of the Russian-American relations, but to the healing of the political discourse in the U.S. as well.

In the end, to quote Russian President Vladimir Putin (as delivered in his comments during the plenary session of the International Arctic Forum on April 9, 2019), “we have been saying from the start that this commission led by Mr. Mueller won't find anything, because no one knows better than us: Russia has not interfered in any U.S. election”.
