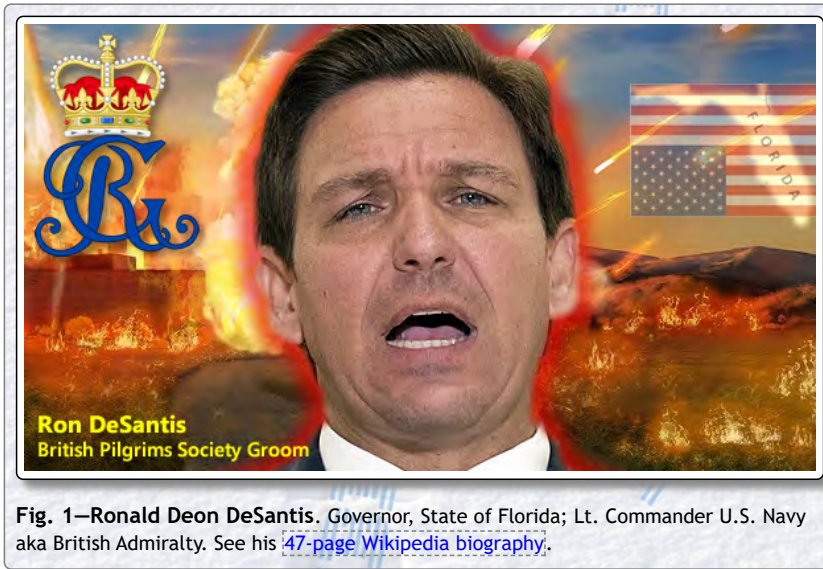


Fig. 1—Ronald Deon DeSantis. Governor, State of Florida; Lt. Commander U.S. Navy aka British Admiralty. See his [47-page Wikipedia biography](#).

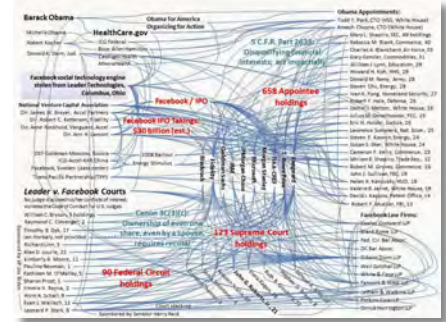

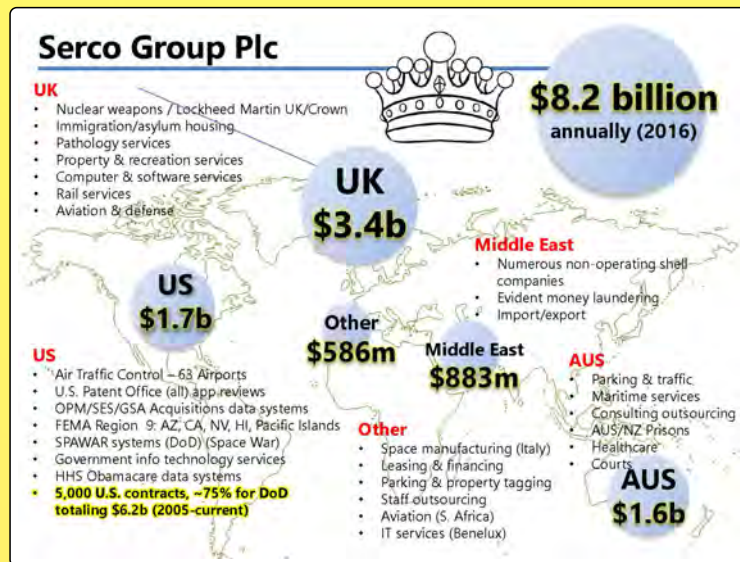


Fig. 5—Anonymous Patriots. (Compiled May 15, 2018). Serco Group Plc global operations.

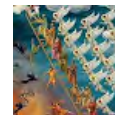

subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on *Leader v. Facebook* until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

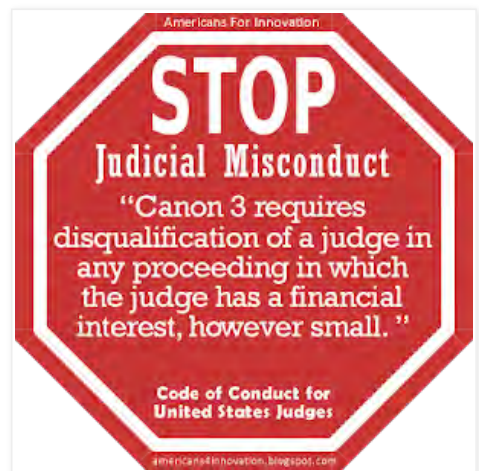

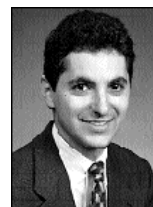

 - a. **Lord Walter Rothschild**, Pilgrims Society co-founder,
 - b. **Baron Henry de Worms, Lord Pirbright**, a maternal Rothschild), appointed [Jan. 02, 1889](#) to Privy Council; Pilgrims Society co-founder, and

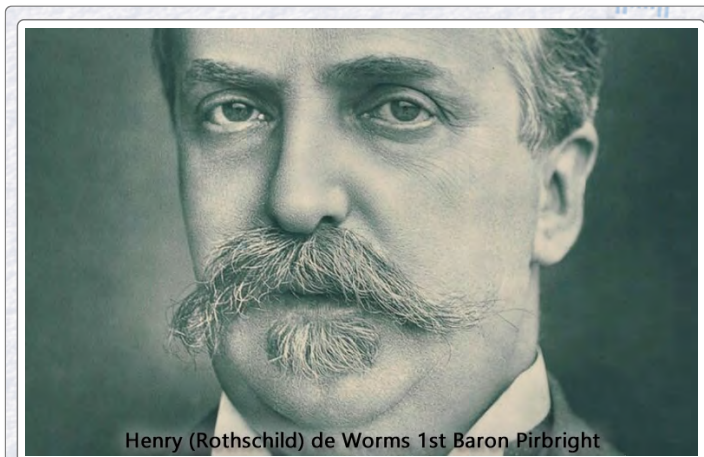


Fig. 8—Henry (Rothschild) de Worms 1st Baron Pirbright (b. Oct. 26, 1840-d. Jan. 09, 1903), also called Lord Pirbright. Baron Pirbright's grandmother was Schönche Jeannette Rothschild (1771-1859). Her father was [Mayer Amschel Rothschild](#) (1744-1812), the founder of the [Rothschild colonial banking business in Ceylon](#) where Lord Pirbright's father Solomon de Worms established the "Rothschild" coffee and tea plantation with slave, and nearly slave labor.

Hannah de Rothschild, Rosebery's wife, became the richest woman in England. Her more than \$500 million fortune passed to Rosebery in 1890 at her untimely death from typhoid fever at age 39.

Coincidentally (?), J.P. Morgan's father, Junius Morgan, died in a carriage crash in the French Riviera also in 1890. J.P. Morgan then took over George Peabody's Riggs Bank whose name he changed to J.P. Morgan & Company.

In 1891, Lord Rosebery, J.P. Morgan, Cecil Rhodes, Baron Henry de Worms, Lord Rothschild and Lord Alfred Milner founded the Round Table to use Jesuit discipline and Masonic secrecy to promote the reorganization of the British Empire into an Imperial Federation that they insisted include America coming back under the British Crown.

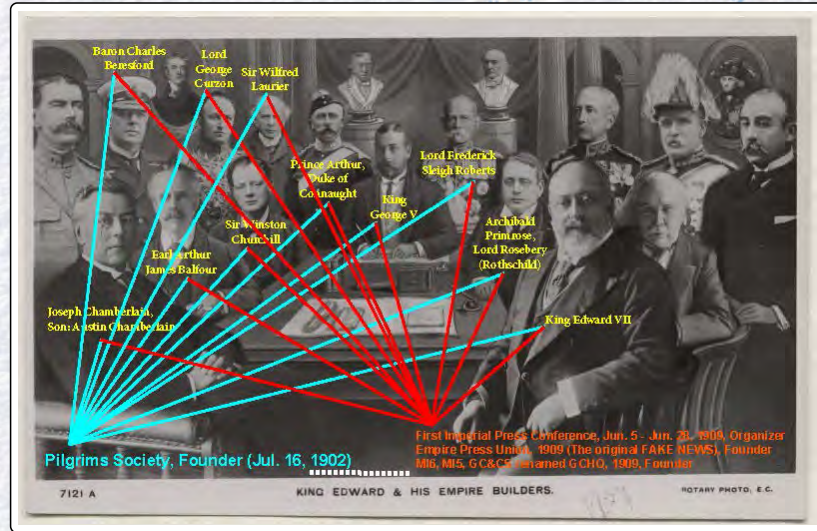


Fig. 10—[King Edward & His Empire Builders. \(ca. 1907\)](#). First Imperial Press Conference, Jun. 5 - Jun. 28, 1909, Organizer Empire Press Union, 1909 (The original FAKE NEWS), Founder MI6, MI5, GC&CS renamed GCHQ, 1909, Founder. See original at the [National Portrait Gallery \(UK\)](#).

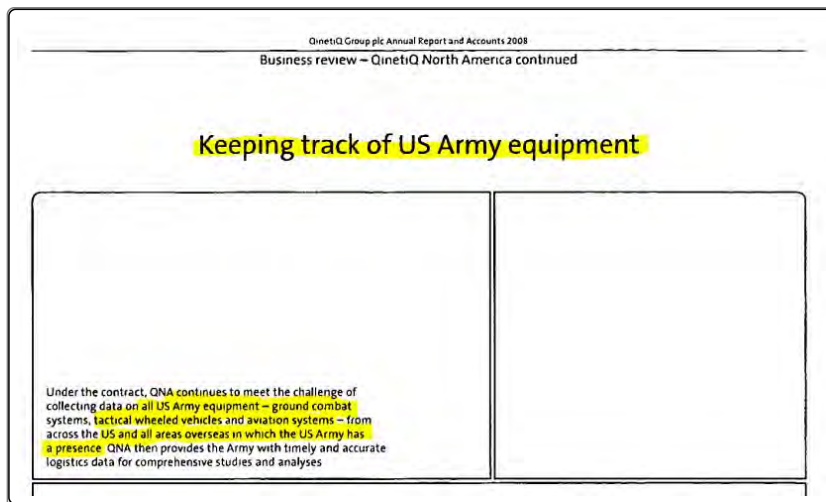


Fig. 17—QinetiQ Group Plc, Co. No. 4586941. (Aug. 07, 2008). Annual Report and Accounts, p. 17 (PDF p. 21), Keeping track of US Army equipment worldwide. Companies House (UK).

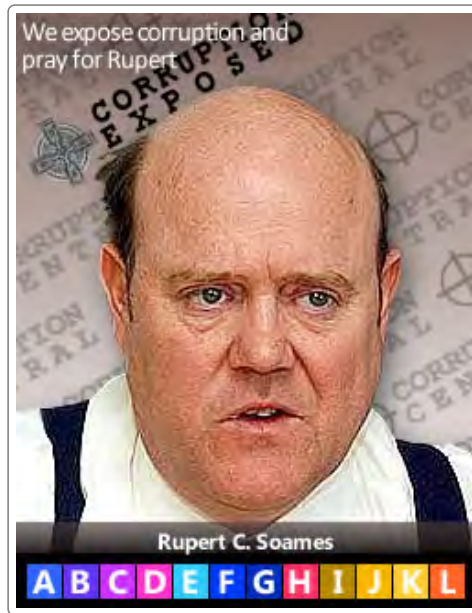


Fig. 18—Rupert C. Soames OBE (born 18 May 1959) is a British businessman and CEO of Serco. He was awarded an OBE (Order of the British Empire) in 2010. He is the brother of Sir Arthur Nicholas Winston Soames, and the grandson of Winston Churchill.

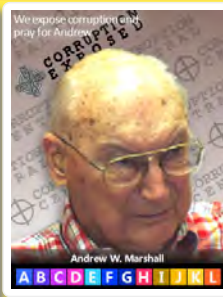
