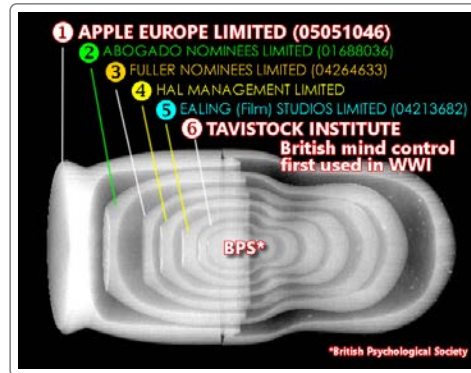
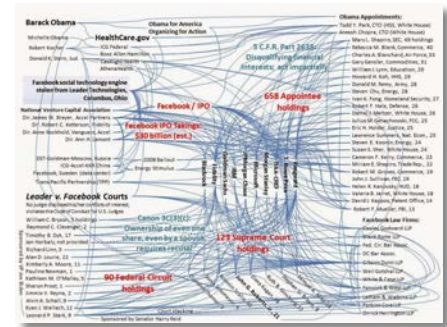


Fig. 4—British Pilgrims Society Interlocking Relationships.

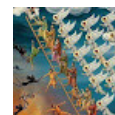

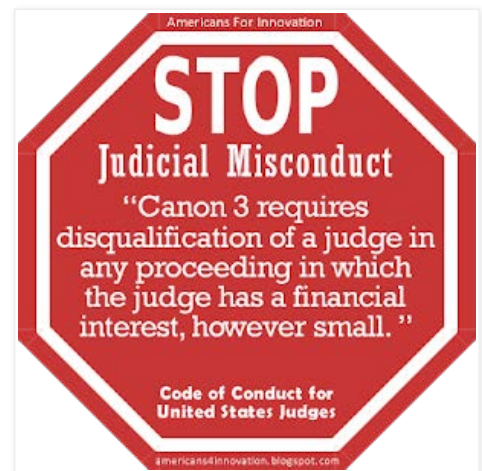

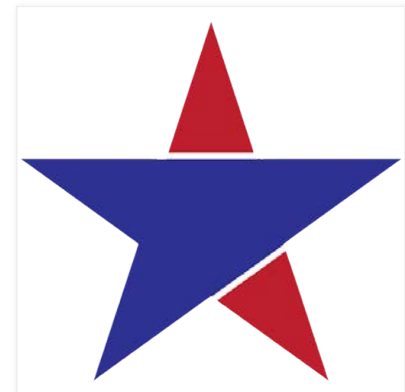
