ROAD TRAFFIC REGULATION ACT 1984

The Secretary of State for Transport hereby gives notice that he has made an Order entitled "The Trunk Roads (London—Edinburgh—Thurso Trunk Road (A1) (De-restriction) Order 1991 under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984. The effect of the Order, which comes into force on 9th July 1991, is that the lengths of road specified in the schedule to this notice have ceased to be subject to a speed limit of 30 m.p.h. which was automatically imposed on these lengths of road by virtue of sections 81(1) and 82(1) of the Road Traffic Regulation Act 1984 when a system of street lighting was installed.
