18 Petitioner _____'s Affidavit Requesting Confidentiality Pursuant to NRS 247, 250,
19 and/or 293, incorporated by reference, and the Court having considered the same, and good

21 THE COURT FINDS, based on a preponderance of the evidence, that a threat exists to
22 Petitioner, Petitioner's spouse, domestic partner, and/or minor child, and that such threat is
23 mitigated by making the personal information contained in the records of the County Recorder,
24 the County Assessor, and/or the Secretary of State/City Clerk confidential.

26 THE COURT FINDS, based on a preponderance of the evidence, that a threat has
27 existed within the last five (5) years to a person who holds a similar position as the Petitioner and

1 that such threat is mitigated by the personal information contained in the records of the County
2 Recorder, the County Assessor, and/or the Secretary of State/City Clerk confidential.

3 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that pursuant to NRS 247,
4 250, and 293, subject to the exceptions delineated in state law, the County Recorder, the County
5 Assessor, the Secretary of State, and the County and/or City Clerk shall keep confidential and
6 shall not disclose the personal information (home addresses, phone numbers, email addresses) of
7 the following person(s): _____

9 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Order expires in
10 five (5) years after the date this Order is filed.

12 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon evidence
13 sufficient to the County Recorder, the County Assessor, the Secretary of State, and the County
14 and/or City Clerk that the real and/or personal property subject to this Order has been conveyed
15 from the person herein named in this Order, the entity may without further order of this Court
16 terminate the non-disclosure of confidential information as delineated herein.

18 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this order shall be
19 sealed and access will not be allowed to anyone without a court order.
