OBJECTION TO CLAIM OF EXEMPTION FROM EXECUTION**

This hearing date is not later than 7 judicial days after the filing of the Objection to Claim of Exemption from Execution in accordance with NRS 21.112(6).

**PLEASE NOTE THAT** at the hearing, the party or non-party who filed the Claim of Exemption will have the burden to prove to the Court that he or she is entitled to the claimed exemptions. NRS 21.112(6). Such proof may include, without limitation, a letter from the government, an annual statement from a pension fund, receipts for payment, copies of checks, records from financial institutions or any other document which demonstrates that the money in the party's or non-party's account is exempt. A proposed order to be used by the court to grant or deny an exemption, which the party or non-party who filed the Claim of Exemption should take to the hearing, is available at the Civil Law Self-Help Center, 200 Lewis Ave., Las Vegas, Nevada, or on its website at [www.civillawselfhelpcenter.org](http://www.civillawselfhelpcenter.org).

Pursuant to NRS 21.112(8), you may withdraw your Claim of Exemption prior to the hearing and direct that the property be released to the judgment creditor if you choose to do so. Similarly, the judgment creditor may withdraw the objection and direct that the property be released to you. You may be able to have your property released more quickly if you contact the judgment creditor or the attorney of the judgment creditor and provide written proof that the property is exempt.

Pursuant to NRS 21.112(3), not less than 5 judicial days before the date set for the hearing, the Plaintiff or Counterclaimant filing this objection shall serve notice of the date of the hearing on (1) the Defendant, Counterdefendant, Third-Party Defendant, or other non-party who filed the Claim of Exemption, (2) the sheriff or constable, and (3) any garnishee.
