A LETTER FROM OUR PRESIDENT AND CEO

Hospitals are much like people; they have a personal side and a business side. The personal is reflected through the compassionate care we provide to patients. The business keeps operations running smoothly and productively.



Being true to our mission "To Restore, Maintain and Improve Health" is serious business at Lafayette General. To the point, it has taken the focus from primarily delivering acute care to proactively keeping populations healthy. We have tackled that ambitious goal, most effectively, by establishing relationships with hospitals that were previously under stress to stay afloat. In fact, it was the notable acquisition

of newly named University Hospital & Clinics (UHC) that made our previous networking efforts official with the formation of a health system, Lafayette General Health (LGH).

University Hospital & Clinics (formerly University Medical Center when it was run by the State of Louisiana) was the only major teaching hospital in Lafayette when it opened in 1982. After LGH took over management of UHC from the State of Louisiana, the residency program was expanded to Lafayette General Medical Center on July 1, 2013. These two hospitals share in a synergistic relationship, where residents based out of LSU's New Orleans and Baton Rouge campuses rotate throughout each of these hospitals.

Including UHC, LGH owns or manages five facilities; Our flagship, Lafayette General Medical Center, as well as Lafayette General Surgical Hospital, St. Martin Hospital and Abrom Kaplan Memorial Hospital. We enjoy clinical affiliations with: Opelousas General Health System, Abbeville General Hospital, American Legion Hospital in Crowley, Savoy Medical Center in Mamou, Franklin Foundation Hospital and, just days after our fiscal year ended, Bunkie General Hospital.

These smaller, rural hospitals have especially benefitted from being affiliated with LGH, Acadiana's largest health system. They are now in a better position to share information, increase purchasing power, consolidate services and cut costs. Electronic medical records and physician recruitment are two other vital components of our support to affiliates. And, in areas where specialists are seldom seen, LGH has leveraged our physician relationships to make those services accessible.

More importantly, affiliate hospitals have someone to turn to for aligning clinical protocols and analyzing best practices. Our partnerships give patients more top treatment options, all while staying home in Acadiana.

By integrating our services, Lafayette General Health is reaching more patients, reducing the variation in the way care is delivered and improving patient outcomes. We are also training tomorrow's doctors, today.

Lafayette General Health (LGH) is affiliated with LSU School of Medicine's Graduate Medical Education (GME) residency programs at Lafayette General Medical Center (LGMC) and University Hospital & Clinics (UHC), Lafayette's only two major teaching hospitals. The GME residents are medical school graduates who train for additional years to meet advanced standards to practice medicine. This teaching program offers structured educational experiences designed for an intern, resident and/or fellow that adheres to requirements of a particular specialty.

On any given day, there are close to 60 permanent residents at UHC, with an additional 20 or so who rotate through LGMC from anywhere between four to 12 weeks. The residents span a wide range of service lines, including Family Medicine, Internal Medicine, Otolaryngology (Ear, Nose & Throat), Ophthalmology, General Surgery, Obstetrics, Anesthesiology and Orthopedics.

Some studies have shown that teaching hospitals have better clinical outcomes than non-teaching hospitals.

What began as a community healthcare facility has grown into a thriving network that consistently delivers excellent care and outcomes for our community. GROWING Our flagship hospital, Lafayette General Medical Center, has been in operation since 1911 and is a 501(c)(3) not-for-profit corporation that does not pay out any revenue to shareholders as for-profits do.

TREATING Lafayette General Medical Doctors (LGMD) is a physician group consisting of 38 physicians (as of September 2013). LGMD directly operates and manages several medical practices including: Cardiology, Family Medicine, Hospitalists, Internal Medicine, Medical Oncology and Hematology, Neurosurgery, Orthopedics and Otolaryngology.

TEACHING Education is a fundamental value of Lafayette General Health. Both Lafayette General Medical Center and University Hospital & Clinics are major teaching hospitals—providing graduate medical education across many disciplines.

THRIVING In 2013, Lafayette General Health saw over 375,000 patient encounters, while the health system offered a charitable allowance in excess of \$100 million. Our property and assets total nearly \$400 million, employing approximately 3,000 staff.

LAFAYETTE GENERAL MEDICAL CENTER

Lafayette General Medical Center (LGMC) staffs a total of 377 beds and remains the largest full-service acute care medical center in Acadiana. LGMC operates the busiest emergency department in Acadiana, and handles the highest level of trauma in the region. In an effort to meet the needs of the community, LGMC boasts a Center of Excellence in Minimally Invasive Gynecology, a Center of Excellence in Neuroscience, an Accredited Cancer Center, an accredited Metabolic and Bariatric Surgery program and an Advanced Certified Primary Stroke Center.

GROWTH

Construction began on the \$52.5 million Emergency Department and Operating Room expansion and renovation project. The expansion will increase Emergency Department (ED) bed capacity from 31 beds to 45, and two new trauma rooms will be added. A new trauma elevator will add direct access from the emergency helipad landing area to the ED, ICU and surgery areas below. This will make LGMC the only facility with such direct access, helping to conserve precious, life-saving time in helicopter transports and other emergencies. The new surgery area will have 13 state-of-the-art operating rooms, in addition to three existing OB-GYN surgical suites in LGMC's Pavilion for women and children. Construction and renovation is expected to last all of fiscal year 2014, as well.

In non-construction news, LGMC launched a Certified Nursing Aide school to help prepare nursing students for Louisiana certification.



LAFAYETTE GENERAL SURGICAL HOSPITAL

Lafayette General Surgical Hospital (LGSH) is a 10-bed, short-stay hospital and medical office complex. It is part of a joint venture between Lafayette General Medical Center and local physicians. Offering a variety of specialized services and programs, the hospital proudly ranks in the 99th percentile in both employee and patient satisfaction surveys nationally.

GROWTH

LGSH has experienced tremendous growth over the last several years and saw its highest volume ever in the 2013 fiscal year. Many factors have contributed to the facility's increase, but none as important as additional physicians bringing their surgical cases to LGSH. Orthopedic cases grew by 140 percent due, in part, to Drs. Schutte, Yerger and Kennedy adding many surgeries. Dr. Durel (ENT) and Dr. Foreman (Glaucoma) also contributed heavily to the bulk of new business. Two new Ophthalmologists joined LGSH at the end of the fiscal year, as Dr. Ledoux welcomed Mary Summers, M.D.; and Dr. Bourgeois welcomed Maria Bidros, M.D. As always, LGSH relied heavily on its loyal physicians continuing to solidify its foundation.

UNIVERSITY HOSPITAL & CLINICS

University Hospital & Clinics (UHC) is a full-service, acute care hospital that serves Acadiana as its primary graduate medical education center by training residents and fellows, cultivating physicians for the future. The hospital is licensed for 116 beds and is Acadiana's primary safety net facility for the uninsured, underinsured and indigent population.

GROWTH

From late June through September, many strides were made at UHC in just a short period of time. A third operating room (OR) was opened and more OR time was added. Cardiology services were enhanced through a partnership with Cardiovascular Institute of the South (CIS) and cardiology clinic days increased, meaning more availability for patients. The Oncology Clinic was advanced through an affiliation with Cancer Center of Acadiana. Outpatient diabetes nutrition education classes began on a monthly basis.

Lafayette General Health invested \$750,000 into University Hospital & Clinics for facility upgrades and new equipment including: a nuclear medicine camera that allows for more cardiac testing, along with other nuclear medicine studies; a C-arm for surgical imaging; a Stress EKG Unit to perform cardiology studies; a new ultrasound unit; and a new Auditory Brainstem Response testing system that allows for inner ear and brainstem studies without sedation.

ST. MARTIN HOSPITAL

St. Martin Hospital (SMH) is a critical access hospital maintaining inpatient acute and skilled nursing rehabilitation units, as well as a staffed 24-hour Emergency Department. Emergency visits at SMH exceeded over 15,000 in the 2013 fiscal year, an increase of 11 percent from the prior year. St. Martin Hospital features the only emergency room available in all of St. Martin Parish. The hospital features a new Outpatient Services wing and a newly renovated Emergency Department. SMH spent over \$2.5 million during the year on improving its facility. These new areas offer enhanced services and convenience for the people of Breaux Bridge and all of St. Martin Parish.

GROWTH

SMH held an official ribbon-cutting ceremony on May 15, 2013, opening its new Outpatient Services wing. The 5,712 sq. ft. addition includes a new outpatient registration area and waiting area, newly expanded imaging, laboratory, respiratory and infusion clinic, and an employee break/dining area.

SMH then began to renovate its Emergency Department (ED), adding two Fast Track rooms, a nursing station, a registration and waiting area, a physicians' lounge, a sub-waiting/triage area and an employee break room. Once completed, the project would double the size of the previous ED.

QUALITY

Several years ago, Lafayette General Medical Center engaged its ICU and Respiratory Therapy staff and empowered them with improved processes that would help eliminate ventilator associated pneumonia (VAP).

VAP is caused by bacteria invading the lungs while the patient is on a ventilator. The bacteria leads to infection resulting in pneumonia. Patients acquiring pneumonia while hospitalized will need more medications and a longer stay, increasing the cost of care.


Prevention of VAP involves limiting exposure to resistant bacteria and there are a variety of strategies to limit infection while intubated. Resistant bacteria are spread in much the same ways as any communicable disease.

The staff at LGMC chose to follow key components recommended by the Institute for Healthcare Improvement (IHI), which include:

- Slightly elevating the head of the bed (30-45 degrees)
- Daily assessment for readiness to remove ventilator while reducing sedation
- Administering daily medications to reduce stomach acids in order to stop reflux
- Regularly using blood clot prevention protocols
- Maintaining a strict oral care schedule and process in order to reduce bacteria in the mouth

All of these components have been addressed on every ventilated patient, every time, and this process improvement has led to no ventilator associated pneumonia at LGMC since January 2010. Lafayette General ranks alongside the 25 percent of hospitals nationally with no reported cases of VAP.







GROWTH

As Fiscal Year 2013 ended, and Fiscal Year 2014 began, significant growth continued to be realized around the health system.

LGMC The massive ED/OR project remains on schedule to be completed in 2014. The hospital will then enter into the first phase of a long-term master plan to prioritize growth. Designs are in the works and some bold new ideas will unfold. Possible items include upgrading the Cath Labs, expanding the doctors' lounge, enlarging the chapel and remodeling the Bayou Bistro cafeteria and its kitchen facilities.

LGSH Lafayette General Surgical Hospital's surgical volume reached nearly 5,000 cases in the past fiscal year, and is accelerating at a rapid pace. In 2014, new decontamination and sterilization areas will be constructed which will provide added safety equipment to accommodate the growing volume of surgical instrumentation and provide more efficiencies for processing.

OCSP In 2014, Lafayette General Medical Center is partnering with Lafayette Surgical, LLC to develop a four-room ambulatory surgery center called Oil Center Surgical Plaza (OCSP). OCSP will be located on the second floor at 1000 West Pinhook Road.

UHC Just a few short months after the close of the 2013 fiscal year, UHC re-opened the Pediatrics Clinic and reintroduced Inpatient Medical Detox.

A new electronic medical records program is expected to launch in late spring/early summer 2014. Much needed elevator maintenance, HVAC upgrades and plans for an emergency department expansion are all in motion. Aramark anticipates expanded cafeteria hours and an improved menu.

The \$52.5 million expansion (pictured) at LGMC adds approximately 95,000 square feet of space, including a trauma elevator, 13 state-of-the-art operating rooms, 50 percent more ER bed capacity and a six-level parking garage.

SMH After finishing its Emergency Department renovations in 2014, St. Martin Hospital will be looking to renovate other inpatient areas of the hospital. These renovations will help increase capacity for inpatient care and continue to expand outpatient service capabilities.

LGMD Lafayette General Medical Doctors is revolutionizing the hospitalist program with the addition of a nocturnist, an overnight hospitalist to offer 24-hour service and distributed workload. New physicians continue to be added, including Blaine Walton, M.D., who will serve as an orthopedic traumatologist, an orthopedic surgeon specializing in trauma. The group is also embarking into Patient-Centered Medical Home care that uses a team-based approach to coordinate care through evidence-based medicine to maximize patient benefits and efficiency.
