





 ${f I}$ come ${f I}$ ppopotamo.





 ${f O}$ come ${f O}$ rso.



 ${\bf Q}$ come ${\bf Q}$ uaglia.





 ${\bf T}$ come ${\bf T}{\rm artaruga}.$





The licenses for most software and other practical works are designed to take away your freedom to share and change the works.
