Data analysis Fiji (with ImageJ 1.52p) and GNU Octave (5.1.0) custom code was used to analyse cryoEM data. Code was deposited on Zenodo ([doi.org/10.5281/zenodo.4642359](https://doi.org/10.5281/zenodo.4642359)). 3D reconstructions were prepared with Imaris 9.2 (Bitplane). All molecular dynamics simulations were carried out with the publicly available GROMACS software ([www.gromacs.org](http://www.gromacs.org)).
