

**FORM FOR AMENDMENT OF SUBSCRIBED CHANNELS  
AND SUBSCRIBED BOUQUETS  
(FOR DIRECT TO HOME OPERATOR)**

This amendment agreement (“**Amendment Agreement**”) is made on this \_\_\_ day of \_\_\_\_\_, 20\_\_ by and between:

TODAY NETWORK LIMITED**, a company incorporated and registered under the Companies Act, 1956, having its GSTINs 07AABCT0424B3Z0 (Delhi with Address at First Floor, F-26, New Delhi, Delhi 110001), 19AABCT0424B1ZX (West Bengal with Address at 52, Jawahar Lal Nehru Road, 4th Floor, Kolkata, West Bengal 700071), 36AABCT0424B1Z1 (Telangana with Address at 6-3-885/7/B, Somajiguda, Hyderabad, Telangana 500082), 27AABCT0424B1Z0 (Maharashtra with Address at 101-102, First Floor, Trade Avenue Building, Dr. Suren Road, Opp. Landmark Building, Chakala, Andheri East Mumbai 400093) and 29AABCT0424B1ZW (Karnataka with Address at 116-118, 1st Floor, 12, Richmond Tower, Bangalore, Karnataka 560025) bearing PAN AABCT0424B, and having its registered office at F-26, First Floor, Connaught Circus, New Delhi -110001 (hereinafter referred to as “**TVTN**”, which shall include its successors and assigns) through its authorized agent **STAR INDIA PRIVATE LIMITED**, a company incorporated and registered under the Companies Act, 1956 and having office at Vatika Business Centre, Thapar House, Gate No. 1 Eastern & Central Wing, Third Floor, 124, Janpath, New Delhi – 110 001, bearing PAN No. AAACN1335Q and registered office at STAR House, Urmi Estate, 95 Ganpatrao Kadam Marg, Lower Parel (W), Mumbai, 400013, Maharashtra (hereinafter referred to as “**STAR**”, which shall include its successors and assigns);

having GSTIN and headend as detailed in **Annexure B** to the SLA (defined below) through its [Authorized Signatory / Sole Proprietor/ Managing Partner / Partners \_\_\_\_\_ (hereinafter referred to as the “**DPO**”, which expression shall, unless repugnant to the context or meaning thereof, be deemed to include the heirs, executors and administrators in the case of a sole proprietorship; heirs, executors and administrators of the last surviving partner in the case of a partnership firm; its successors, affiliates and permitted assigns).

TVTN and the DPO are each referred to herein as a “**Party**” and collectively as the “**Parties**”.

**WHEREAS**

A. The DPO has entered into a Subscription License Agreement dated \_\_\_\_\_ (“**SLA**”)

whereby the DPO is granted the non- exclusive right by TVTN to Distribute the Subscribed Channels as set out in the SLA, to its subscribers in Territory for the Term as stated in SLA;

- B.** The DPO now intends to amend the list of Subscribed A-la-carte Channels and/or Subscribed Bouquets. Therefore, the DPO has requested TVTN through its authorized agent STAR for change in the Subscribed A-la-carte Channels and/or Subscribed Bouquets. The Parties have agreed to amend the terms of the SLA on account of request made by DPO to amend the Subscribed A-la-carte Channels and/or Subscribed Bouquets (as defined in the SLA), in accordance with the terms and condition set out hereinafter. The Parties agree that the amendment to the Subscribed A-la-carte Channels and/or Subscribed Bouquets shall be given effect from the Effective Date (as defined below).

**NOW THEREFORE IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES THAT:**

**1. Subscribed Channels**

From the Effective Date, the Subscribed Channels shall mean and include the A-la-Carte Channels of TVTN and/or Bouquets of TVTN which are subscribed by the DPO by specifically mentioning Yes/No against such A-la Carte Channel /Bouquets of TVTN listed in Schedule I to this Amendment Agreement subject to approval and receipt of requisite IRD (as defined in the SLA) from TVTN or its authorized agent STAR at the sole discretion of TVTN.

**2. Effective Date**

The Effective Date for this Amendment Agreement shall mean \_\_\_\_\_ or the date on which TVTN through its authorized agent STAR executes this Amendment Agreement whichever is later.

**3. Term**

This Amendment Agreement shall be valid from the Effective Date and shall be co- terminus with the SLA.

**4. Miscellaneous**

4.1 This Amendment Agreement together with the SLA constitutes the entire agreement between the Parties relating to the subject matter. Save for the specific amendments set out in this Amendment Agreement, the SLA shall remain in full force and effect and shall be read in conjunction with these presents and shall be enforced as if the provisions of these presents were incorporated therein. The terms and conditions of the Amendment Agreement, as amended pursuant to this Amendment Agreement from the Effective Date, shall be valid and binding on the Parties thereto on and from the Effective Date of this Amendment Agreement.

4.2 In this Amendment Agreement, the terms used in capital case but not defined herein shall have the meaning assigned to them in the SLA.

4.3 The Parties agree and affirm that all other terms and conditions of the SLA shall apply mutatis mutandis to this Amendment Agreement.

4.4 This Amendment Agreement, read with the SLA supersedes all prior discussions, information, writings, memoranda and documents exchanges and agreements between the Parties with respect to the subject matter of this Amendment Agreement.
