#### Raisin US LLC Privacy Policy

Raisin US LLC ("Raisin US," "us," "our," "we") realizes the importance of protecting personal information in line with applicable law and to meet our customer expectations. We are committed to securing and protecting the privacy of our users' personal information, as well as the personal information of all consumers who visit Raisin.com/en-us (the "Website"). This privacy notice explains how we may collect, use, and share personal information from or about you on Raisin.com/en-us.

#### I. Information Collected

- (3) Information collected by cookies: In order to optimize this Website and our services, we use Google Analytics, a web analytics service provided by Google, Inc. Google Analytics uses "cookies," which are small text files that are placed on your device to capture information about your activity on Raisin.com/en-us. Cookies are uniquely assigned to you and can be read only by a web server in the domain that issued the cookie to you. We, as well as third-party vendors including Google, may use first-party cookies (such as the Google Analytics cookie) to inform, optimize and serve content based on your visit to Raisin.com/en-us. You have the ability to accept or decline cookies by changing the settings in your web browser. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies. **Business Transfers:** We may transfer or share a copy of personal information about you in the event of a business reorganization or transition, such as a merger, acquisition, or the sale of all or a portion of Raisin US' assets.

As Required by Law or to Protect Our Rights and Interests or for the Protection of Others: We may disclose information to comply with applicable laws and regulations, such as to respond to a subpoena or similar legal process, to protect against misuse of Raisin.com/en-us, to protect or enforce our rights and interests or to protect the rights, property or safety of other users of Raisin.com/en-us or the public and to otherwise cooperate with law enforcement or regulatory authorities.

# IV. Marketing, Tracking and Analytics

By using Raisin.com/en-us, or providing us with any information, you consent to the collection, processing, maintenance and transfer of such information in and to the United States and other applicable countries in which the privacy laws may not be as comprehensive as or equivalent to, those in the country where you reside and/or are a citizen. Raisin US takes steps to provide an adequate level of privacy protection for Personal Information it receives in the United States from the European Union and Switzerland.

# VII. Children's Privacy
