Mongabay awarded ten special reporting initiative (SRI) prizes amounting to more than \$150,000 in support of journalists to investigate key issues. The program produced over 50 in-depth and high-quality news articles published on Mongabay.com as well as numerous articles published in major media outlets such as the BBC World Service, Lucky Peach Magazine, and Scientific American.

The program supported over 15 professional journalists to become issue-area experts in their specific SRI topic.

Since its launch in May 2012, Mongabay-Indonesia has become one of the leading environmental web sites in Indonesia and the dominant place for reporting on the intersection of social and environmental issues. More importantly, the site has become well known in key decision-making and policy sectors, including the palm oil sector, government agencies like USAID and NORAD, and other important civil society groups. The site as even garnered attention at the highest levels of the Indonesian government.
