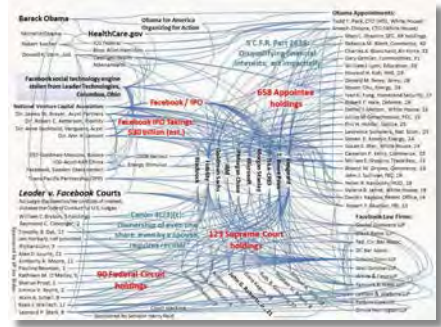

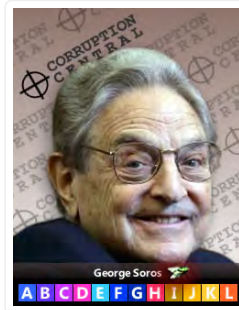

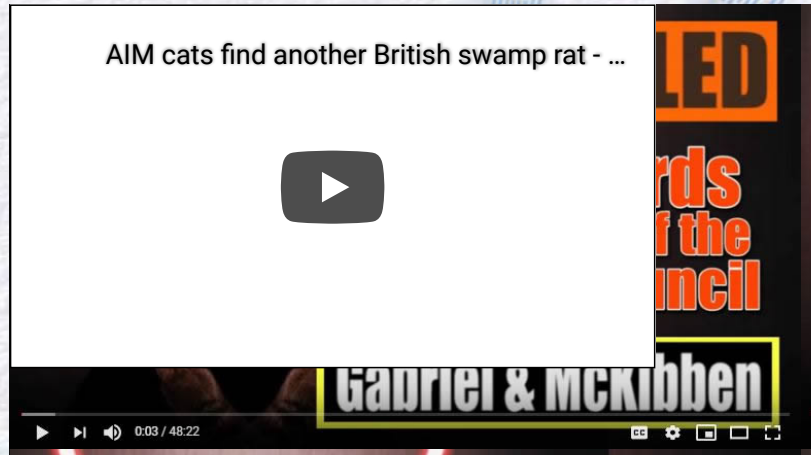


Fig. 4—Douglas Gabriel, Michael McKibben. (Oct. 25, 2018). AIM cats find another British swamp rat - YUCK! American Intelligence Media, Americans for Innovation. <https://youtu.be/lAFp3-xMxmA> | (Raw *.mp4 video file).

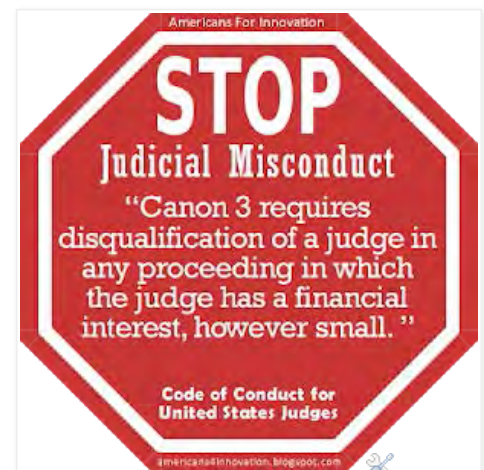

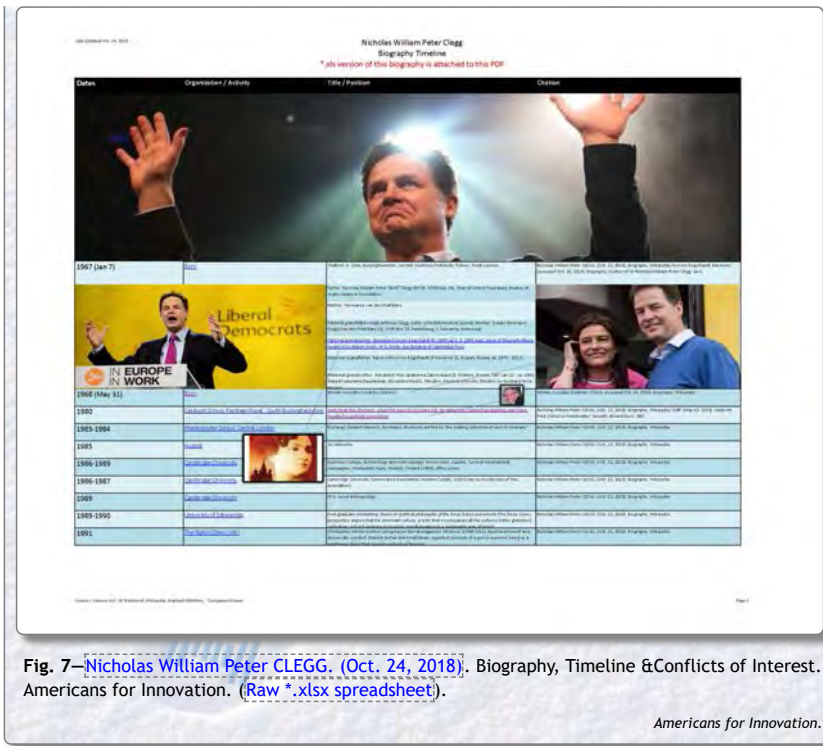

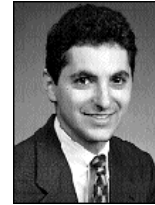

Judge Leonard P. Stark, U.S. District Court of Delaware, trial judge in *Leader Techs, Inc. v. Facebook, Inc.*, 770 F. Supp. 2d 686 (D.Del. 2011). Judge Stark heard his jury foreman admit that the jury made the on-sale bar decision *without any evidence other than speculation*, and yet he supported that verdict anyway. Just months before trial, Judge Stark allowed Facebook to add the on-sale bar claim after the close of all fact discovery and blocked Leader from preparing its defenses to this new claim. Judge Stark allowed the claims despite Leader's prophetic argument that the action would confuse the jury and prejudice Leader. He also permitted the jury to ignore the *Pfaff v. Wells Electronics, Inc.* test for on-sale bar, even after instructing the jury to use it. (See that [Jury Instruction No. 4.7 here.](#)) He also contradicted his own instruction to Leader to answer Interrogatory No. 9 in the present tense (2009), then permitted the jury to interpret it as a 2002 admission as well. Papadopoulos: 'I have absolutely no contacts whatsoever in Russia'

After testifying in Congress on Thursday, George Papadopoulos, a key figure in special counsel Robert Mueller's Russia investigation, said in a television interview Friday morning he has evidence that he was framed.

"I believe there was tremendous misconduct on the government's behalf regarding my case," he said in an interview with "Fox and Friends."

Papadopoulos, who was a volunteer foreign adviser for the Trump campaign, said that based on new information he learned from congressional investigators, which he can't publicly disclose, he is considering withdrawing his plea of lying to the FBI.

He served only one day of a two-week sentence, but he said he would press the case because of the precedent it set.

Papadopoulos explained that there was a misunderstanding that he was a Russia insider.

"I have absolutely no contacts whatsoever in Russia," he said. "I've never been to Russia. I have no Russian friends."

Boasberg, which required the State Department to complete processing by September 28, 2018, the remaining documents of the 72,000 pages recovered by the FBI in its investigation into Hillary Clinton's illicit email server. These new classified and other emails appear to be among those that Clinton had attempted to delete or had otherwise failed to disclose.

Voters casting their ballots early in Texas claimed this week that when casting Democratic or Republican straight-ticket ballots, voting machines in at least 80 counties in the Lone Star State flipped their votes to the other party in key midterm races, including the high-profile competition between incumbent Sen. Ted Cruz and his Democratic opponent Beto O'Rourke.

The Texas secretary of state's office on Friday said that there have been issues reported with Hart eSlate voting machines, which are used in approximately 30 percent of counties statewide. The machines feature a wheel for selecting candidates and buttons to move from screen to screen.

But the secretary of state's office said the issues were not caused by the voting machines, but by voters themselves.

"The Hart eSlate machines are not malfunctioning, the problems being reported are a result of user error – usually voters hitting a button or using the selection wheel before the screen is finished rendering," said Sam Taylor, spokesman for the office of Secretary of State Rolando Pablos.

The Houston Chronicle reported that Democratic voters claimed the machines indicated that they were about to cast a vote for Cruz, when they originally intended to choose O'Rourke. Several people said they were able to get help from employees at polling places in order to change their vote back.

Facebook claimed that these pages had "broken our rules against spam and coordinated inauthentic behavior." However, sites like The Free Thought Project were verified by Facebook and widely recognized as legitimate sources of news and opinion. John Vibes, an independent reporter who contributed to Free Thought, accused Facebook of "favoring mainstream sources and silencing alternative voices."

In comments published here for the first time, a neoconservative Washington insider has apparently claimed a degree of credit for the recent purge — and promised more takedowns in the near future.

Among them are nationals of Bangladesh, a south Asian Islamic country that’s well known as a recruiting ground for terrorist groups such as ISIS and Al-Qaeda Indian Subcontinent (AQIS). “There are lots of dirty businesses associated with this,” Guatemalan authorities told Judicial Watch. “There’s lots of human trafficking.”

The Inspector General expressed concern about “potential compromise to whistleblower confidentiality” and “chilling effect”

Newly-declassified documents show the CIA intercepted sensitive Congressional communications about intelligence community whistleblowers.

The intercepts occurred under CIA Director John Brennan and Director of National Intelligence James Clapper. The new disclosures are contained in two letters of “Congressional notification” originally written to key members of Congress in March 2014, but kept secret until now.

In the letters, then-Intelligence Community Inspector General Charles McCullough tells four key members of Congress that during “routine counterintelligence monitoring of Government computer systems,” the CIA collected emails between Congressional staff and the CIA’s head of whistleblowing and source protection. McCullough states that he’s concerned “about the potential compromise to whistleblower confidentiality and the consequent ‘chilling effect’ that the present [counterintelligence] monitoring system might have on Intelligence Community whistleblowing.”

One year on, St Catherine's College Oxford still holds investments in two funds managed by Colter International, the private equity firm in the offshore financial centre of Guernsey, that were revealed by The Guardian last year to have past links to offshore oil and gas exploration.
