48. According to the clerk's notes, most of the submissions made by the CPS advocate related to the alleged terrorist background rather than the offences charged. The notes record that the advocate said that Raissi had instructed four of the five hijacker pilots. He had failed to disclose material information in order to get a pilot's licence. (In fact, as we have said, he had had a licence since 1997 but the law required him to have an annual medical certificate. The difference is perhaps semantic.) It was said that there were pages missing from his log book and that those pages related to the time that he was training the dead pilots, with whom he had conspired. As we shall see, this allegation relating to the missing pages was withdrawn in late November/early December 2001 when it was realised, so it appears, that someone had taken the log book apart for copying and had reassembled it in the wrong order.
49. According to the notes, the defence advocate protested: "These charges are a device". No formal application for bail was made.
50. That brief account from the notes was supplemented for the purposes of these proceedings with a chronology prepared on behalf of the appellant. We have no reason to think that it is inaccurate. In respect of the hearing on 28 September, it says:

51. We have seen a schedule of media stories which set out similar remarks said to have been made by Ms Sambir or Sambei (as her name is spelt in the recently disclosed background note to which we have referred). According to the background note, Ms Sambir denies having spoken to the press.
52. We have not been shown any contemporaneous document which supports the allegation made by the CPS that Raissi was involved in 9/11. The letter dated 17 September had said no more than Raissi may have been involved. Notwithstanding his "de-arrest" on 28 September, it was being said later that day that he was involved. On the face of the documents we have seen, there does not appear to have been any justification for the submissions advanced by the CPS on this first occasion.
53. According to the chronology, the appellant's advocate submitted that the allegations were not proved, that there was no justification for keeping him in custody and that the arrest was "only a device".
54. At the conclusion of the hearing on 28 September, the appellant was detained in custody.

The FBI wants Raissi, 27, to be extradited to the US for questioning over his alleged role in the attacks, which left more than 6,000 dead.

Prosecutor Arvinda Sambir gave a list of devastating charges which put him at the heart of the terror plot. She claimed he was the lead instructor for four of the hijackers, including the man who seized the controls of American Airlines Flight 77 from Washington to Los Angeles and skillfully steered it into the Pentagon.

Prosecutors say that the warrant from the US was for obtaining a pilot's licence dishonestly - because he did not declare a previous conviction for theft or that he had had surgery on his knee. Both would have barred him from applying for a licence. Further charges are expected. One source said: 'It is no secret that conspiracy to murder is being looked at.'

Sambir said that when Raissi was arrested by British police, logbooks were found in his house with crucial dates missing. Further details about Raissi were also emerging in the US yesterday, including the disclosure that he received a US commercial pilot licence in January 1999, with a rating to fly a Boeing 737. Two days later he was certified a ground instructor, and in March 1999 received a license to be a flight instructor.

He said the FBI and intelligence services were 'not just looking at the al-Qaeda network' but 'a series of networks all over the world'. Among them - it is now becoming clear - is the network commanded by Beghal.

U. S. authorities began extradition proceedings in a London court Friday against a British-based Algerian pilot suspected of being the flight instructor for four of the 19 hijackers who attacked U.S. landmarks Sept. 11.

Investigators consider the arrest a breakthrough in the search for living co-conspirators to the New York and Pentagon attacks.

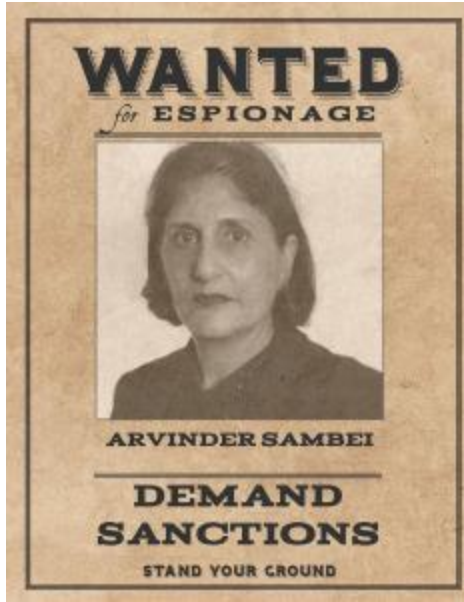
Lotfi Raissi, 27, the first of dozens of suspects arrested throughout Europe to be officially linked to the U.S. hijackings, was ordered held without bail after a British prosecutor told the court that Raissi may have helped the hijackers acquire their piloting skills.

"What we say is that he was in fact a lead instructor for four of the pilots responsible for the hijackings," said the prosecutor, Arvinda Sambir. "He was in the background to facilitate training of these pilots. His job was to ensure the pilots were capable and trained."

Sambir said Raissi's mission related to American Airlines Flight 77, the plane that crashed into the Pentagon. It was unclear whether he was suspected of training hijackers on other jets.
