Supplemental Form: Marijuana Cultivation Plan

What is this form?

An operating plan is required for all recreational marijuana applications. Under [OAR 845-025-1030 \(4\) \(g\)](#), applicants seeking a producer license must submit information about their growing operation.

This **Supplemental Form** is required for all applicants seeking a producer license. Applicants for a producer license will also need to submit a **Marijuana Canopy Area Designation** form. If designating a new or changed canopy area for an existing license, you do not need to submit this form, and will only need to submit the **Marijuana Canopy Area Designation** form. Producer applicants must also submit an **Electricity and Water Usage** report or estimate and provide proof of water rights.

What additional information is required for producers?

Applicants for a producer license must provide information for the following:

- Proposed canopy tier, size, and initial designated canopy area
- Whether the operation is indoor, outdoor, or mixed
- Type of growing media
- Descriptions of all equipment used

Section 2 – Medical Grower Opt-In

Under [OAR 845-025-1115 \(1\)\(c\)\(B\)\(i\)](#), the Commission must deny an application for a producer license when the proposed premises is at the same physical location or address as a medical marijuana grow site registered under ORS 475.304 unless one of the following conditions is met:

- The applicant applies as a “Medical Marijuana Grow Site Opt-In” and meets all requirements of the opt-in.
- The medical marijuana grow site registration is surrendered prior to receiving the recreational marijuana Producer license.

Note that this rule does not prevent a medical marijuana grower from applying for or holding a Producer license at a **different** physical location and address.

The medical marijuana registration will be surrendered prior to receiving a Producer license from the OLCC **and**

All marijuana items will be removed from the premises prior to licensure. (Continue to Section 3)

(Selecting this option may result in the denial of the application. Continue to Section 3.)

Section 3 – Proposed Canopy Size and Tier

Identify whether the business is seeking licensure for indoor production, outdoor production, or mixed (indoor/outdoor) production, and the proposed maximum canopy size of mature marijuana plants.

- “Outdoor Production” is the production of marijuana on clear or open ground or the production of marijuana in a greenhouse, hoop house, or similar non-rigid structure that does not use any artificial lighting on mature marijuana plants.
- “Indoor Production” is the production of marijuana using artificial lighting on mature marijuana plants -OR- any production of marijuana other than outdoor production.
- For mixed production, specify the maximum square footage for both indoor and outdoor you expect to use in the license year.
- **A producer who uses mixed production cannot change the ratio of licensed indoor to outdoor production except at renewal. This means you may not reduce the square footage of outdoor production to increase the square footage of indoor production or vice versa except at renewal.**

- Demonstrating that water will be provided by a public or private supplier; or
- Providing proof from the Oregon Water Resources Department that the water to be used for production does not require a water right.
