NEIGHBORHOOD CLEAN UP DUMPSTER RESERVATION AND USE AGREEMENT

OUR CONTRACTOR DELIVERS DUMPSTERS 7am - 5pm. THERE ARE NO SCHEDULED DELIVERY TIMES

RESERVATION INFORMATION

- Reservations from November 1st – March 31st are required to be placed entirely on private property during that time and cannot impede or obstruct sidewalks or roadways. The dumpster is approximately 8’ wide x 22’ long x 5’ tall.
- Reservations can be made in person or by submitting the form by fax or email. **You will be contacted to confirm your reservation.**
- Dumpsters may only be scheduled for the same residence once every 60 days (subject to availability).
- Dumpsters may be scheduled year-round. Please provide 48 hour notice for cancellations. Any resident found to be abusing this service may be subject to suspension at the discretion of the City.
- For disposal of green waste (grass clippings, tree limbs, shrubbery, etc.) complete the green waste dumpster form.

RULES AND LIABILITY

To receive the maximum benefit of the City-wide service and to protect public health and welfare, the undersigned agrees to abide by the following rules and accepts the terms and conditions as stated:

1. Dumpsters are for residential use only and the property must have an open and current West Jordan garbage utility account. The dumpsters shall not be used for business or commercial use of any kind.
2. Dumpsters shall only be used for yard debris (tree limbs, shrubbery, grass clippings, etc.), building materials, household items including furniture and limited appliances (anything with Freon is not allowed).
3. **Residential electronic waste such as televisions, computers, printers, cell phones and other similar devices** are accepted at no charge by the Trans-Jordan Landfill or at a community event and are **NOT allowed** in the dumpster. The following items are also **NOT allowed** in the dumpster: **Mattresses, box springs, road ties, concrete, dirt, rocks, toxic, hazardous, flammable materials (pesticides, herbicides, solvents, chemicals, paints, motor oil, gasoline, etc.), tires, batteries, dead animals, liquid or septic loads. Refrigerators, tanks, drums and barrels of any kind are also NOT allowed.** For information on proper disposal of such household hazardous wastes, please contact the Trans-Jordan Cities Landfill at 801-569-8994.
4. Dumpsters are intended for neighborhood use. Prohibited materials are unsafe to dispose of and expensive to remediate from a neighborhood dumpster. The West Jordan Public Works Department must be notified immediately if a person is seen disposing of prohibited materials. If a person is found in violation of the prohibited materials, the violator may have current and future dumpster reservations terminated and/or denied for the resident and property. Violators will be invoiced for the City’s administrative costs and costs of disposal for any unacceptable items.
5. **Dumpsters shall not be overloaded.** Residents using the dumpsters are required to clean up any spillage.
6. The City and the Solid Waste Contractor are hereby released from any and all claims for damages resulting from the City’s or the Solid Waste Contractor’s equipment or personnel being on or causing damage to private property to deliver or remove the requested dumpsters, including but not limited to; any damage to any pavement or subsurface material on any route reasonably necessary to perform the services herein contracted. The City and the Solid Waste Contractor are hereby released from any and all claims for all bodily injury as a result of dumpster use or location of dumpster/s. The undersigned shall be responsible for any and all damage to the dumpster while the dumpster is located on the undersigned’s property or while the undersigned is using the dumpster.
7. All court costs and attorney’s fees incurred in the event of legal action to enforce any term or condition of this agreement will be the responsibility of the undersigned.
