Statement by Robert O. Young CPT, MSc, DSc, PhD, ND

I am making this statement because it has come to my attention that certain people have published an accusation of plagiarism against me, particularly those referenced in this article: Important information regarding The Scientists' Club work/Orwell City, Sep 1, 2021 and this video, https://rumble.com/vlxne7-important-information-regarding-the-scientists-club-work.html /August 31, 2021/

This is a regrettable accusation and one which is unfounded and inaccurate. My work in scientific analysis with electron microscopy of vaccines, the blood of the vaccinated, bio-effects of EMF radiation, filterable bacteria now called viruses, bacteria, mold, pleomorphism, and the acidic causes of disease dates back to the '80s; my publications in peer-reviewed journals in this field date back to the '90s and can be readily verified, as also my educational background, credentials, and academic and scholarly accomplishments. I was the first scientist to reveal the effects of EMF made visible in the blood through light and electron microscopy, and the first to describe and publish on pH balance and alkalized tissues as primary key to health, subjects foreign to conventional medical views on disease and health, for which I have long been attacked, on an ad hominem basis, in efforts to deflect attention from the work and findings of true health I have made and sought to educate the world on. I am glad to report that today the larger scientific community has come to fully recognize my work, and that scientific papers on these subjects are now being published everyday. I refer you to my statement "Message to Critics" at my website, which addresses these matters more fully.

Regarding the electron microscopy, phase contrast, dark field and bright field optical microscopy, and X-ray dispersive spectroscopy findings of Graphene Oxide, Aluminum, PEG capsids, parasites and more in 4 COVID Vaccines which I addressed in my article Scanning & Transmission Electron Microscopy Reveals Graphene Oxide in CoV-19 Vaccines/August 20, 2021, and which I have recently spoken about in interviews to disseminate the important findings of these toxins in the Pfizer, Moderna, AstraZeneca, and Johnson & Johnson vaccines, it has been my intention from the beginning to educate my readership on the latest scientific analyses of these vaccines, which I have information about. The sources of the information, micrographs, and spectrographs in the article are fully referenced, to the extent that they have been shared with me; the article includes my own micrographs, particularly of the blood of vaccinated patients, showing Graphene Oxide. Please note that I have 59 references to the work presented in my article, including to my own previous work.

As I have explained in Newsbreak 133 at Ramola D Reports, the work I have presented in this article (Scanning microscopy...) is the work of a group of scientists, many of whom have not wished to share their name and participation. I have not included their names in references therefore in honor of their requests for privacy and anonymity. It has been my understanding they did not wish their names to be published. It is now clear that the group has published online their report, https://www.medicdebate.org/files/Scientist%20club12.pdf, which has been referenced by the La Quinta Columna in their video and article, which I have been aware of but chosen not to link or reference in my article reporting the group findings, in deference to their then-stated desire for anonymity. If some or all of these scientists wish to be known and named, I will be glad to name them to honor their work: my intention always has been to reveal the

findings to humanity, and I am not taking credit for their work. Regarding the La Quinta Columna scientists such as Dr. Ricardo Delgado who has made these accusations against me without considering the facts, I do not know them, nor did I know of their report until recently (although I knew of the images they had published from online conversations with other scientists and used them in my article), when I added in the correct citations for some of the images in my article linking back to their report, and in Reference No. 4 (Muestra RD1, La Quinta Columna Report, June 28, 2021; Graphene Oxide Detection in Aqueous Suspension; Delgado Martin, Campra Madrid.)

My intention has always been and still is to educate, to bring knowledge and learning to people, to give people the tools to understand more and learn more. There is no plagarism here, and any scientist wishing further accreditation on these group findings to be included in my article has only to ask me.

Finally, I will restate what I have noted in my "Message to Critics" as I stood in the pulpit at the Martin Luther King Jr Memorial Chapel in Atlanta, Georgia on the campus of Morehouse College, at the very place Martin Luther King had once stood, where I was blessed to have the opportunity to share my own message of health to add to their powerful messages of freedom, love and light, to the world, which has now blessed the lives of millions around the World.
