Miscellaneous

- Accountability finalized reporting year 2015 detail reports are available which show comparison metrics on each college and system-wide totals.
- Online Education Survey The Board of Governors (BOG) for the State University System (SUS) has
 asked the Florida College System (FCS) to assist in learning more about online education in Florida.
 Survey responses were coordinated with Institutional Research and Online Learning Services.
- <u>Data Element Dictionary Updates</u> CCTCMIS requested assistance from the colleges to review, clean up, and update where applicable the data element dictionaries. The first is the Student Database Guide since it is the most comprehensive and influences the most reporting systems. The majority of the interaction would be through email with a conference call once per month.
- <u>Perkins</u> several webinars are available (2016-17 Funding Opportunities, <u>Program of Study Registration</u>, <u>Program of Study PowerPoint</u>).

Florida Education Identifier (FLEID) – Fact Sheet, Technical Assistance

- A quick reference document with contact information, file naming conventions, and common errors was distributed.
- There was discussion about including the FLEID on high school transcripts.

IPEDS - Handout

- <u>IPEDS Human Resources Survey</u> differences from the Annual Personnel Report (APR);
 - \circ Excludes Gender (DE0035) = Unknown (X);
 - Excludes Occupational Activity Code (DE0130) = Student Assistants (39);
 - Excludes Leave (DE0170) = Leave of Absence Without Pay (3);
 - o Temporary (DE0080=Y) and Full-time (DE0090=F) are include in part-time.
- <u>IPEDS Outcome Measures Survey</u> fatal error occurs when eight year exclusions are less than six year exclusions. This is valid because students who were excluded in year six but received an award in year seven or eight are kept in the cohort. Contact the IPEDS helpdesk for an administrative override.
- <u>IPEDS Graduation Rate Survey</u> Bachelor's or equivalent degree-seeking subcohort error. Please provide the following explanation: The Florida College System is a 2 + 2 system and therefore will not have a Bachelor's cohort.
- <u>Miscellaneous:</u> Proposed changes include the addition of Pell Grant data to the Graduation Rate and Outcome Measure Surveys and providing additional guidance on the appropriate classifications for Non-instructional Occupational Categories.
