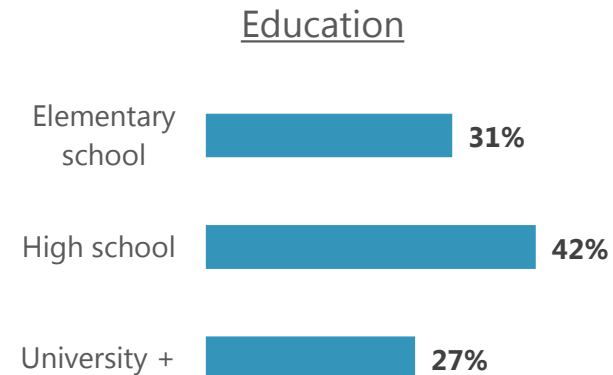
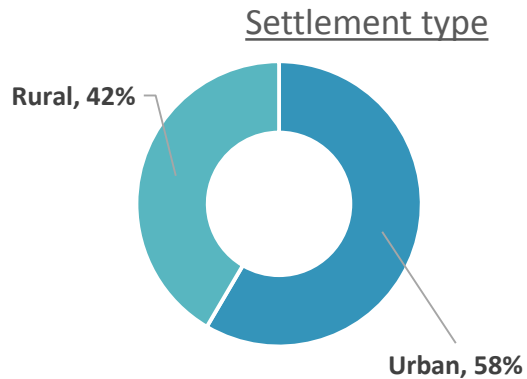
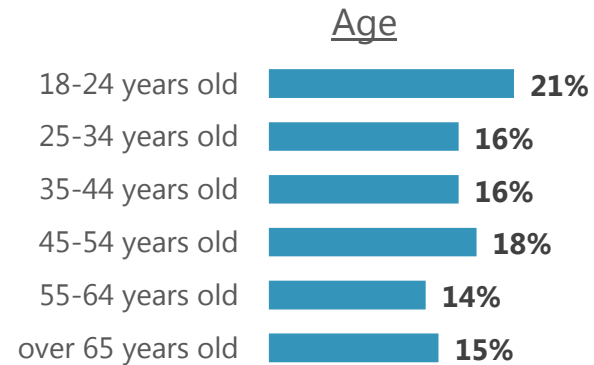
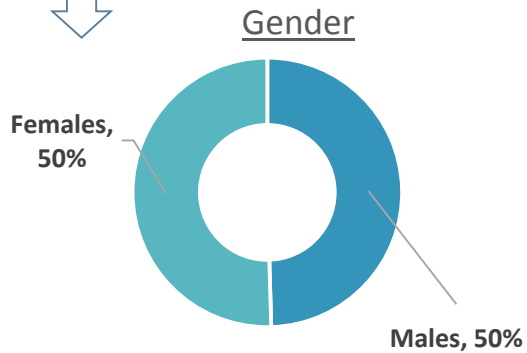
● Nr. of Interviews per region

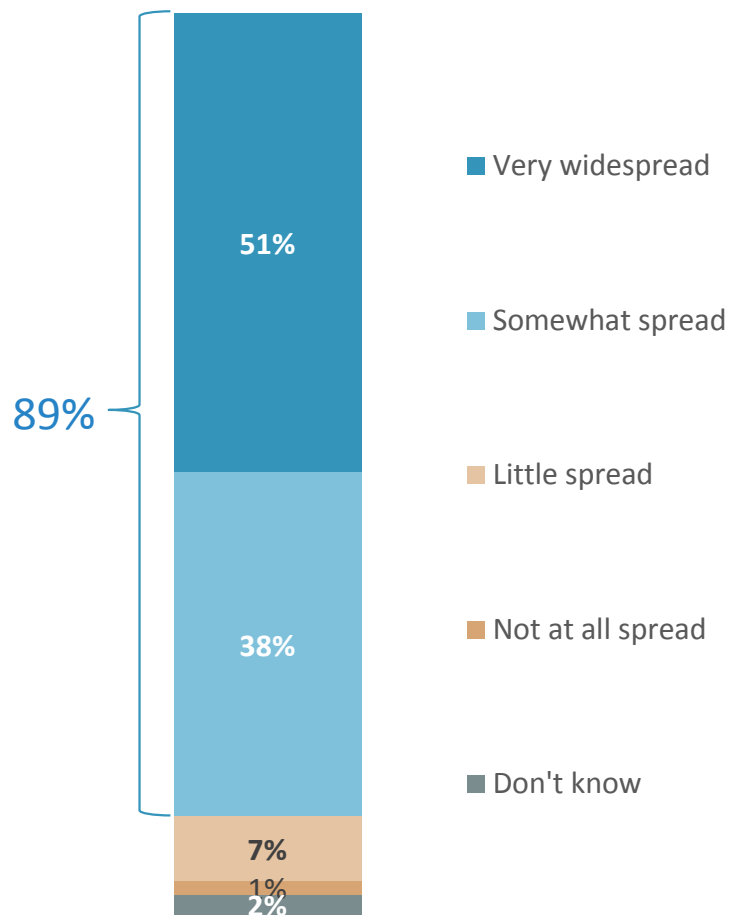




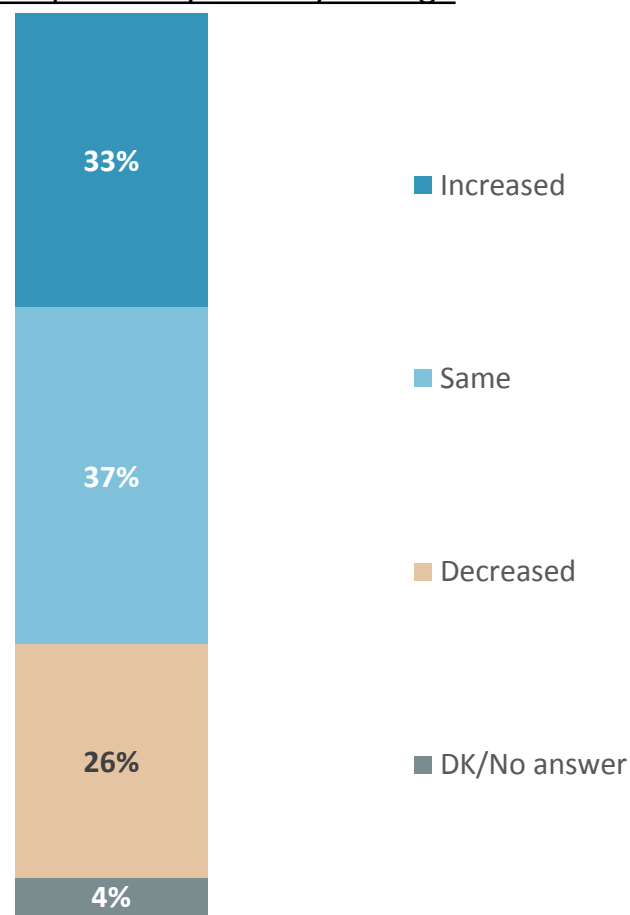

Level of corruption today

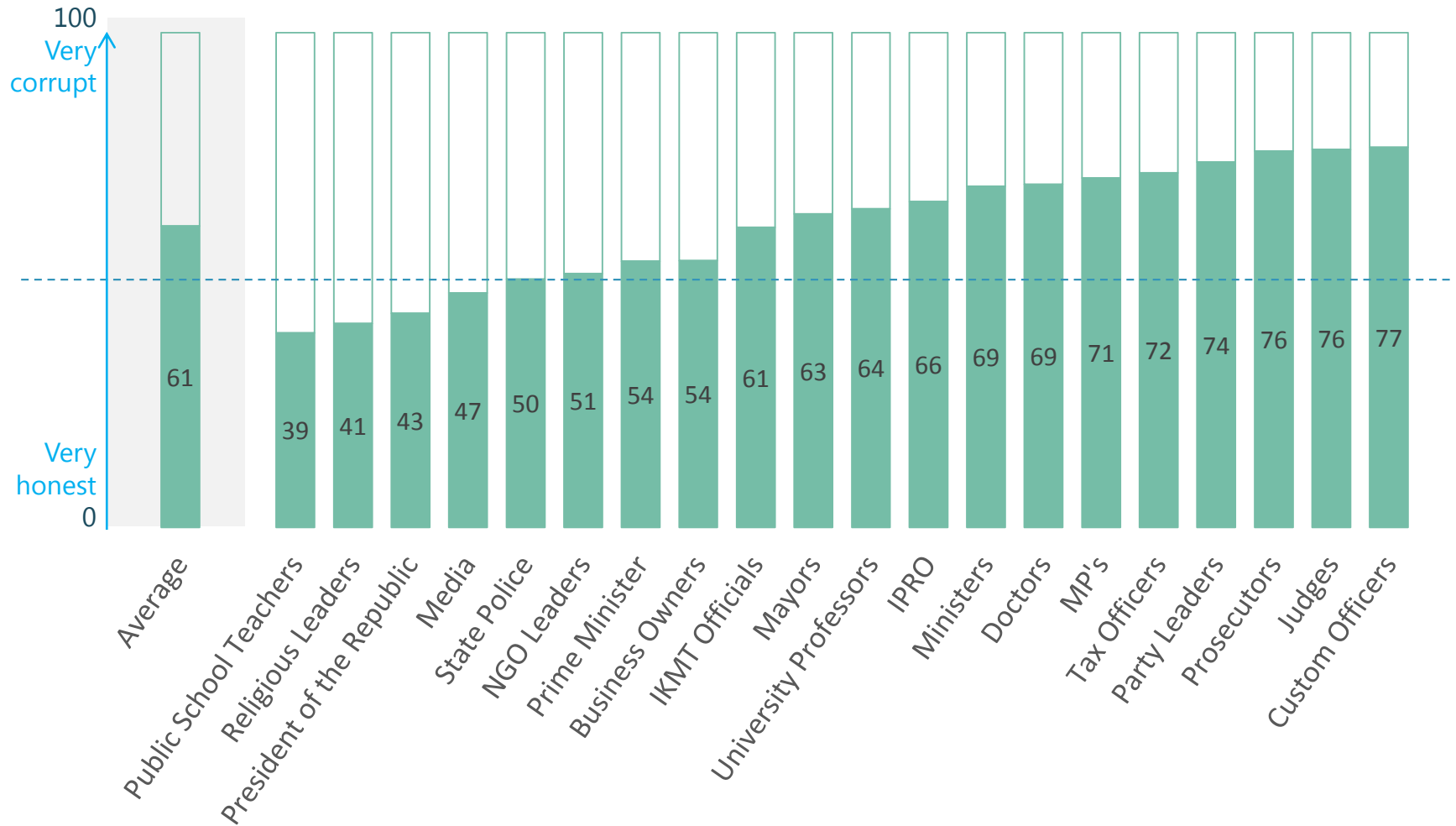


Level of corruption comparatively with 3 years ago

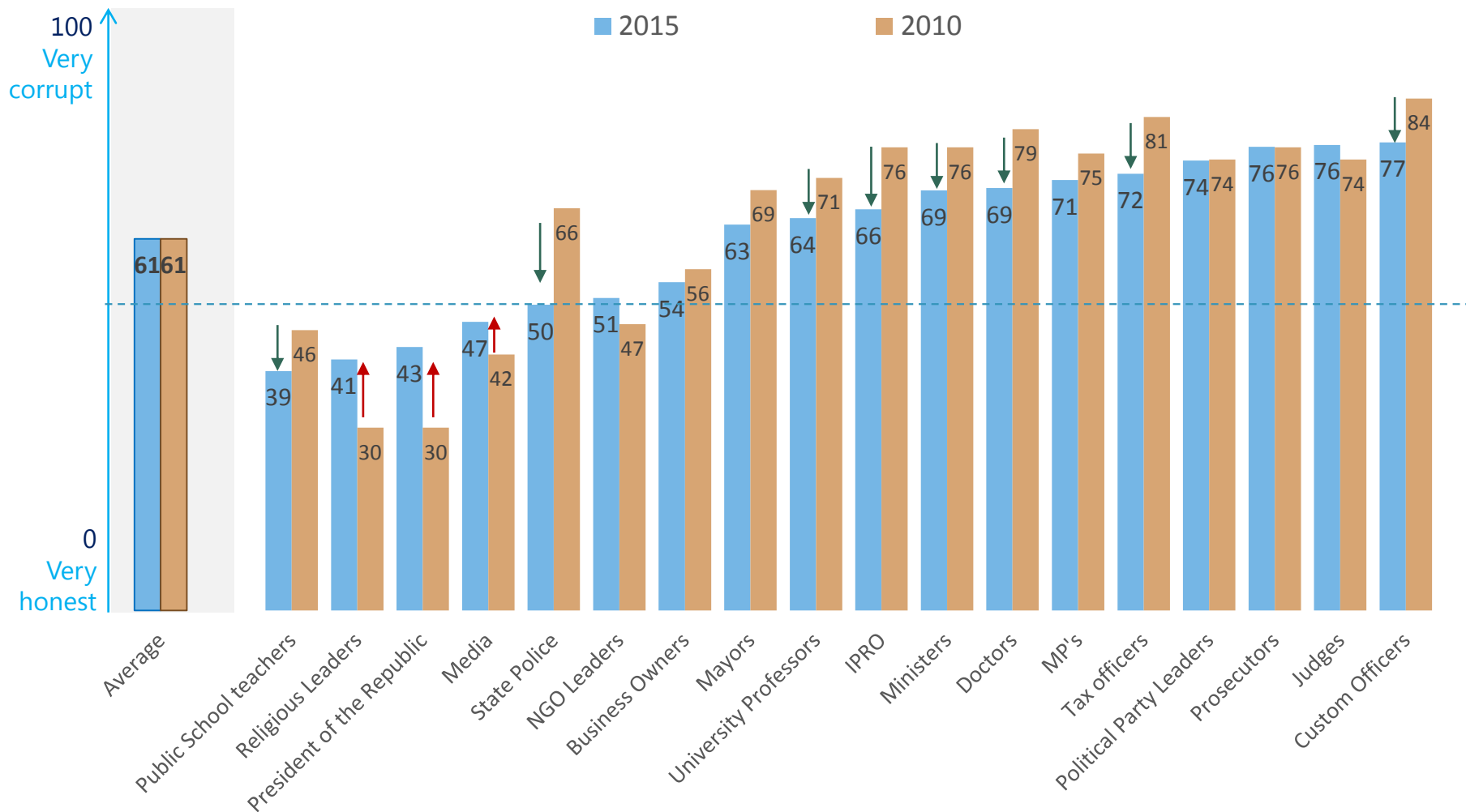

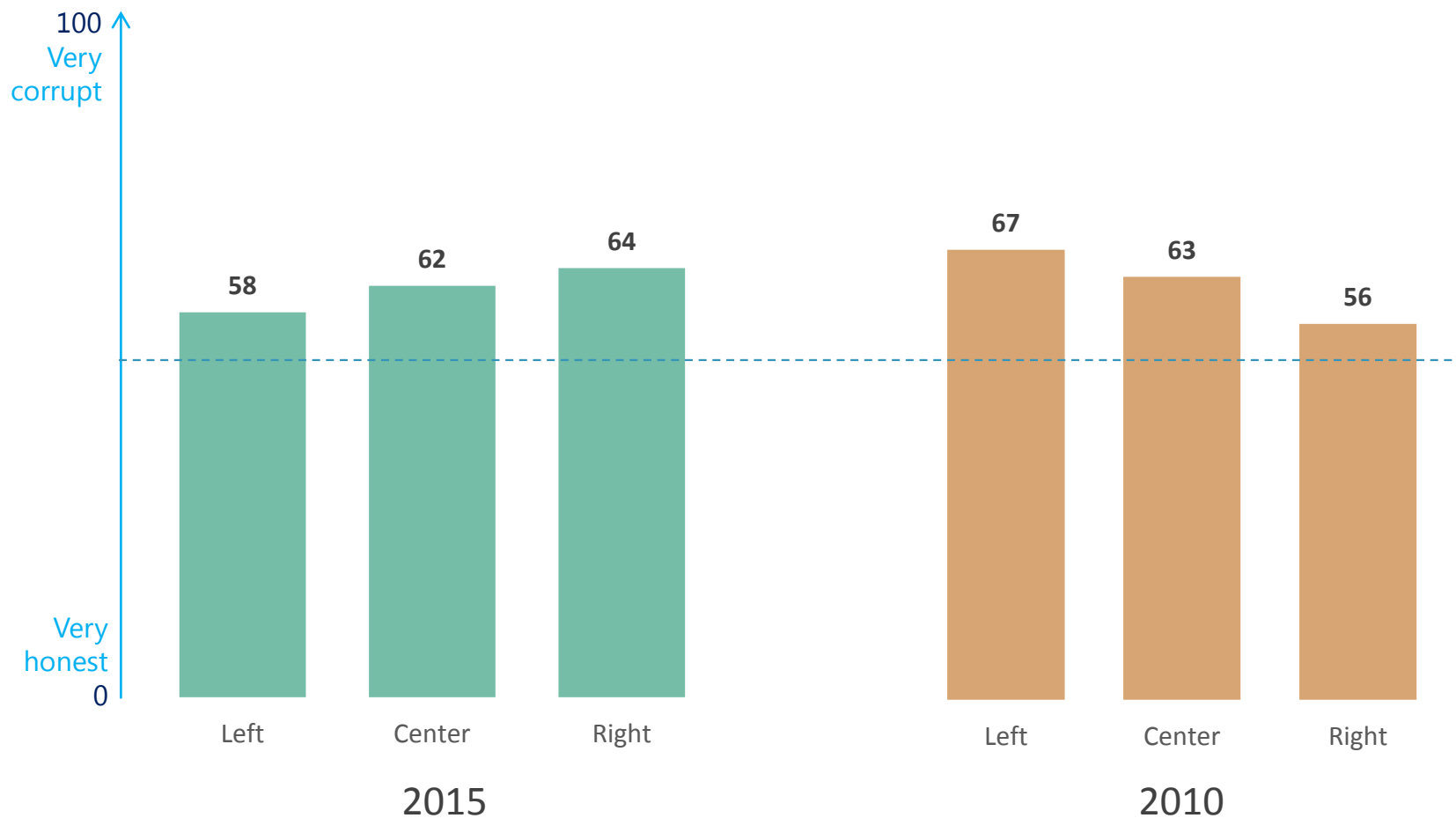

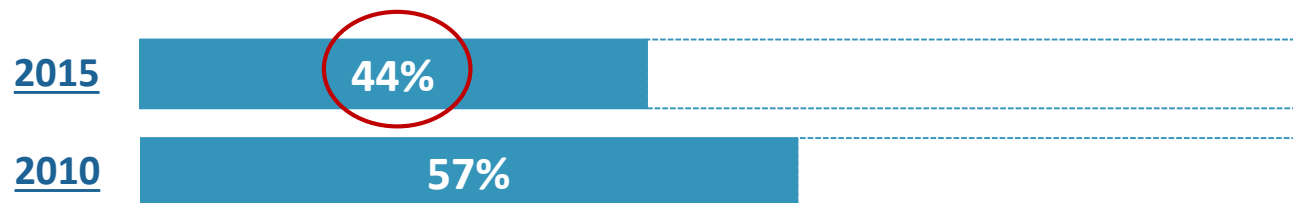

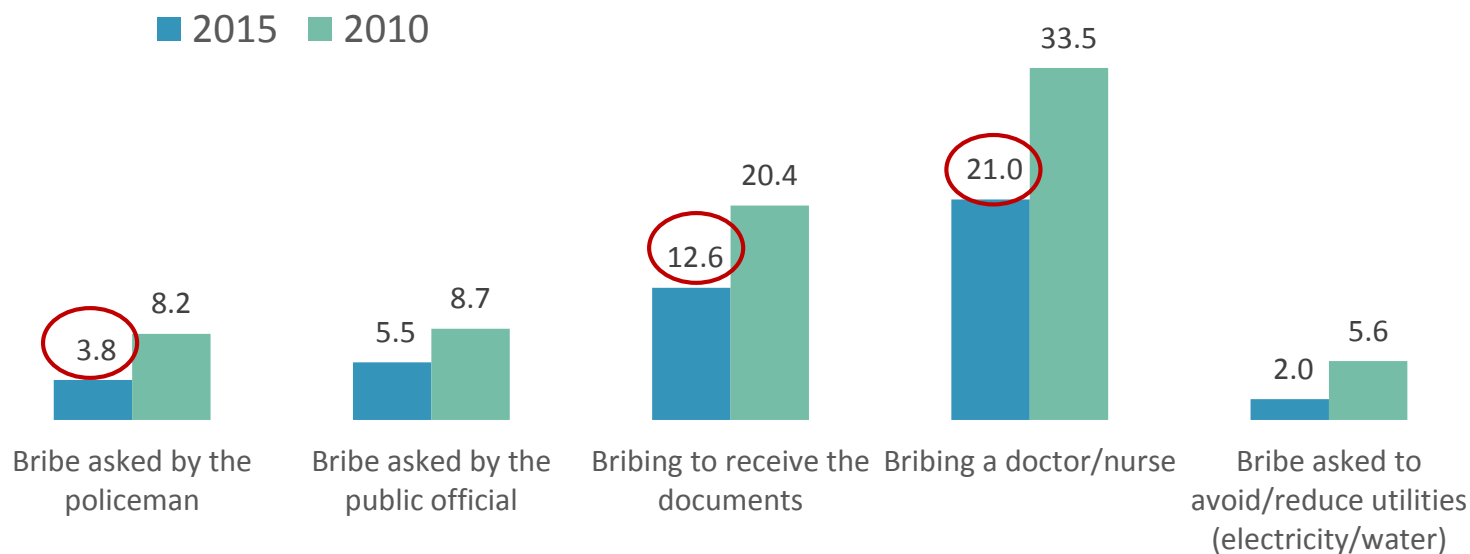

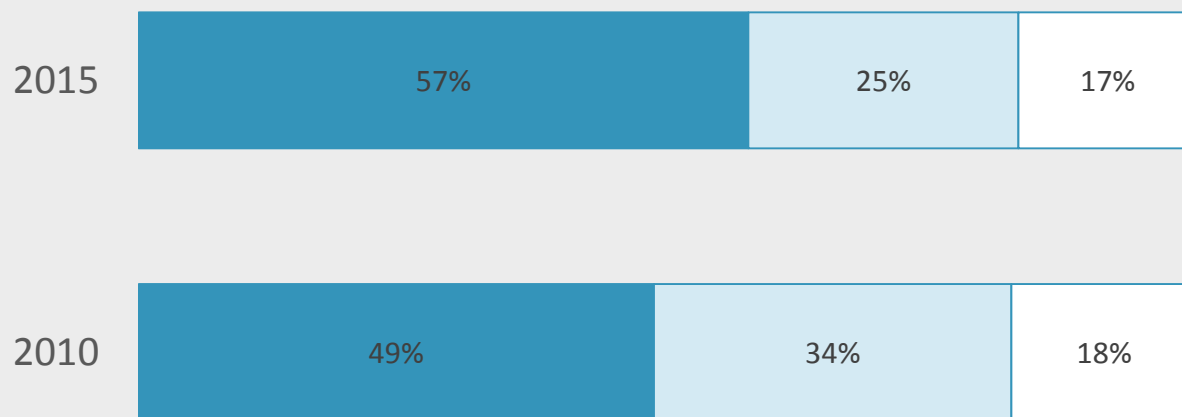

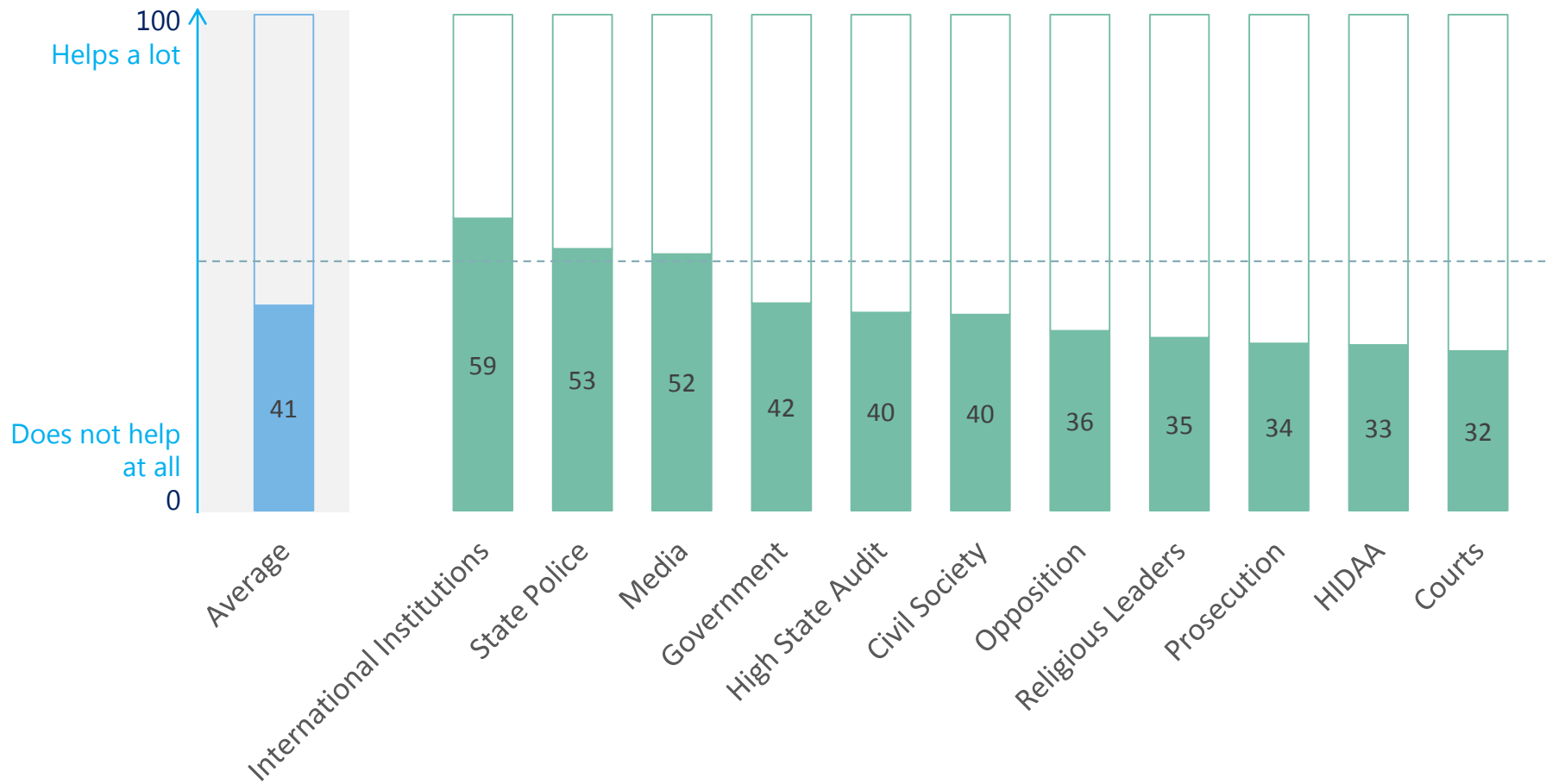

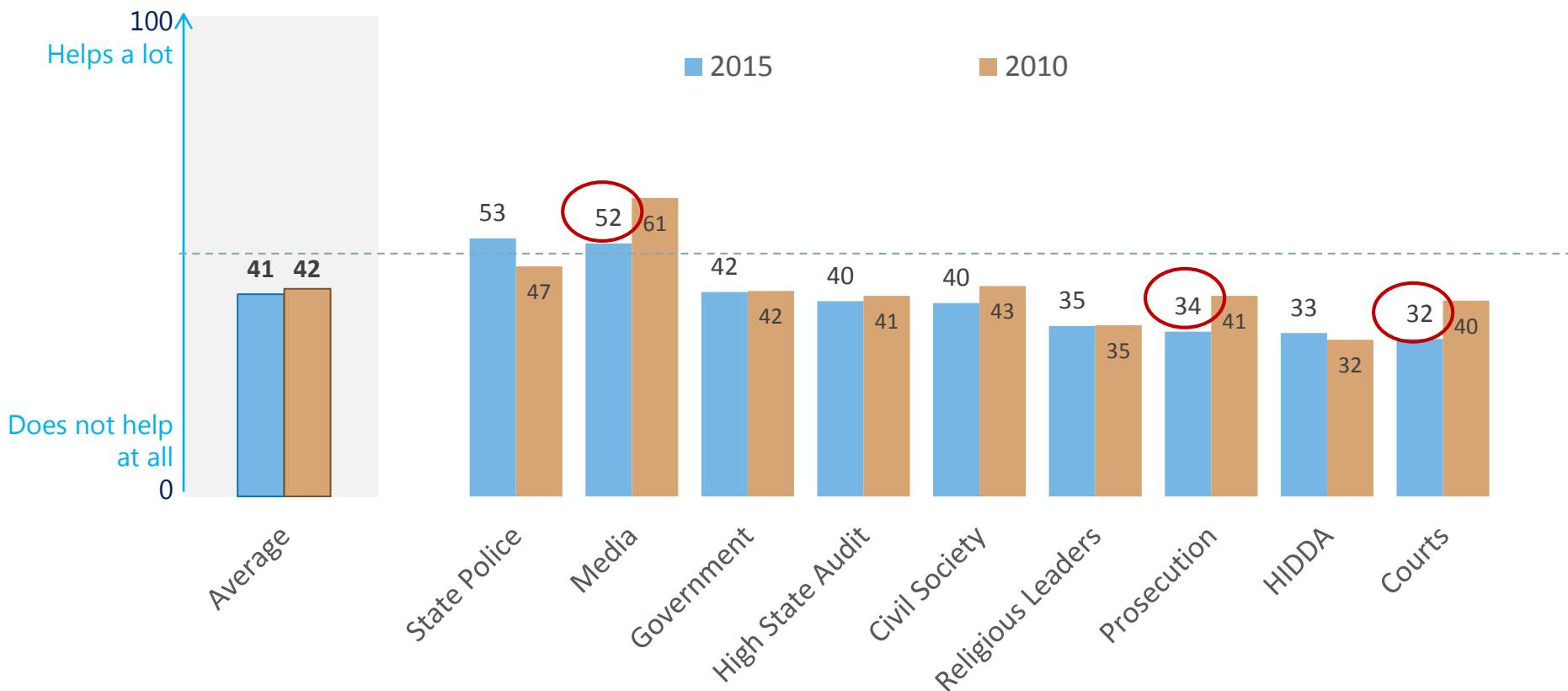




Contribution of institutions to the fight against Corruption through years

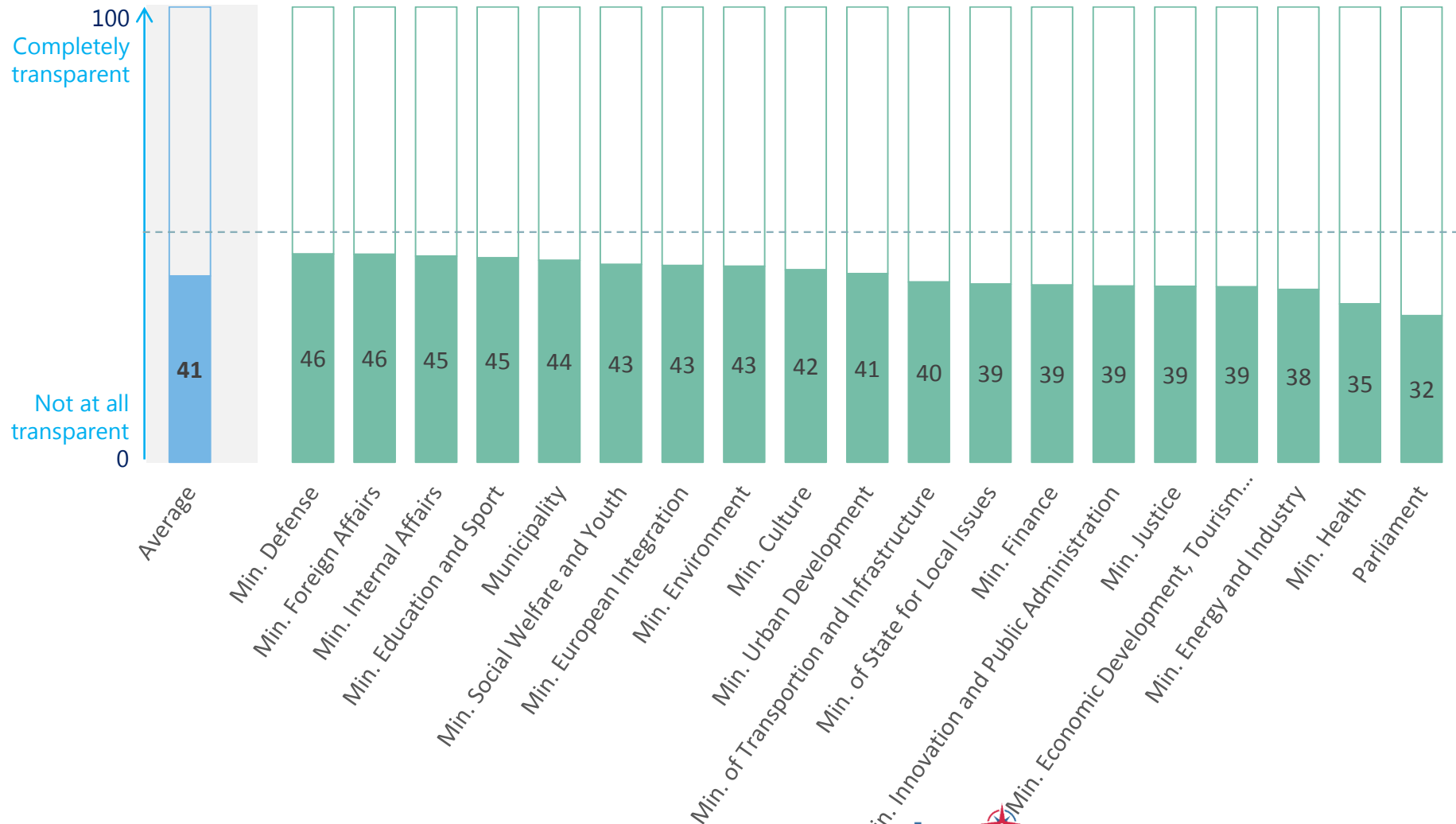

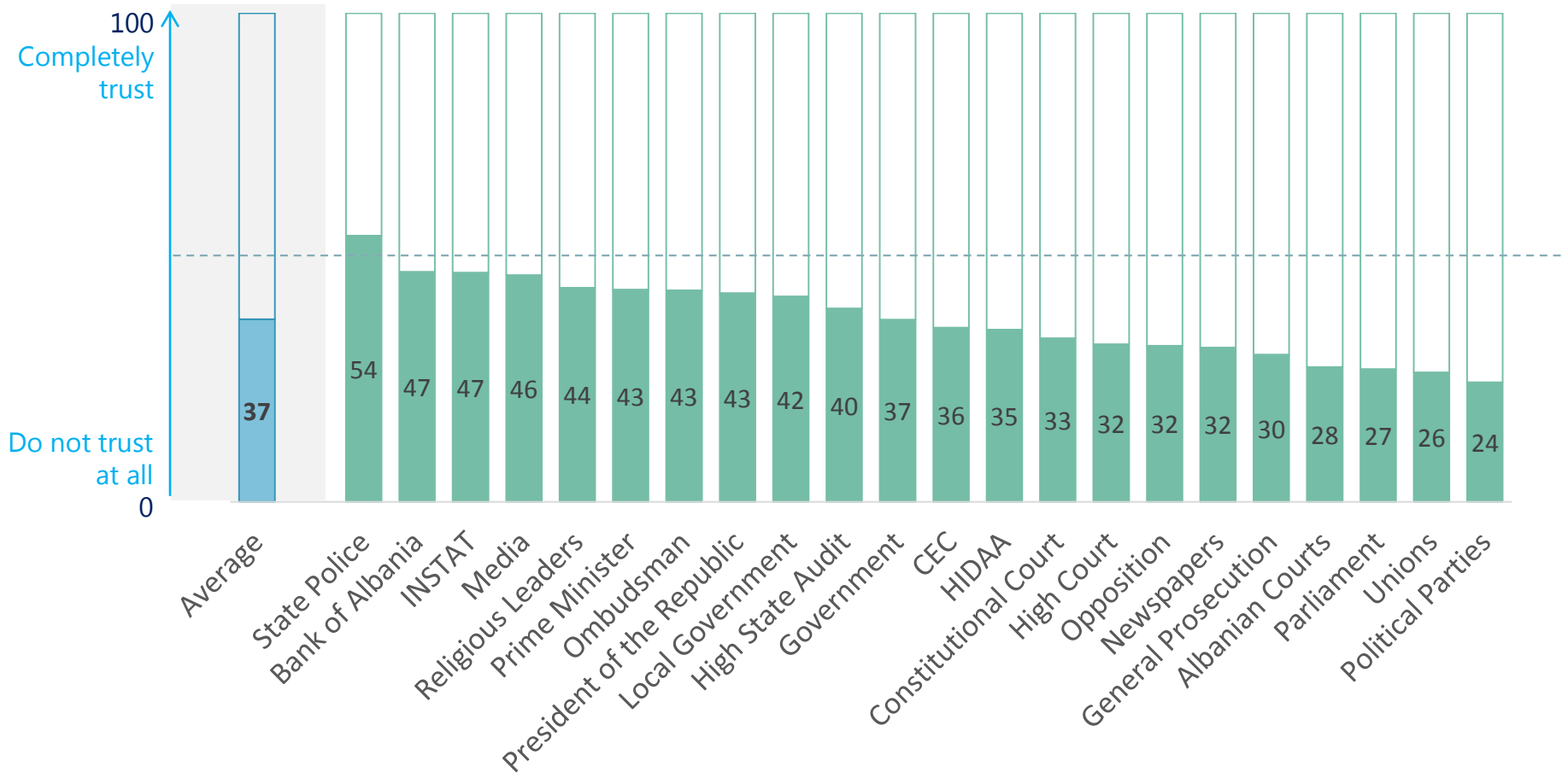

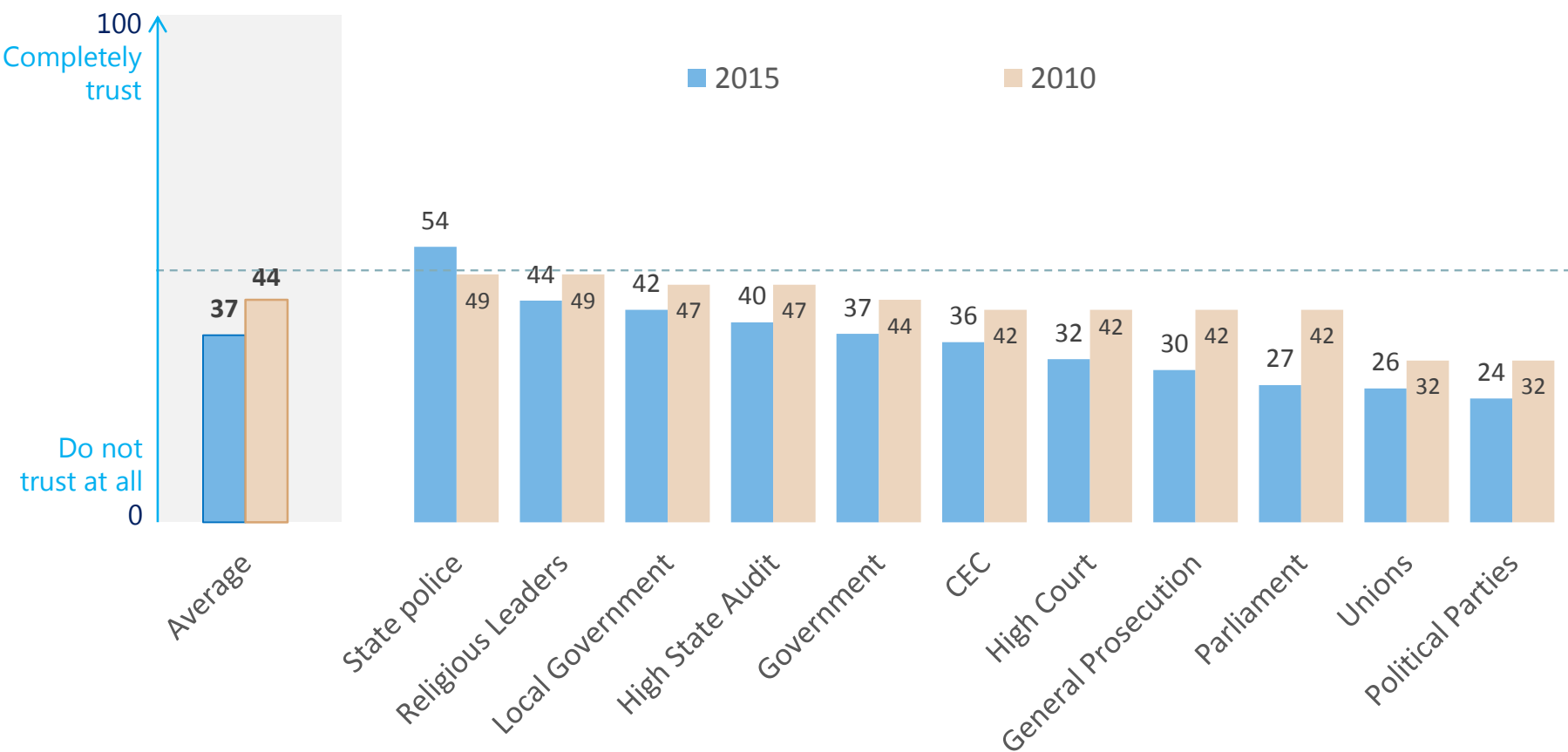

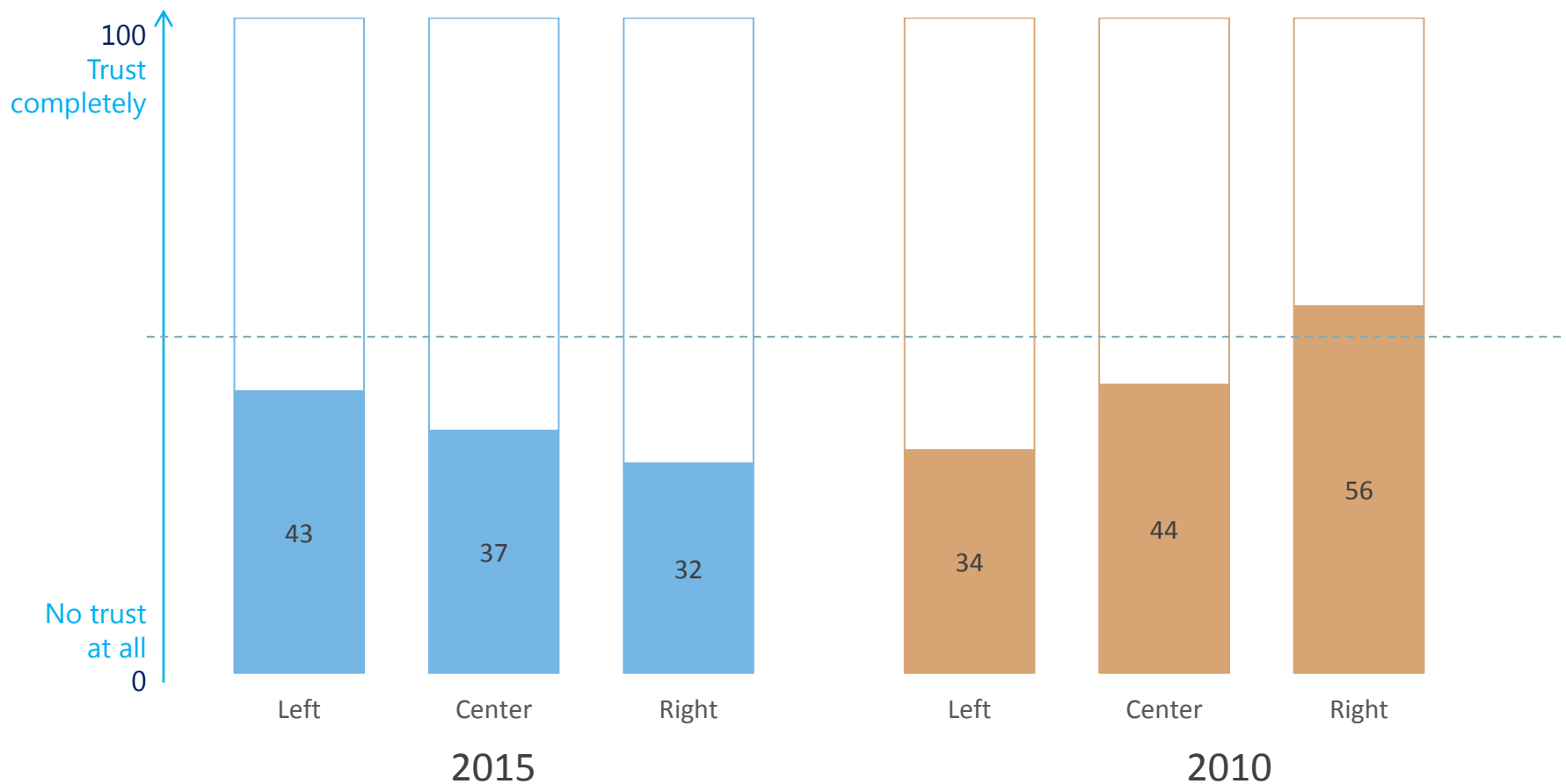

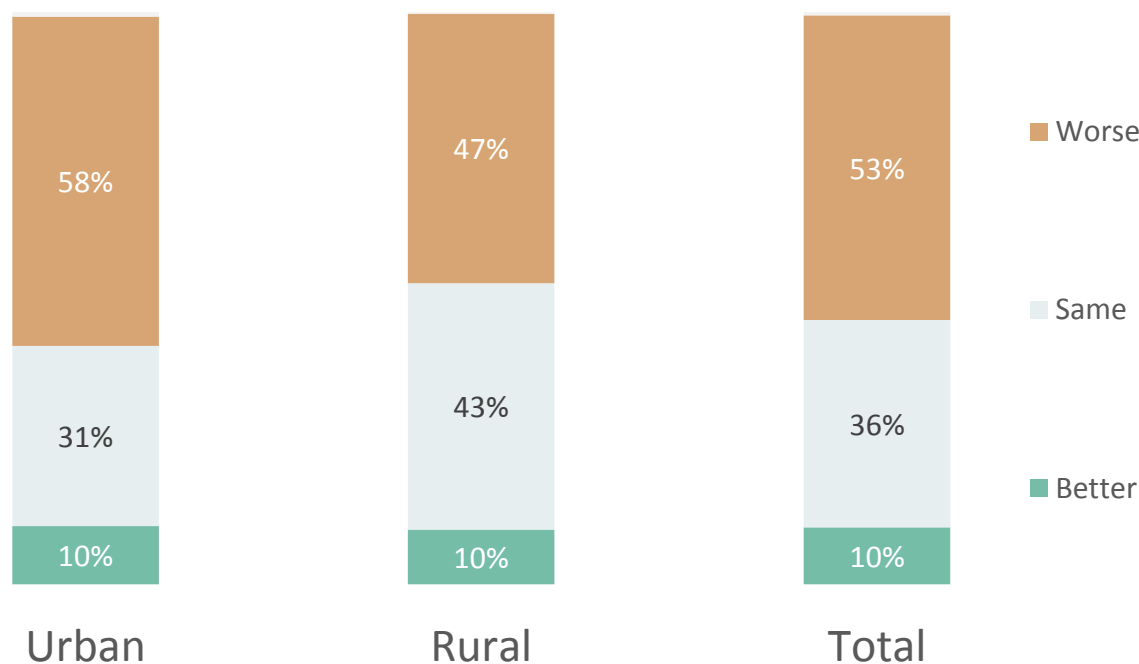

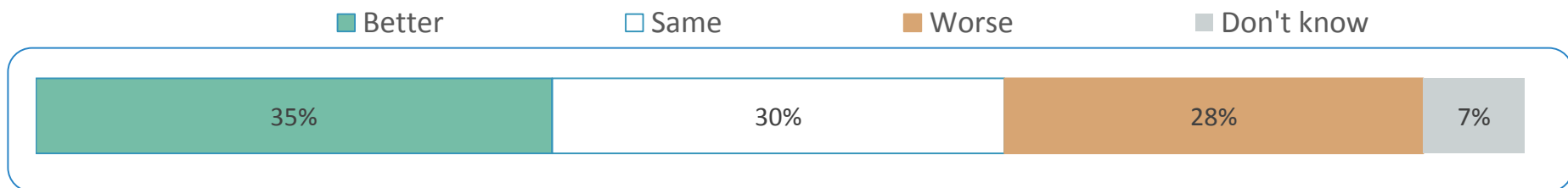

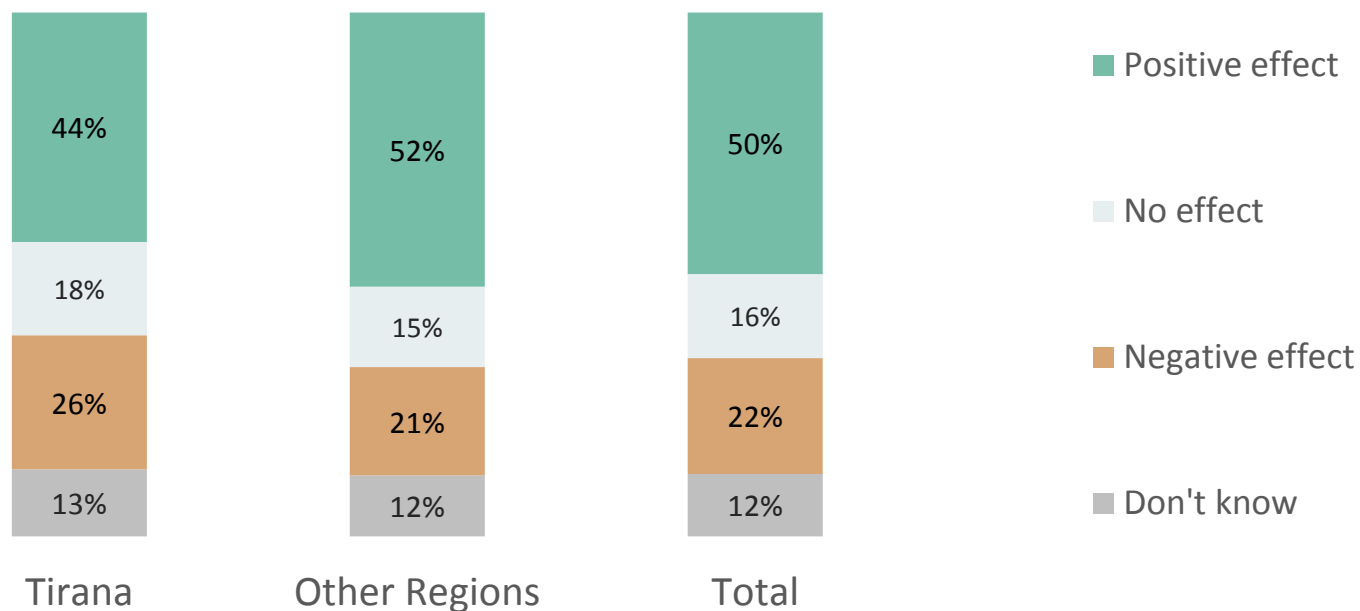
