BOARD MINUTES – 7 JUNE 2021

1. Apologies and Conflicts of Interest

1.1 Tom Ilube was an apology for the meeting.

2. Annual Report Review

- 2.1 The Board met to review a draft of the front half of the Annual Report, less the accounts and the equality information report (EIR). The full Annual Report and Accounts for 2020-21 would return to the Board on 18 June for approval.
- 2.2 The Board discussed the overall narrative and format of the report. Directors requested a number of amendments to the draft ahead of its return to the June Board meeting.
- 2.3 Board members noted that the Audit and Risk Committee had approved the financial statements earlier that day. The Chief Financial Officer provided a summary of the final balance sheet and operating surplus position. The work on the audit was now complete and an unmodified opinion on the accounts and the licence fee trust statement were expected from the NAO.

3. Serota Review: Terms of Reference

- 3.1 Following the publication of Lord Dyson's independent review into the 1995 *Panorama* interview with Diana, Princess of Wales, the Board announced a review looking into the oversight of the BBC's editorial practices and procedures, including the robustness and independence of whistleblowing processes in editorial areas. The review will be led by Sir Nicholas Serota. The Board considered a draft Terms of Reference for that review.
- 3.2 The Board approved the draft Terms of Reference subject to a draft amendment. Directors would receive an update on the work of the review at the next Board meeting.
