**Right to object**

The processing of your personal data (including profiling) occurs (i) for the performance of a task carried out in the public interest (ii) in the exercise of official authority vested in ACCURAT or (iii) on grounds of the legitimate interests of ACCURAT or a third party and you wish to object to the processing of your personal data on grounds relating to your particular situation.

**Note:** ACCURAT shall no longer process your personal data unless ACCURAT demonstrates compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise or defence of legal claims

- You wish to object to the processing of your personal data for direct marketing purposes (including profiling related to such direct marketing). More specifically, you wish that:
  - ACCURAT erases all your personal data from its filing systems. ACCURAT will contact you again in future if access is regained to your personal data from a third party
  - ACCURAT does not process your personal data anymore for direct marketing purposes and ensures that you will never receive direct marketing again from ACCURAT or its partners

**III. REACTION OF ACCURAT TO YOUR REQUEST**

ACCURAT shall provide without undue delay and in any event within one month of receipt of your request, information on action taken on your request.

Depending on the complexity of your request and the number of requests, that period may be extended by two further months where necessary. In that case, ACCURAT will inform you within one month of receipt of your request.

If ACCURAT does not take action on your request, ACCURAT will inform you within one month of receipt of your request and, in addition, ACCURAT will provide the reasons for not taking action on your request. ACCURAT will also inform you on the options to (i) lodge a complaint with a supervisory authority or (ii) seek a judicial remedy.

**IV. PROOF OF YOUR IDENTITY**
