## **Description of the Weighing Test**

The applicant is required to secure the agreement of one of the clearing banks represented on the LBMA Physical Committee to send to its vault a batch of 2 tonnes of large gold bars which have previously been accurately weighed by an approved weigher on both a deadweight and rounded basis, using a combination of an electronic gold scale and a beam balance. The applicant will not be provided with a weight list but instead a simple list of the brands and bar numbers of the bars in the batch. The approved weigher will send the full weight list of the batch to the LBMA Chief Executive.

The applicant must similarly weigh the bars and provide a report to the LBMA Chief Executive within 5 business days of receiving the bars. The report should contain, for each bar, both the deadweight and the weight rounded down to the nearest 0.025 troy ounces according to Annexes G and H of the LBMA Good Delivery Rules. The report should be sent in hard copy and also as an Excel electronic spreadsheet.

The LBMA recommends that if a large gold bar weighs from 0.001 to 0.003 troy ounces above the nearest 0.025 division on an electronic gold scale, the bar should also be weighed on a beam balance. In the case of different weights being recorded by the beam balance and the electronic scale, the beam balance weight should normally be preferred.
