A PROCLAMATION

WHEREAS it is provided by section 60(1) of the *Constitution* that each session of Parliament shall be held at such place and commence at such time as the Governor-General may appoint:

AND WHEREAS by Proclamation dated the 7th day of September, 2020 the Governor-General appointed the Lloyd Erskine Sandiford Centre, Two Mile Hill, Saint Michael as the place at which the Second Session of Parliament should be held on 15th September 2020 at 10:00 hours in the morning:

AND WHEREAS it was expedient to continue the session of Parliament at the Worthing Corporate Centre, Worthing, Christ Church with effect from the 22nd day of September, 2020:

AND WHEREAS it is now expedient to have this session continued with a Joint Sitting of both Houses of Parliament at the Lloyd Erskine Sandiford Centre on the 20th October, 2021:

NOW THEREFORE by virtue and in exercise of the power and authority in me vested, I, Dame Sandra Prunella Mason, Dame Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Dame of St. Andrew, Queen's Counsel, Governor-General of Barbados, DO HEREBY APPOINT the Lloyd Erskine Sandiford

Centre, Two Mile Hill, St. Michael as the place at which the session of Parliament shall be held on Wednesday, 20th October, 2021 and 10:00 in the morning as the time at which the said session shall commence.

PROCEDURE GUIDE FOR THE JOINT MEETING OF BOTH HOUSES OF PARLIAMENT

Section 14(1) of the Constitution (Amendment) (No. 2) Act, 2021 which was proclaimed on the 11th day of October, 2021 as Statutory Instrument 2021 No. 68 provides as follows:

In accordance with the provisions of this section,

- (a) the Prime Minister shall; and
- (b) the Leader of the Opposition may,

no later than 15th October, 2021, nominate a person to be elected as the President of Barbados.

(2) If the Prime Minister and the Leader of the Opposition make in writing to the Speaker a joint nomination of a qualified candidate for election as President, being a nomination to which that candidate has consented, the Speaker shall notify both Houses of the joint nomination and, at a joint meeting of both Houses, the Speaker shall ask the members whether any member has an objection to the candidate being declared duly elected and if no member objects thereto, the Speaker shall declare the candidate duly elected.




Dear Mr. Speaker,

ELECTION OF PRESIDENT NOTICE, 2021

The Speaker, in exercise of the powers conferred on him by section 14(8) of the *Constitution (Amendment) (No. 2) Act, 2021*, gives the following Notice:

1. This Notice may be cited as the *Election of President Notice, 2021*.
2. The Hon. Miss Mia Amor Mottley, Q.C. M.P., Prime Minister, and Bishop the Hon. Joseph J.S. Atherley, J.P. M.P., Leader of the Opposition, have jointly nominated Her Excellency Dame Sandra Prunella Mason, GCMG, D.A., Q.C. for election to the office of President of Barbados.
3. The election will take place at a joint meeting of both Houses on the 20th day of October, 2021 at 10 o'clock in the forenoon at the Lloyd Erskine Sandiford Centre, Two Mile Hill in the parish of Saint Michael.

Mr. President read the Statement of the Poll taken in the Honourable Senate on the election of the President of Barbados. 18 votes were cast in favour of the candidate and there were none against.

Mr. Speaker read the Statement of the Poll taken in the Honourable the House on the election of the President of Barbados. There were 27 votes in favour and none against.

The candidate having received not less than two-thirds of the votes cast in each House, Mr. Speaker declared the candidate duly elected.

Mr. Speaker read the following:

INSTRUMENT OF ELECTION OF PRESIDENT

TO ALL TO WHOM THESE PRESENTS SHALL COME GREETINGS

WHEREAS it is provided by section 14(2) of the *Constitution (Amendment) (No. 2) Act, 2021* (Act 2021-22) that if the Prime Minister and the Leader of the Opposition make in writing to the Speaker a joint nomination of a qualified candidate for election as President, being a nomination to which that candidate has consented, the Speaker shall notify both Houses of the joint nomination and at a joint meeting of both Houses the Speaker shall ask the members whether any member has an objection to the candidate being declared duly elected and if no member objects thereto, the Speaker shall declare the candidate duly elected:

AND WHEREAS the Prime Minister and the Leader of the Opposition jointly nominated Her Excellency Dame Sandra Prunella Mason, Dame Grand Cross of the Most Distinguished Order of Saint Michael and St George, Dame St Andrew, Queen's Counsel, Governor General of Barbados as the candidate for election for the office of President of Barbados:

AND WHEREAS the Speaker notified both Houses of the joint nomination and at a joint meeting of both Houses held on the 20th day of October, 2021 at the Lloyd Erskine Sandiford Centre one member objected to the said Dame Sandra Prunella Mason being declared duly elected:

AND WHEREAS pursuant to section 14(3), (4), (5) and (6) of the *Constitution (Amendment) (No. 2) Act 2021* (Act 2021-22) aforementioned, the Speaker suspended the joint meeting and the members reconvened in their respective House where the question mentioned in the first paragraph hereof was put to the vote and immediately upon announcement of the vote in each House the joint meeting resumed and the President of the Senate and the Speaker of the House announced the result of the vote:

AND WHEREAS the candidate aforementioned received 18 votes in the Senate and 27 votes in the House of Assembly being not less than two-thirds of the votes cast in each House;

NOW THEREFORE I, Arthur Holder, Speaker of the House of Assembly of Barbados in accordance with the provisions of section 14 of the *Constitution (Amendment) (No. 2) Act, 2021* (Act 2021-22) do hereby declare the said, Dame Sandra Prunella Mason elected as the President of Barbados.
