At the age of 19 he came to London, studied for a time at University College, and was called to the Bar by the Inner Temple. Leader from 1893 of the Indians in South Africa in connection with the representation of their local grievances. Developed there his conception of resistance without violence. Was in charge of an Indian Ambulance Corps during the Boer War and the Zulu revolt in Natal. Returned to India shortly after the outbreak of the Great War. Took part in the Conference called by the then Viceroy to mobilise Indian opinion. Raised an ambulance corps and conducted a recruiting campaign. Became the leader of the non-co-operation and civil disobedience campaign inaugurated in 1920. Sentenced to six years' imprisonment in 1922, but released in less than two years. For a time confined himself to social and moral reform, concentrating expressly on village industry, but soon came back to politics. Since 1929 has been the dominant figure of the Indian National Congress. His second civil disobedience campaign began in the spring of 1930. His internment and release, and his conversations with the then Viceroy (Lord Irwin), leading to the agreement of the 5th March, 1931, and to the abandonment of the campaign, are recent outstanding features.
