To the extent possible, we keep confidential the identity of informants.

**Counterfeits:** The sale of counterfeit merchandise is prohibited on eBay and exposes the seller to both criminal and civil penalties. Sale of counterfeit AEO products will result in removal of the auction, and could include a subsequent enforcement action from AEO against the seller. Ignorance of the law or innocent intent is not a defense to violating the intellectual property rights of others. Additionally, the fact that a product is being sold on eBay provides no guarantee that it is a genuine Brand product.

**Trademarks:** As well as trademark rights developed through use, AEO’s trademarks are registered throughout the world. Any use of AEO’s trademarks or service marks without the express written permission from AEO exposes sellers to an infringement claim and a possible lawsuit.
