We protect the reputation of our brands by monitoring eBay on a daily basis and maintaining active membership of the Verified Rights Owners programme (VeRO). The VeRO program enables us to request eBay remove listings for products that infringe our trademarks or other intellectual property rights. FREQUENTLY ASKED QUESTIONS

I have had a listing removed and now my account has been suspended. Can you assist me with having my eBay account suspension removed?

It will be necessary for you to contact eBay directly regarding your account status. eBay will not discuss the activation of a trader's account with us.

I bought the product from eBay so assumed it must be genuine.

I bought the product in good faith from eBay. Can you provide me with a refund?

MGA is not a trader or distributor of our brands via eBay. If you believe you may be entitled to a refund as the result of an imitation product, please contact eBay/PayPal directly.

I only want to buy genuine MGA goods. How can I be sure I am doing this?

To be sure the goods you have purchased are genuine we recommend purchasing MGA brands from a reputable retailer. MGA cannot guarantee the authenticity of any MGA item sold on eBay.

I want to report a trader on eBay who I think is selling infringing MGA products. Who should I contact?
