

AMENDMENT TO RULES COMM. PRINT 117-54
OFFERED BY MR. KINZINGER OF ILLINOIS

At the appropriate place in subtitle D of title XII,
insert the following:

1 **SEC. ____ . EXPANSION OF COOPERATION AND TRAINING**
2 **WITH UKRAINE.**

3 (a) **AUTHORIZATION OF APPROPRIATIONS.**—There is
4 authorized to be appropriated \$100,000,000 to build the
5 capacity of foreign security forces pursuant to relevant au-
6 thorities under title 10, United States Code. Amounts so
7 authorized shall be made available to provide assistance
8 to Ukrainian military pilots and associated persons for the
9 following purposes:

10 (1) Training and familiarity building with
11 United States fixed-wing aircraft and other air plat-
12 forms as appropriate for air-to-air and air-to-ground
13 combat.

14 (2) Training on the use of munitions sets deter-
15 mined appropriate by the Secretary of Defense.

16 (3) Establishing a rapport between the Armed
17 Forces of the United States and the armed forces of
18 Ukraine to build partnerships for the future.

1 (4) Enhancement of capabilities for aerial com-
2 bat operations.

3 (5) Focusing on the ability of Ukraine to teach
4 current and future pilots on fixed-wing aircraft and
5 other air platforms in Ukraine and elsewhere, espe-
6 cially during the ongoing Russian invasion of
7 Ukraine.

8 (6) Fostering a better understanding of the air
9 platforms, tactics, and techniques of the United
10 States and other member countries of the North At-
11 lantic Treaty Organization.

12 (b) NOTICE TO CONGRESS.—Not later than 15 days
13 before providing assistance or support using amounts
14 made available pursuant to the authorization under sub-
15 section (a), the Secretary of Defense shall submit to the
16 Committee on Appropriations of the Senate and the Com-
17 mittee on Appropriations of the House of Representatives
18 a notification containing the following elements:

19 (1) A detailed description of the assistance or
20 support to be provided, including—

21 (A) the objectives of such assistance or
22 support.

23 (B) the budget for such assistance or sup-
24 port; and

1 (C) the expected or estimated timeline for
2 delivery of such assistance or support.

3 (2) A description of such other matters as the
4 Secretary considers appropriate.

5 (c) OFFSET.—Notwithstanding the amounts set forth
6 in the funding tables in division D, the amount authorized
7 to be appropriated in section 301 for operation and main-
8 tenance, Air Force, Flying Hour Program, Line 080, as
9 specified in the corresponding funding table in section
10 4301, is hereby reduced by \$100,000,000.
