Note:-1 The General Educational qualification will be relaxed as **completed SSLC course** subject to the condition that this relaxation will be allowed only to the extent necessary to fill up the quota reserved for and in the absence of qualified candidates.

2 Differently Abled Candidates are not eligible to apply for this post

3 Rule 10(a)(ii) of Part II of KS&SSR is applicable for selection to this post.

In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission.

8 **Mode of submitting Applications:-**

- (a) Candidates must register as per **ONE TIME REGISTRATION** scheme through the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User ID and password. Candidates must click on the **Apply Now** button of the respective posts in the Notification link to apply for the post. The photograph uploaded should be one taken after **31.12.2013. Candidate who have created new profile should upload their photograph taken within a period of 6 months.** Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading of photographs. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link **My Applications** in their profile. All correspondence with the commission, regarding the application should be accompanied with the print out of the application. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for.
- (b) If written Test /OMR/ Online Test is conducted as part of this selection, candidate shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the admission tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Programme itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Tickets will alone be permitted to attend the examination. As per Rule 22 of the KPSC Rules of Procedure 1976, appropriate disciplinary action will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification experience etc. and give confirmation for examination, irrespective of the fact that they have appeared or not for the examination.
- (c) **Candidates who have Aadhar Card should Add Aadhar Card as ID proof in their profile.**

11 Special Instructions to candidates

- (a) In the case of difference in Caste/Community claimed in the application and that entered in SSLC Book , the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate /Community Certificate at the time of certificate verification.
- (b) Candidates are required to acquaint themselves within the instructions given in the notifications as part II , General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
- (c) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure 1976 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education ,experience etc. and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written / practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
