Ms. Pace, acting in your official capacity as one of the three United States' delegates to the World Health Organization (WHO), on January 18, 2022, you submitted a proposal to the WHO which included a number of very troubling amendments to the International Health Regulations.

It appears that these proposed amendments would VOLUNTARILY cede United States sovereignty and the sovereignty of the other 193 member nations over to the WHO.

Ms. Pace, by definition, your decision to submit documents that give away national sovereignty has an impact on my personal sovereignty, freedoms and rights as well as those of everyone else on earth.

I believe that you, like many other people, are under the influence of many powerful illusions. Perhaps you have not read, nor have you actually comprehended the ramifications of the proposed amendments.

I believe that you may have **UNWITTINGLY** overstepped your authority, and you have clearly failed to be transparent and inclusive in the development of the proposed amendments.

### THERE IS A SIMPLE REMEDY:

This is a plea to encourage you to publicly reject your association with the submission of these amendments and to RESIGN YOUR POSITION as a member of the United States delegation to the 75th World Health Assembly this May 22-28, 2022.

You have the opportunity to "save face" by resigning your position as a member of the delegation and renounce the proposed amendments to the International Health Regulations

You made a mistake by doing this in darkness.

You can make amends, and all will be forgiven, if you IMMEDIATELY AND PUBLICLY retract the submission and open up this issue to extended public discussions.

#### BACKGROUND:

Ms. Pace announced the proposed amendments in a very cryptic manner on January 26, 2022. Here is the link...

Below is an excerpt from the January 26, 2022 announcement:

The United States strongly supports the ongoing efforts to strengthen WHO and make it more agile, transparent, and efficient.

On behalf of more than 40 Member States, we are pleased to propose a Decision for the Executive Board, asking Member States of WHO and States Parties of the International Health Regulations (IHR) of 2005, to discuss targeted amendments to the IHR (2005) and address specific issues, challenges, or gaps that are crucial to their effective implementation.

The draft decision also requests the Working Group on Preparedness & Response (WGPR) establish a dedicated process for in-depth discussions of targeted amendments to the IHR and facilitate a transparent, Member State-led process.

The United States led an **inclusive and transparent process to develop this decision**, as we are mindful that updating and modernizing the IHR are critical to ensuring the world is better prepared for and can respond to, the next pandemic.

Finally, the United States formally transmitted its proposals for targeted amendments to the IHR (2005) to the Director General consistent with IHR Article 55 for circulation to States Parties at least four months in advance of WHA 75.

We are confident of continued progress on the various complementary WHO strengthening work streams:

(1) targeted amendments to the International Health Regulations (IHR) (2005),

(2) a full review of by the WGPR

(3) an intergovernmental negotiating body (INB) to develop a new international instrument on pandemic preparedness and response, and

(4) governance improvements at WHO, starting with an informal group and then establishing a Task Team of Member States to work with the Secretariat.

## The purpose of our republic is for our government to protect our rights, not to give them away.

### The delegation has failed to even attempt to represent the will of the people.

The delegation has certainly not taken the time to listen to the will of the people. It certainly seems as though this process has been conducted in the very darkness in which democracy is said to die.

I question the claim that the delegation conducted an *"inclusive and transparent process to develop this decision."* The process by which these proposed amendments were developed was so dark that it appears to have been shrouded by a cloak of invisibility.

Despite your claims to an *"inclusive and transparent process to develop this decision,"* to the best of my knowledge, the proposed amendments have never been posted publicly by the United States Mission to Geneva, the State Department or the Department of Health and Human Services, nor have I been able to find them in the Federal Register. Please correct me if I am wrong.

Nearly three months after you submitted the proposal, the WHO finally posted them publicly on their website on April 12, 2022. Here is the link...

### Questions for Loyce Pace and the other members of the United States delegation to the 75th World Health Assembly.

1. The announcement by the United States Mission to Geneva claims that the proposed amendments to the International Health Regulations were developed through a process that was inclusive and transparent. Who was included? Where may I find the minutes or recordings of the public proceedings that document this supposedly transparent process?

- 2. Were these proposed amendments ever published in the Federal Register? Please provide the link, if it exists.
- 3. Were these proposed amendments ever published on the website of the United States Mission to Geneva? Please provide the link, if it exists.
- 4. Were these proposed amendments ever published on the website of the Department of State? Please provide the link, if it exists.
- 5. Were these proposed amendments ever published on the website of the Department of Health and Human Services? Please provide the link, if it exists.
- 6. Was there ever a 30, 60, 90, 180 day period during which public comment was requested and accepted? Could you please provide a link to the archive of these public comments?
- 7. This action appears to be the first of its kind and is thus without precedent. To the best of my knowledge, the United States has never before proposed amendments to the International Health Regulations. This is uncharted legal territory. Please provide me with the section of the U.S. Code that gives the delegate to the World Health Assembly the authority to hand over United States sovereignty to the World Health Organization. If that power is not specifically and clearly stated in the Constitution or in the U.S. Code, then it is reserved for the people. (See the 10th Amendment).
- 8. Can you explain to me how "approval" by the 194 member nations of the World Health Assembly generates any legal authority over the United States? Section 5 of <u>THIS LAW</u> clearly states that the United States is NOT obligated to change any of its laws in order to align itself with any recommendations made by the WHO.
- 9. Article 59 Section 1 of the International Health Regulations gives every member country 18 months to reject any amendments that may have been "approved" by the World Health Assembly. This is similar to a line item veto. Member nations are under NO obligation to enact legislation or craft regulations to conform to the DESIRES of the WHO. The approval of any amendment by the World Health Assembly does NOT create any legal obligation to comply with it. IT MERELY CREATES THE ILLUSION OF SUCH AN OBLIGATION. Can you state clearly and publicly that even if the amendments are approved, their passage will NOT have the force of law over the United States? No nation is obligated to comply. They can only be tricked into giving up their rights to opt out of any portion of the amendments.
- 10. The Constitution clearly states that the while President shall have the power to make treaties with nations, provided two-thirds of the Senators present concur. While this will undoubtedly be debated by Constitutional scholars, there is no legal justification to assume that amendments to existing treaties are exempt from this requirement.
