INSTRUCTIONS FOR AUTHORS

Thank you for your interest in *Politics and Religion Journal*. These instructions will help you prepare your submission in a way it can successfully move through peer review, production and publication phases. We urge you to take time to carefully read and follow the instructions as closely as possible; doing so will ensure you paper matches the journal's requirements and standards.

Politics and Religion Journal accepts the following types of submissions: original articles, books reviews, critical views and polemics.

Politics and Religion Journal uses the Open Journal System platform (OJS). Thus, you are required to submit your work via online submission system available on the web site. In order to do so, you are required to firstly login or register (in case you don't have an account), and follow the submission's steps. In case you are experiencing difficulties with the registration form, or in any other steps along the way, please do change your browser to Mozilla Firefox, or contact the Journal's editors. In a very unlikely event of not being able to submit your work via the online submission system, please send your submission materials to the editor-in-chief via Email: politikologijareligije@yahoo.com

Politics and Religion Journal does not accept manuscripts that are under review elsewhere, previously published, or already committed for publication. Submitted manuscripts are to be reviewed by at least two anonymous reviewers in a double-blind peer review process. The process of evaluation usually lasts between 2 and 6 months. You can learn more about the peer review process here.

Please note that this journal only publishes manuscripts in **English,** and that there are **no fees** payable to submit or publish in this Journal.

SUBMISSION CHECKLIST

Full submission includes the following: Main Document (Anonymous); Title page; Short bio(s), and Author's statement.

- Main document (Anonymous): Main document (Anonymous) typically includes: title (bold), abstract (up to 200 words), 4-6 keywords, body of the manuscript, references, and table and figures.
 - As *Politics and Religion Journal* use a double-blind review process, please omit name(s) of author(s) elsewhere in the manuscript, expect when citing previous work. If you use self-citations, these should always be done in the third person and in such a way that reviewers cannot identify author(s). Prior to peer review process, the Journal will review your manuscript for anonymity and make changes if necessary. Manuscripts needing substantial changes will be returned to the authors.
- **Title page:** Submit a separate title page that contains the following information: a) Title of your work; b) 200-words abstract, followed with 4 to 6 keywords, and c) a statement of acknowledgment, and/or funding sources (if any).

- Short bio(s): Submit a separate page that contains information on the author(s). It is necessary to include the author(s) affiliations, contact information, position held, areas of expertise, and major publications. It is also necessary to include author's ORCID ID. In case you don't have one, please do register by following this <u>link</u>.
- Author's statement: Please <u>download</u>, fill, sign, and upload the author's statement as a PDF. This statement acknowledges that you are submitting your original work that has not been published in any other journal, not does it constitute plagiarism or auto plagiarism. It also acknowledges that your submission has not been submitted to any other journal for consideration, and that is has not been offered to any other journal for publication in a language other than English.

FORMATTING YOUR MANUSCRIPT

Please submit your manuscript, title page, and short bio(s) exclusively in **Microsoft Word format** (A4, normal layout).

Other formatting requirements for the manuscript include the following:

- Word count: A typical paper published is this journal should be no more than 10,000 words, and no less than 5,000 words. This includes tables, references, and footnotes.
- Font: Times New Roman, size 12, line spacing 1.5, paragraph 0. Font size in footnotes is 11.
- **References:** list of references include all cited work. The list should be at the end of the manuscript, after the conclusion.
- **Tables and figures:** Tables and Figures should not be uploaded as separate files. Throughout your ms simply add [Table/Figure X about here], and add all your tables and figures at the end of the ms, after the references.
- **Quotation style:** *Politics and Religion Journal* uses author-date system as proposed by the <u>Chicago Style</u> for Referencing and Citations. Footnotes can be only used for some additional clarifications.

The peer review process <u>will not</u> be initiated if you manuscript does not meet the above listed formatting requirements.

IN-TEXT CITATIONS, AUTHOR-DATE SYSTEM AND REFERENCES

Politics and Religion Journal uses author-date system and in-text citations. That being said, you should **strictly bind to the following quotation style** within the manuscript.

Journal article

In the text, cite specific page numbers. In the reference list, include the page range for the whole article. For articles consulted online, include a URL or the name of the database in the reference list entry. Where applicable, please add DOI (Digital Object Identifier) instead of the URL. If there are more than three authors, use **et al.** in the in-text citation. However, list all authors in the references.

In the reference list, it can be helpful to repeat the year with sources that are cited also by month and day. Page numbers, if any, can be cited in the text but are omitted from a reference list entry. If you consulted the article online, include a URL or the name of the database.

These are the most frequent sources used in the academic work. In case you want to cite personal communications, translated book, interview, etc. please consult the Chicago Manual.

BOOK REVIEWS, CRITICAL VIEWS AND POLEMICS

Besides original articles, *Politics and Religion Journal* publishes book reviews, critical views and polemics. If you are interested in submitting any of these, we urge you to consults the Editorial board prior submission.

In general, we are interested in publishing reviews of the books related to the subject of politology of religion, and similar disciplines, i.e. sociology of religion, psychology of religion, history of religion, etc. The book which is a subject of a review should be published in the last couple of years, preferably by a reputable international publisher. If you make a strong case of its relevance, we also publish reviews of books written in a language other than English.

Book review should include the following information:

- Author information: including affiliation, contact information, position held, areas of expertise, and major publications. It is also necessary to include author's ORCID ID. In case you don't have one, please do register by following this <u>link</u>.
- **Book information:** provide full information about the book that is under review. This includes the full title of the book, publisher, ISBN, total number of pages, and a price.
- Word count: book review should not exceed 1500 words.
- Book review check-points: The review should follow the usual check-points: you should begin with an overall analysis of the book, including a brief summary of its contents. Please highlight the importance/relevance of the book for the field of religion and politics, and discuss its theoretical and practical implications. If you find it necessary, please include a critique of a certain claims from the book. In the closing paragraph, please should provide conclusions regarding the book's contribution to the field and indicate the type of audience that would be interested in the book under review.

You are also invited to submit a critical view and/or polemic related to the field of politology of religion, or a similar discipline. It should not exceed 1500 words, and can include, but it is not limited to, your critics of a recently published article, book, or any other form of a scholarly work. It can also relate to the contemporary phenomena in the field, religio-political changes, etc.
