



## Covid-19 Vaccination- Information/Links for Parents and Teens

### Key issues for parents and children to consider before making a decision

#### 1. Very little direct benefit to healthy children from Covid-19 vaccination

- Latest data confirms children and young adults are at extremely low risk from severe Covid-19. Most children experience very mild symptoms and recover within a week. <https://www.bristol.ac.uk/news/2021/july/ncmd-covidrisks.html>. There have been very few deaths in children and the majority of deaths have not been 'from' Covid-19 and mostly occurred in children with multiple life-limiting co-morbidities. <https://www.nature.com/articles/s41591-021-01578-1.pdf>
- Latest studies also show children are at very small risk from Long Covid and most recover within a week <https://www.bbc.co.uk/news/health-58071898> . In addition, there is no data or evidence that the vaccines prevent "Long Covid" in children.
- Majority of teens (>95%) have now been infected and have already developed natural immunity through infection, which is shown to be more robust, comprehensive, and long-lasting than vaccine-derived immunity. <https://www.wsj.com/articles/prior-covid-19-infection-offered-better-protection-than-vaccination-during-delta-wave-11642619009>
- Many experts have argued that healthy children should be allowed to catch Covid-19 and develop natural immunity when young, when the illness is very mild. In this BMJ article the authors state ***"Once most adults are vaccinated, circulation of SARS-CoV-2 may in fact be desirable, as it is likely to lead to primary infection early in life when disease is mild, followed by booster re-exposures throughout adulthood as transmission blocking immunity wanes but disease blocking immunity remains high. This would keep reinfections mild and immunity up to date."*** <https://www.bmj.com/content/373/bmj.n1197>
- Real-world data has shown that the vaccinated are still catching the latest variant Omicron due to its ability to evade the vaccines, which were developed against the original Wuhan strain, which is now extinct.

#### 2. Known and unknown risks to children from Covid-19 vaccines

- There are risks attached to any new drug or vaccine and the Covid-19 vaccines have limited short-term and no long-term safety data. The children's study used for emergency authorisation was too small and short in duration to show up rare adverse events or any adverse effects on long-term health.



- Several risks have been identified since the roll out of these vaccines which were not identified in the trials e.g. **myocarditis/pericarditis** and **clotting disorders** but long-term effects remain unknown. Please see section 4 of PIL

  - The JCVI did not recommend mass rollout of Covid-19 vaccines for healthy 12–15-year-olds. In their statement on Sept 3, 2021, they stated: ***"Overall, the committee ...acknowledges that there is considerable uncertainty regarding the magnitude of the potential harms. The margin of benefit, based primarily on a health perspective, is considered too small to support advice on a universal programme of vaccination of otherwise healthy 12 to 15-year-old children at this time. As longer-term data on potential adverse reactions accrue, greater certainty may allow for a reconsideration of the benefits and harms.   - The US FDA and Pfizer advisory committee admitted that the long-term safety of the vaccine for 5-11-year-old children will have to be carried out post vaccinations. ***"The number of participants in the current clinical development program is too small to detect any potential risks of myocarditis associated with vaccination. Long-term safety of COVID-19 vaccine in participants 5 to <12 years of age will be studied in 5 post-authorization safety studies, including a 5-year follow-up study to evaluate long term sequelae of post-vaccination myocarditis/pericarditis"*** <https://www.fda.gov/media/153409/download>
  - Peter Doshi study in the British Medical Journal finds more harm than initially estimated : ***"Today (Aug 31), our study of serious adverse events in the Pfizer and Moderna phase 3 covid-19 vaccine trials was published in the peer-reviewed journal Vaccine.[6] The results showed the Pfizer and Moderna both exhibited an absolute risk increase of serious adverse events of special interest (combined, 1 per 800 vaccinated), raising concerns that mRNA vaccines are associated with more harm than initially estimated at the time of emergency authorization."***

- 3. Unethical to vaccinate children for the benefit of society and the vulnerable are (in any case) protected by their own vaccine or by naturally acquired immunity**
- Up to 9 January 2022 around 70% of adults in UK were triple vaccinated.
  - According to latest ONS data, at least 96% of the adult population in UK tested positive for Covid-19 antibodies in week up to 9 January 2022

  - Some scientists argue that given how mild Covid-19 is for the young, allowing them to develop natural immunity is a good way of 'topping up' immunity in the population in the long run.

- Contrary to claims in the media, whilst children can catch and transmit Covid-19, children and schools have not been key drivers of transmission of Covid -19 and transmissions tend to follow community transmission. <https://www.thetimes.co.uk/article/study-shows-schools-do-not-spread-covid-vmzgitckw>
- **The vaccinated can still catch and transmit Covid with waning immunity over 12 weeks.** Omicron can evade the vaccines, with many triple vaccinated adults and double-jabbed children becoming infected over the recent months. #### 4. The Science is not settled

- Scientists and medics worldwide were divided on extending the vaccines to under 18s. UK's Joint Committee for Vaccination and Immunisations (JCVI) stopped short of recommending mass rollout to healthy 12-15-year-olds based on direct health benefits alone: <https://www.gov.uk/government/publications/jcvi-statement-september-2021-covid-19-vaccination-of-children-aged-12-to-15-years/jcvi-statement-on-covid-19-vaccination-of-children-aged-12-to-15-years-3-september-2021> However, the 4 UK Chief Medical Officers (CMOs) overruled the JCVI decision on 13 September 2021, to prevent 'further disruption to education' and to protect children's mental health. <https://www.gov.uk/government/publications/universal-vaccination-of-children-and-young-people-aged-12-to-15-years-against-covid-19/universal-vaccination-of-children-and-young-people-aged-12-to-15-years-against-covid-19?>
- The CMOs decision has received much criticism, given the uncertainty over the effect of vaccinating 12-15 years on overall transmissions. As the JCVI stated "***There is considerable uncertainty regarding the impact of vaccination in children and young people on peer-to-peer transmission and transmission in the wider population. Estimates from modelling vary substantially, and the committee is of the view that any impact on transmission may be relatively small, given the lower effectiveness of the vaccine against infection with the Delta variant.***" The recent arrival of Omicron has made the case even weaker, due to its ability to evade the vaccines.
- After some delay, JCVI extended the roll out to 5–11-year-olds as 'a one-off, non-urgent offer' but has now stopped the offer for this age group. Sweden and Norway never offered the vaccine to 5-11 yrs. In addition, in Norway, children who have recovered from Covid-19 are not advised to have the vaccine.
- Sweden, which never offered Covid-19 vaccines to under 12's, has now stopped offering to healthy under 18s <https://www.folkhalsomyndigheten.se/nyheter-och->

## Known Risks and Adverse Events

### 1. Myocarditis/Pericarditis (heart inflammation which can lead to permanent heart scarring and elevated risk of heart failure, possibly needing transplant, over 5-10 years)

- Latest Oxford study finds myocarditis rates higher after vaccine than after infection in men under 40 "Associations were stronger in men younger than 40 years for all vaccines. In men younger than 40 years old, the number of excess myocarditis events per million people was higher after a second dose of mRNA-1273 than after a positive SARS-CoV-2 test (97 [95% CI, 91–99] versus 16 [95% CI, 12–18])"

- Recent paper in BMJ on Myocarditis and pericarditis risk after Covid-19 vaccination: "*In summary, a large body of reviewed studies continues to suggest that mRNA covid-19 vaccines are associated with a rare but heightened risk of acute myocarditis and pericarditis. These risks are highest in young males shortly after the second dose. Key uncertainties remain, including risks associated with boosters, risks associated with primary vaccination of young children, and the long-term outcomes of those who experience myocarditis.*"

And it will take some time to find out whether those changes resolve and they end up with a perfectly normal heart with no risk of future problems - or not.*” ...*“We can't be absolutely sure [there's no long-term damage to children from the vaccine]. And that's why indeed the JCVI has hesitated to make a clear recommendation to immunise all these children. Because it is conceivable that it will turn out that there will be a small number of children who could have long-term injury as a consequence of this. We are very definite in this country that we don't recommend vaccination routinely unless we're really sure that the benefits outweigh the risks.”* <https://youtu.be/XwzpP3t17LU>

## 2. Blood Clots

- According to the latest study, Pfizer's coronavirus vaccine is just as likely to trigger blood clots as AstraZeneca's, which has been stopped for under 40s.
