On, April 28, 2021, at approximately, 2000 hours, I, Corporal Steven Hansen, was on duty in the County of Saguache, in the State of Colorado, when I was contacted by Sheriff D. Warwick in regards to a party, later identified as Miguel Lamboy (DOB 06/29/1978) going to the Salida Police Department, located in Salida, Colorado, within Chaffee County, to report a death. I was told that Mr. Lamboy lives at 4 Alcedo Court, in a subdivision known as Casita Park, Moffat, Colorado, within Saguache County. I was given contact information by Sheriff Warwick for Sergeant (SGT) C. Orth from SPD.

At approximately, 2015 hours, I contacted SGT Orth. SGT Orth stated that Mr. Lamboy walked into to SPD to report the death of female known to Mr. Lamboy as Lia Carlson (DOB 11/30/1975). The following statements were told to me by SGT Orth as they were told to him from Mr. Lamboy:

Mr. Lamboy stated that yesterday (April 27, 2021) he was driving all over the state. Mr. Lamboy stated that he went to Montrose, Colorado, and dropped off some type of computer. Mr. Lamboy stated that from Montrose, Colorado he drove someone to the airport in Denver, Colorado. Mr. Lamboy stated that he returned to his residence, 4 Alcedo Court, Moffat, Colorado. Mr. Lamboy stated that there were people at his residence needing a place to stay. Mr. Lamboy identified the people as Jason Castillo, John Robertson, Crystal Raymond, Karen Raymond, and Ryan Cramer. I do not have any more information other than that on the five persons that Mr. Lamboy stated needed a place to stay.

Mr. Lamboy stated that he got up this morning (April 28, 2021) and left for Denver, Colorado. Mr. Lamboy stated that he left Denver and went to Buena Vista, Colorado and then returned to his residence. Mr. Lamboy stated that is when he found a deceased female, known to him as Lia Carlson (DOB 11/30/1975). Mr. Lamboy stated that Ms. Carlson skin appeared to be grey in color and her eyes were glazed over or missing. Mr. Lamboy stated that it was obvious that Ms. Carlson was dead because her eyes were missing. Mr. Lamboy stated that the body appeared to be mummified with Ms. Carlson's teeth exposed through the lips. Mr. Lamboy stated that Ms. Carlson was wrapped in a cloth.

Mr. Lamboy stated that he attempted to take his son, identified as **Constant Sector**), and leave but the other people at the house would not let Mr. Lamboy leave with **Constant**. It is not known where **Constant** mother is at this time. There is an ongoing complaint with the Saguache County Department of Social Services in regards to Mr. Lamboy and **Constant** Mr. Lamboy then left his residence and drove to SPD to report the possible death of Ms. Carlson.

Mr. Lamboy is believed to be part of a Religious group known as "Love has Won". "Love has Won" is known to take people in from all over the world. The Saguache County Sheriff's Office has received many complaints from families within the United States saying that the group is brainwashing people and stealing their money. The DSS complaint was because of **Mathematical and the "Love has Won" group.** Ms. Carlson is believed to be the leader of "Love has Won" and goes by the name "Mother God"

At approximately, 2350 hours, the search warrant for 4 Alcedo Court, Moffat, Colorado was executed. The search warrant was granted to check the welfare of Mr. Lamboy's son and to search for a deceased person. During the search of the house 7 persons, later identified as Ryan Kramer (DOB 01/07/1991), Christopher Royer (DOB 04/26/1986), Sarah Rudolph (DOB 02/13/1986), Karin Raymond (DOB 07/26/1973), Jason Castillo (DOB 08/05/1975), John Robertson (DOB 02/07/1989) and, Obdulia Franco (DOB 09/05/1968), were found inside the house. All seven persons were taken into custody and transported to the Rio Grande County Jail in Del Norte, Colorado, and booked in on the above listed charges. After all persons were taken into custody a search of the house did discover the mummified remains of what appears to be a human female.

The mummified remains were found in a back bed room on the south side of the house. The mummified remains were found lying on a bed wrapped in what appears to be a sleeping bag. The mummified remains have what appears to be glitter type makeup on around the eyes. The mummified remains were decorated with Christmas tree lights. The mummified remains appeared to be set up in some type of shrine. The mummified remains could be seen from the hallway between the kitchen area and the living area of the house.

Also found in the house was a 13-year-old female, identified as All and the daughter of Karin Raymond. Mr. Lamboy's 2-year-old son Both children were in good health and sleeping at the time the search warrant was conducted. Saguache County Department of Social Services (DSS) was contacted to take custody of as Ms. Raymond was taken into custody. Was turned over to DSS for placement awaiting a forensic interview to be held at a later date.

I was informed by SGT Orth that Mr. Lamboy believes that the people that showed up at his residence have transport the mummified remains to his residence from California. Mr. Lamboy stated that the vehicle that they showed up in was a Nissan Rouge later found to have California license number plate of **Mathematical and VIN of** Mhile on scene I could see inside the Nissan vehicle and found that the back seat was laid down. The position of the rear passenger seat is consistent with someone transporting the mummified remains. The Nissan Rouge is registered to Obdulia Franco.
