The Ermelo case identified 9 Offenders who worked together and in other cases the number is 4 or 5 or 6 syndicate members. Definition of Organised Crime according to the UN Convention on Transnational Organized Crime: "A structured group of three or more persons, committing one or more serious crimes or offences in order to obtain, directly or indirectly, a financial or material benefit."
